These references are certainly MORE CREDIBLE than GOOGLE and WIKIPEDIA.

## **Who Is Warren Bell ?**

Bell is NO expert on pest control products.

Bell has ABSOLUTELY NO background, training, or experience concerning pest control products, making his opinions FLAWED, DISTORTED, VALUELESS, and WORTHLESS.

Reportedly, Bell is an out-spoken expert on NEAR-DEATH OR OUT-OF-BODY EXPERIENCES.

Additionally, it has been reported that Bell is part of a group that attempts to PURGE JEWS from organizations like World Medical Association.

Bell's name appears among a list of ANTI-SEMITIC Activists.

This list was obtained through Google, and this information is every bit as CREDIBLE as the Google Anti-Pesticide references that Bell has provided the public.

Through Google, Warren Bell is a JEW-HATING GHOST-WHISPERER ( ? )

Do we believe these stories ?

The Google stories concerning Bell are NO MORE CREDIBLE as those ALLEGING that pest control products somehow CAUSE HARM.

## **No Expert**

Bell is NO CREDIBLE expert on pest control products, and neither are any of his buddies.

The problem with Bell reflects the overall larger problem with ALL Anti-Pesticide Activists.

There are NO Anti-Pesticide Activists who are scientists or researchers with credentials in the field of pest control products.

NONE !

Bell has expressed MOCK-CONCERN for representatives of the manufacturing industry who are trying to protect their businesses.

Who can blame them for protecting their investments, and, at the very least, these people have EXPERTISE that Bell CLEARLY DOES NOT POSSESS.

Bell has also expressed MOCK-CONCERN about the unwillingness of manufacturers to upgrade to so-called less toxic Green Alternatives.

Which Green Alternatives ?!?!

Name them. Name the ones that are somehow less toxic.

Again, Bell has SQUAT !

There are NO viable, efficacious, or economical Green Alternatives available to replace conventional pest control products — and they are mostly BOGUS, INEFFECTIVE, STUNNINGLY EXPENSIVE, and often MORE TOXIC !

## **Hidden Agenda**

DOES Bell have a HIDDEN AGENDA ?

Of course ... PROFIT.

Bell has a HUGE VESTED INTEREST IN PERPETUATING IMAGINARY DANGERS about these products.

Doing this attracts HUGE SUMS OF PROFIT to his organizations, in the form of MEMBERSHIP, DONATIONS, and GOVERNMENT GRANTS.

Bell's Anti-Pesticide Organizations are Canadian Association of Physicians for the Environment ( CAPE ) and Canadian-Cancer-Society ( CCS ).

Bell also has a HUGE VESTED INTEREST IN PERPETUATING IMAGINARY DANGERS about pest control products BECAUSE HE IS PAID TO DO SO.

On top of his 165,000-dollar-per-year salary at Shuswap Lake General Hospital, Bell is PAID UNFATHOMABLY VAST SUMS OF MONEY by Canadian Association of Physicians for the Environment ( CAPE ) and Canadian-Cancer-Society ( CCS ).

Observers question how Bell can properly perform his duties as a GOVERNMENT-HEALTH-OFFICIAL with a without being in SEVERE CONFLICT-OF-INTEREST WITH HIS PARTISAN ANTI-PESTICIDE ACTIVITIES.

## **What Is CAPE ?**

The primary reason for the existence of CAPE and CCS has NOTHING TO DO WITH HEALTH or ENVIRONMENT, but has everything to do with BUSINESS, CASH-FLOW, PROFIT, MEMBERSHIP, DONATIONS, and GOVERNMENT GRANTS.

The Anti-Pesticide Organization that Bell co-founded, CAPE, is a TAX-EXEMPT MONEY-GRABBING FUND-RAISING FOR-PROFIT NON-EXPERT Anti-Pesticide Organization.

CAPE is CERTAINLY NOT a science or research organization.

Moreover, the VAST MAJORITY of CAPE members ARE NOT EVEN PHYSICIANS.

In fact, CAPE represents an INFINITESIMALLY SMALL number of doctors.

CAPE merely represents LESS THAN 4 PER CENT of all doctors in Canada.

## **Ruined Investments**

Bell expresses MOCK–CONCERN about manufacturers that worry about the British Columbia government's plan to limit the use of pest control products in the Urban Landscape.
