**Green Alternatives are DISMAL FAILURES since they merely SUPPRESS some pests of turf.**

**Conversely, conventional pest control products FULLY and EFFECTIVELY CONTROL pests, without the need for excessively repeating applications, as is the case with Green Alternatives.**

**Overall, when conventional pest control products are used properly, there are NO HARMFUL IRREVERSIBLE EFFECTS TO HEALTH AND THE ENVIRONMENT !**

**Furthermore, many Green Alternatives are actually MORE TOXIC than conventional pest control products.**
