Position of the Government of Alberta

The Government of British Columbia is also aware that the neighbouring Province of Alberta WILL NOT legislate Anti-Pesticide PROHIBITION.

On August 9th, 2011, the Government of Alberta stated that it STRONGLY SUPPORTS the use of SCIENCE-BASED EVIDENCE when assessing pest control products.

Moreover, the Government of Alberta WILL NOT CREATE RESTRICTIONS OR LAWS THAT CONFLICT WITH THE FEDERAL GOVERNMENT, that is relied upon for health and safety assessments.

According to the Government of Alberta, restricting access to products that are designed and approved to be used safely CONFLICTS with its assessment of the public's need for access to all tools available for controlling a variety of pests.

The government has monitored Anti-Pesticide PROHIBITIONS over the past few years and the approaches taken by other jurisdictions, and has found THE BASIS FOR ACTION CONFUSING AND INCONSISTENT.

Restricting access to products that are designed and approved to be used safely CONFLICTS WITH ALBERTA'S ASSESSMENT of the public's need for access to all tools available for controlling a variety of pests.

ALBERTA ENVIRONMENT AND WATER is the agency of the Government of Alberta that is responsible for the provincial regulation of pest control products.
