Forman's Antics Are Just Like Wagstaff's

Forman's ACTIVIST-ANTICS remind us of the film Horse Feathers.

In the opening act, Wagstaff and a group of college professors SING AND DANCE in full academic robes and mortar-board hats —

*« I don't care what you have to say
It makes no difference anyway;
Whatever it is, I'm against it ! »*

Forman is AGAINST coal.

He is AGAINST pest control products.

He is FOR wind turbines because his friend Dalton McGuinty tells him to.

Forman COULD NOT CARE LESS

It is PITIFULLY LUDICROUS to believe that Forman and CAPE are somehow concerned about health and the environment.

It is also LUDICROUS to believe that CAPE somehow represents the views of health care workers, such as PHYSICIANS.

In fact, CAPE represents an INFINITESIMALLY SMALL number of doctors.

CAPE merely represents LESS THAN 4 PER CENT of all doctors in Canada.

The primary reason for the existence of Canadian Association of Physicians for the Environment has NOTHING TO DO WITH HEALTH but has everything to do with BUSINESS, CASH-FLOW, PROFIT, MEMBERSHIP, DONATIONS, and GOVERNMENT GRANTS.

Non-Partisan ?!?!

It is LAUGHABLE to believe that Forman and CAPE are somehow NON-PARTISAN in view of OBVIOUS INDISCREET ASSOCIATIONS with Dalton McGuinty and the Ontario Liberal Government.

Through The Ontario Trillium Foundation, the McGuinty Government has given CAPE, TAX-FREE, HUNDREDS OF THOUSANDS OF DOLLARS to represents its interests in matters concerning the environment.

This FREE TAX-EXEMPT MONEY helped pay for a LARGE CHUNK of Forman's salary as a NON-EXPERT FUND-RAISER who works for an organization that TERRORIZES and DESTROYS LAW-ABIDING and TAX-PAYING INDUSTRIES.

Until 2009, Forman was PAID-FOR-PROFIT to CONSPIRE to PROHIBIT pest control products used in the Urban Landscape.

On April 22nd, 2009, the Government of Ontario ARBITRARILY PROHIBITED pest control products.

- Health-Canada-Approved
 - Federally-Legal

- * Except when stored improperly in the home.

Forman's Anti-Pesticide CARNAGE

Because in large part to Forman's ACTIVIST-ANTICS, Ontario Anti-Pesticide PROHIBITION led to LOSS OF REVENUES, BUSINESS FAILURES, BANKRUPTCY, and UNEMPLOYMENT, inflicting TERROR, DESPAIR, and DESTITUTION on THOUSANDS of hapless victims throughout the Professional Lawn Care Industry.

Because of the Anti-Pesticide PROHIBITION, Professional Lawn Care businesses were forced to TERMINATE many or most of their employees.
