# The History of STRIKING Back Against Environmental Terror in Quebec and Across Canada



1991

---

In 1991, the Town of Hudson, Quebec, governed by a SUBVERSIVE GROUP OF LUNATICS, enacted a by-law that PROHIBITED the use of pest control products that were otherwise HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, and SCIENTIFICALLY-SAFE.



Hudson officials easily capitulated under the pressure of a mere handful of Enviro-Lunatic-Activists.

The Agriculture and Golf Industries were provided with an Exception Status.

Mr. William H. Gathercole crafted the original Golf Industry Exception Status, which endures to this day for virtually all jurisdictions in North America.

1992

---

In 1992, two Professional Lawn Care companies, ChemLawn and Spraytech, were each fined three hundred dollars for accidentally spraying pest control products on lawns located in the Town of Hudson.

The fine was LEGALLY CHALLENGED by the Professional Lawn Care Industry on the basis that the by-law was invalid, since it was PROHIBITORY and DISCRIMINATORY, and LIMITED or NEUTRALIZED PROVINCIAL AND FEDERAL LAWS.

It is a little-known fact that the Enviro-Lunatic-Leader of New Democratic Party of Canada, JACK LAYTON, was born and raised in Hudson, Quebec.

1994

---

In 1994, in a Quebec court, the Town of Hudson won the right to maintain its NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products.

The attempt was ill-fated.

In 2009, in the Province of Quebec, Dow AgroSciences initiated a **LEGAL CHALLENGE** against the Canadian federal government under the provisions of the North American Free Trade Agreement ( **NAFTA** ).

The North American Free Trade Agreement, or **NAFTA**, is an agreement signed by the governments of Canada, Mexico, and the United States, creating a tri-lateral trade bloc in North America.

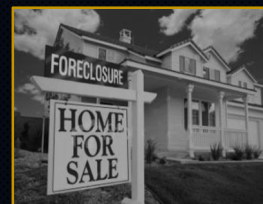
Dow AgroSciences also demanded at least **2,000,000 DOLLARS IN DAMAGES**.

On May 25<sup>th</sup>, 2011, Dow AgroSciences, the manufacturer of the pest control product 2,4-D, SETTLED THE NAFTA CHALLENGE CASE with the Canadian government.

The North American Free Trade Agreement, or NAFTA, is an agreement signed by the governments of Canada, Mexico, and the United States, creating a tri-lateral trade bloc in North America.

As part of agreement, a VICTORY for the company, the GOVERNMENT OF QUEBEC was HUMILIATED into making a STATEMENT saying that ...

*2,4-D DOES NOT POSE AN UNACCEPTABLE RISK  
to human health or the environment.*

Quebec was the first province to declare weed control products containing 2,4-D as POSSIBLY carcinogenic, which has now been DEEMED AS FALSE.

On that basis, municipalities in Quebec instituted NEEDLESS, SENSELESS, and MALICIOUS PROHIBITIONS of 2,4-D use as a lawn pest control product.

Other jurisdictions outside of Quebec also CONSPIRED to IMPOSED the LUNATIC-TERRORIST-PROHIBITIONS of 2,4-D under the PRETEXT that it was a so-called carcinogen.

In fact, ABSOLUTELY NO regulatory body in the world classifies 2,4-D as a human carcinogen — 2,4-D is probably the MOST STUDIED and BEST UNDERSTOOD of ANY chemical — not just pesticide — in existence.
