Copies found their way into England, Africa, Germany, and many other places. What scared people most was that citric acid was on the list, which is in many, many fruits. Books and other leaflets copied the same information over without checking the sources or the facts. These flyers were passed out in schools, hospitals, and health clinics until the late 80s.
