

Nova Scotia is the second-smallest province in Canada with a population of almost 940,000.

Nova Scotia is located on Canada's South-Eastern Coast.

Its capital, Halifax, is a major economic centre of the region.

Halifax Regional Municipality, commonly known as Halifax or HRM, with a population over 370,000, is the capital of the Province of Nova Scotia.

Halifax is the largest population centre in Atlantic Canada, and the largest in Canada east of Quebec City.



2000-2003 Halifax Municipal Prohibition

On August 15th, 2000, the Halifax Regional Municipality moved to PROHIBIT pest control products on lawns and gardens that were otherwise FEDERALLY-APPROVED and SCIENTIFICALLY SAFE —

PROHIBITION Within Halifax Regional Municipality

5. (1) Commencing April 1, 2003, no person shall carry out or permit or suffer to be carried out a pesticide application within the Halifax Regional Municipality.

In 2000, Halifax IMPOSED, over a three-year period, the PROHIBITION of conventional pest control products used in the Urban Landscape.

Although PROHIBITION was ENACTED in 2000, it was only IMPOSED in April 2003, and thus is called the 2000-2003 MUNICIPAL PROHIBITION.

Only some Green Alternative Pesticides were PERMITTED.

In November 2010, Halifax Regional Municipality Council REJECTED the use of the Green Alternative Pesticide FeHEDTA (i.e. Fiesta Herbicide) as an addition to permitted uses in the Pesticide By-Law, but later reinstated the product.

Since 2000, PROHIBITION against conventional pest control products EXTEN-SIVELY DAMAGED the Professional Lawn Care Industry within the Halifax Regional Municipality.

There were NO valid economical alternatives to replace the PROHIBITED products, and there will be NONE within our collective lifetime.

So-called Green Alternative Pesticides, such as Corn Gluten Meal, Fiesta, Nematodes, and Sarritor, were DISMAL FAILURES.

Halifax's 2000-2003 MUNICIPAL PROHIBITION led to CATASTROPHIC HARDSHIP AND LOSSES for businesses operating in the Professional Lawn Care Industry because there were NO valid economical alternatives to replace the prohibited products.

The number of businesses DID NOT GROW WHATSOEVER!

In 2005, two years after the 2000-2003 MUNICIPAL PROHIBITION was IMPLE-MENTED, businesses SUFFERED CATASTROPHIC BUSINESS LOSSES with ...

REVENUES DOWN BY 30 PER CENT, and

CUSTOMER NUMBERS DOWN BY 40 PER CENT



CARNAGE Caused By 2000-2003 Halifax Municipal Prohibition (continued)

These BUSINESS LOSSES were reported in 2005 by Peter Bugden, Principal Owner and President of Nutri-Lawn, reported about the CATASTROPHIC BUSI-NESS LOSSES caused by the 2000-2003 MUNICIPAL PROHIBITION in Halifax Regional Municipality —

The Halifax pesticide by-law, which was FULLY IMPLEMENTED in 2003 after two years of property registration and education.

He [Bugden] indicated that his customers have not been very receptive to the alternative programs that he has offered, and HIS REVENUES AND CUSTOMER BASE ARE DOWN BY MORE THAN 30 PER CENT AND 40 PER CENT RESPECTIVELY.

He also stated that the by-law has damaged the business pace of professional lawn care operators, as there are no restrictions on dramatically.

On February 25th, 2009, M-REP Communications issued a report on the reality of a Statistics Canada report regarding the Professional Lawn Care Industry in Halifax Regional Municipality —

Contrary to published reports by activist about Halifax.

The number of companies in all of Nova Scotia is around 150.

The Stats Canada report they keep referring to reflects a sector that includes lawn care.

Activists made claims that the number of companies operating in the Halifax area have increased by 53 per cent.

THIS IS A LIE BY THE ACTIVISTS TO SCOOP SUPPORT.

The reality is the OPERATIONAL REVENUE DROPPED BY 40 PER CENT [as of 2009] with most of the 9 companies that operate in the Halifax area, and it has taken 5 years to recover from those losses.

CARNAGE Caused By 2000-2003 Halifax Municipal Prohibition (continued)


By 2012, because of the 2000-2003 MUNICIPAL PROHIBITION in Halifax Regional Municipality, businesses LOST OVER 50 PER CENT OF THEIR CUSTOMERS, and REVENUES PLUMMETED BY 40 PER CENT.

Halifax's CATASTROPHIC BUSINESS LOSSES are CONSISTENT WITH LOSSES RE-PORTED IN QUEBEC.

Because of the 2004-2006 QUEBEC PROVINCIAL PROHIBITION, OVER 60 PER CENT of the businesses were ANNIHILATED, and HUNDREDS OF BUSINESSES DISAPPEARED INTO TOTAL OBLIVION.

By 2011, in the sixth year after the IMPLEMENTATION of the 2004-2006 QUEBEC PROVINCIAL PROHIBITION, the REMAINING businesses operating in the Professional Lawn Care Industry LOST UP TO 70 PER CENT OF THE BUSINESS THEY ONCE HAD.

It is INCONGRUOUS to believe that jurisdictions like Halifax could not have suffered the same fate as Quebec.



REPEAL Of 2000-2003 Halifax Municipal Prohibition?

On June 6th, 2011, a Councillor with Halifax Regional Municipality wanted PRO-HIBITION REPEALED.

PROHIBITION led to GARBAGE DUMP Green Spaces.

Regional Councillor Steve Adams (Spryfield-Herring Cove District) says PUBLIC SPACES INFESTED WITH DANDELIONS AND OTHER WEEDS LEAVE A TERRIBLE IMPRESSION NOT ONLY FOR RESIDENTS BUT ALSO FOR TOURISTS.

According to Councillor Adams —

Look at the Roundabout [Halifax's circular highway junction].

Look at any public space we own.

IT'S ABSOLUTELY DISGRACEFUL.

And it's NOT A CRIME to want to have a property that looks good.

It LOOKS AWFUL and it leaves a TERRIBLE IMPRESSION not only for our residents but for TOURISTS.

It's NOT A BAD THING to GET RID OF DANDELIONS.

2010 Nova Scotia Provincial Prohibition

In 2010, the Province of Nova Scotia also NEEDLESSLY, SENSELESSLY, and MA-LICIOUSLY PROHIBITED pest control products under the « Non-Essential Pesticides Control Act ».

This meant that THE ENTIRE PROVINCE WAS SUBJECTED TO PROHIBITION.

Consequently, PROHIBITION DESTROYED LAWN CARE BUSINESSES THROUGH-OUT NOVA SCOTIA.

Betrayal By Idiotic Trade Association

Following in the foot-steps of its Idiotic Ontario Counterpart, Lands-CAPE Nova Scotia Trade Association said that it was « relatively pleased » with the province's NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products under the « Non-Essential Pesticides Control Act ».

Just like Lands-CAPE Ontario, Lands-CAPE Nova Scotia BETRAYED the Professional Lawn Care Industry.






