



# **The great dandelion debate: Councillors grapple with balance between pesticides and aesthetics**

For more than a century, a flowering yellow plant has irked Calgarians.

“Every year, without fail, the No. 1 complaint that we get on a yearly basis is dandelions,” Mayor Naheed Nenshi told reporters Wednesday.

“The complaints are almost evenly split between people who say, ‘There are too many dandelions,’ and people who say, ‘Do not spray chemicals on those dandelions, I don’t want my kids playing on that.’ ”

What to do about unsightly fields of yellow was debated at city hall as far back as 1915, according to Chris Manderson, urban conservation lead for Calgary Parks.

“Somebody last year shared with us a clipping from the Calgary Herald from 1915, where (the superintendent) was asked to come to council and tell them what he’s going to do about the dandelion problem,” Manderson said.

A conversation about dandelions and a host of other unsightly weeds continued 112 years later in council chambers on Wednesday as a city committee discussed a report on pesticide toxicity.

Councillors heard from several citizens at Wednesday's meeting, including a 10-year-old boy who urged the city to stop using pesticides so he can play outside without getting sick, and adults who expressed disappointment in a city report short on recommendations.

The report concluded the level of pesticide exposure risk to Calgarians from the city's use of pesticides is acceptable within the current federal and provincial regulations.

"This is a passionate, inflamed debate," said Ward 6 Coun. Richard Pootmans. "It reminds me a little bit of the fluoride debate, actually. The science is challenging for all sides."

Committee chair and Ward 9 Coun. Gian-Carlo Carra said he was amazed at how politicized the topic of pesticide use has become.

"We heard it today from committee. There are people that think you're going to get cancer right now because of this, and people that think this is perfectly safe," he said.

Manderson said finding a balance when it comes to treating weeds across the city is no easy task.

"It is a difficult situation. We have to figure out a way that we can both reduce unsightly weeds but cut back on the use of pesticides for cosmetic purposes," he said.

Weed control solutions the city is currently trying include goats and insects, which Manderson admitted are “not as sexy as goats,” but are an effective natural control that can keep invasive weeds in check.

Pending a successful change in the city’s land use bylaw, which currently prohibits livestock in most areas, more goats could be coming to city parks down the road to munch on invasive weeds.

“Goats are absolutely part of the solution but they’re not going to solve the whole thing. I don’t see armies of goats in every park and on every boulevard in the city.” Nenshi told reporters.

“I really want to see creative solutions here that both allow us to get rid of unsightly weeds but also allow us to reduce our use of pesticides.”

Doctor Keith R Solomon, Ph.D., is a Professor in the Department of Environmental Biology at the University of Guelph. Dr Solomon is also Director of the Centre for Toxicology. According to Dr Solomon, pest control products used in the urban landscape degrade rapidly, and DO NOT build up residues during the length of the season. There is NO accumulation of pest control products in the environment. In fact, pests come back fairly quickly, within a few short weeks. For example, 2,4-D Herbicide must be applied at least twice per season, otherwise the weeds come back. The half-life of 2,4-D in soils is a matter of weeks. Another herbicide, glyphosate ( a.k.a. Roundup ) is no longer biologically active within hours of being sprayed on soil. Pest control products are known to dissipate extremely rapidly.

Overall, there is NO accumulation over time of pest control products, and NO residues to be concerned about.
