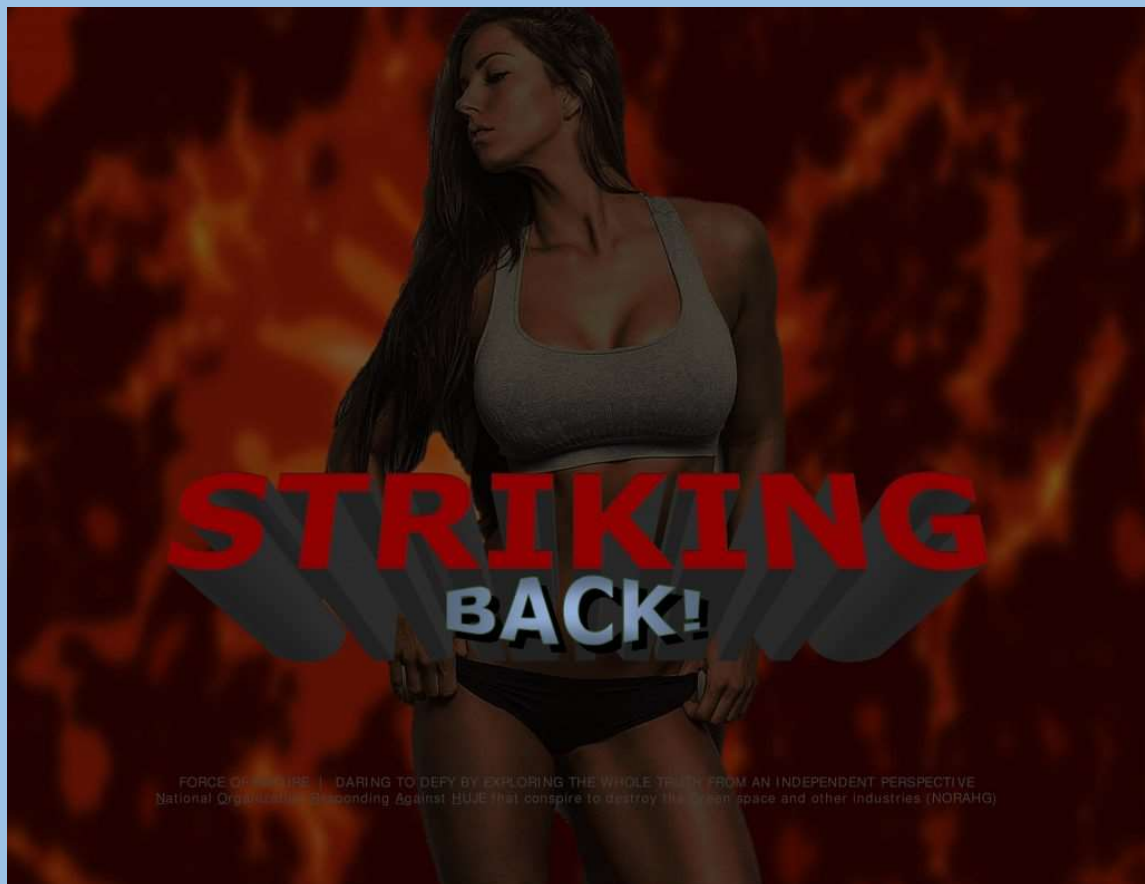

He appealed to the city for more time —

We would love for you guys to delay OPTING-IN [I.E. IMPOSE PROHIBITION] at this point.

... We think there's an opportunity to have a professional EXEMPTION for certified applicators in the lawn care industry, and we think there's a need to maintain personal property rights.

Andrew Bray expressed concern about creating a market for « BAD ACTORS », non-licensed lawn care people who may apply synthetic [A.K.A. CONVENTIONAL] pesticides in the wrong way.

Current ENFORCEMENT of the county's law [I.E. PROHIBITION] is COMPLAINT-DRIVEN, according to Mary Travaglini, the [FANATXKCAL] program manager for the county's [FAILED] ORGANIC lawn and landscapes program.

Offenses incur a 50-dollar civil fine, and this does not escalate for repeat offenses.

According to Travaglini —

It's not a large fine.

On July 8th, 2019, officials from the county parks and planning departments spent more than two hours explaining to members of the Montgomery County Council their limited use of pesticides in the past year.

However, they noted that they **WILL NOT** foresee a day when all county parks will be pesticide-free.

Pesticides Are Allowed – Part 1

Montgomery County Prohibits Some Pest Control Products, But Not Others, Through Thousands & Thousands Of Inconsistent & Unfair Exception Statuses

When the county council of « **BAD GUYS** » voted in 2015 to outlaw [I.E. **PROHIBIT**] the use of cosmetic pesticides, weed control products whose main purpose is to make lawns prettier, several LOOP-HOLES [I.E. **EXCEPTION STATUSES**] were included in the bill [I.E. **PROHIBITION**].

EXCEPTION STATUSES ARE INCONSISTENT & UNFAIR – SEE NEXT SEGMENT

Currently, it is **ILLEGAL** to use cosmetic chemicals that include EPA warning labels on private lawns and at childcare facilities. [?!?!]

It is **NOT ILLEGAL** to apply them at county parks [I.E. **COUNTY-OWNED PROPERTIES**]. [?!?!]

During the combined Planning, Housing and Economic Development and Transportation and Environment hearings, parks director Mark Riley noted the importance of following the policy at their parks.

According to parks director Mark Riley —

Our parks are safe for your patrons and our staff.

I do take this very, very seriously.

*We believe we are the **GOOD GUYS** in this effort, not the **BAD GUYS**. [?!?!]*

EXCEPTION STATUSES ARE INCONSISTENT & UNFAIR !

The AUDACITY & HYPOCRISY of Montgomery County's officials is clearly evident when they CIRCUMVENT their own HARMFUL-PROHIBITION by taking advantage of exceptions that they wrote into their bill. Montgomery County's prohibition has allowed INCONSISTENT & UNFAIR EXCEPTION STATUSES for pest infestations — on county-owned green spaces only [?!?!]. Pesticides Are Allowed – Part 2

Exception Statuses Ensure That Montgomery County Will **Allow** Conventional Pest Control Products

Pesticides are sometimes **ALLOWED** to control invasive weeds and protect plant health, and eliminate poison ivy and stinging insects.

They are also **ALLOWED** along the train tracks at Brookside Gardens in Wheaton, so the train can ride safely, said David Vismara, chief of the horticulture, forestry, and environmental education division at the parks department.

Pesticides also are **ALLOWED** to maintain roads and parking lots so that weeds don't grow in road cracks and worsen conditions, he said.

No pesticides are used on the county's 273 playgrounds.

However, pesticides are **ALLOWED** on the surrounding grass and lawns.

Pesticides are not used at all in 10 parks, as part of a pilot program, and parks director Riley said the number of parks in that program will expand.

According to parks director Mark Riley —

I think we can significantly increase the number of parks in the next six months.

Riley also vowed that as of July 1, 2019. any time pesticides are **ALLOWED**, a sign will be posted in that park and notice will be listed on the park web-site.

Limited Use Of Pesticides

Montgomery County's Prohibition Is A Dismal & Ridiculous Failure, Just Like Other Jurisdictions Such As Vancouver

But parks director Mark Riley's department oversees hundreds of parks, athletic fields, and playgrounds throughout the county, and not all are treated the same.

Officials from the county parks and planning departments spent more than two hours on July 8th, 2019, explaining to members of the Montgomery County Council their LIMITED USE [I.E. PROHIBITION] of pesticides in the past year.

Costly Prohibition

Montgomery County's Stunningly Exorbitant Costs Of Its #@!!% Pesticide Ban Is Nonsense

Money spent to purchase pesticides has declined for the past five years, from a high in Fiscal Year 2014 of 53,395-dollars to only 14,624-dollars during the last fiscal year.

To control weeds, the parks department sets a tolerance level so it does not kill every weed that pops up.

It also does not allow weeds to take over an entire field.

When pushed by council members to say what that level was, Cliff Driver, the park's athletic fields manager, replied —

It can be somewhat interpretive.

When the ratio of weeds to grass is equal, Driver said —

That triggers a FULL [& COSTLY] RENOVATION.

That 50 per cent means we will start over.

Eliminating pesticides would be **COSTLY**, athletic fields manager Driver said.

COSTLY new machinery would have to be purchased and more **COSTLY** employees hired, Driver said.

County planning board chair Casey Anderson said he hesitated to say how much **COSTLY** money would be needed to complete the task.

According to chair Casey Anderson —

That number is going to be so large that people will believe it is overstated.

Councilman Tom Hucker, who is a driving force for elimination [I.E. **PROHIBITION**] of all pesticides, replied that he understood that —

We are going to have to SPEND MORE MONEY.

The council had asked the parks department to start a pilot program to maintain 10 athletic fields using only conventional and organic-based methods.

But parks director Mark Riley said he only received one bid for 650,000-dollars a year.

So, instead, his department decided to create its alternative pilot program at Laytonia Recreational Park in Gaithersburg.

Using two side-by-side fields, the parks department, with the assistance of the University of Maryland's turfgrass experts, the county will test different non-pesticide solutions [I.E. INFERIOR & MORE HAZARDOUS ALTERNATIVES THAT WILL NOT WORK], parks director Riley said.

This pilot program will be conducted over the next three years.

While the general tone of the hearing was cordial, it did get testy at one point.
