The [ British Columbia ] coalition of health and environmental groups [ that includes David Suzuki Foundation, Canadian Cancer Society, Canadian Association of Physicians for the Environment, and Toxic Free Canada ] has recommended provincial legislation that:

- 1. Bans the use and sale of pesticides used to improve the appearance of lawns and gardens, including a requirement for golf courses to phase-out pesticides.
- 2. Allows exemptions only when necessary to protect public health and safety.
- 3. Allows municipalities to enact and enforce bylaws that are more restrictive of pesticide use than the provincial law.
- 4. Includes a 'white list ' of low-risk pesticides that are permitted on lawns and gardens to promote public awareness.

# IMPORTANT EFFORT BEING UNDERTAKEN BY THE I.E.P.M.A. OF WESTERN CANADA and YOU

The British Columbia (B.C.) Government has announced that they will "REVIEW" the use of cosmetic pesticides. Now is the time to make our voice heard. Below you will find a link to our online petition to the B.C. Government requesting that there be no ban of 'COSMETIC' pesticides. It is quick and simple to fill in, and then just click "SEND".

We suggest that you have everyone in your family of voting age complete and send their own form. Note: anyone completing the form must reside in British Columbia.

Print out copies of the attached form. At your office, or when you or your staff visit a customer, request that they, and family members of voting age, complete the form. You can then transfer their information to the online version of the petition. If the customer/friend is also interested in getting others to send in the electronic form, provide them with the website address for the petition (as below). Of course, you can also give it out on the phone.

When customers fill out the written form:

- Make sure that they also sign it, as proof of permission to send it on their behalf.
- Keep the signed form.
- Once the form is completed, you can transfer the information to the online version.

Note: When the form arrives at the offices of the Premier, Minister of the Environment, and Minister of Community and Rural Affairs, the email address seen as its origin will be that which has been entered into the petition form.

Have all of your friends and their families (of voting age) who agree with our stance also fill in the form, either online or one of the printed forms.

Anytime you visit a customer, have enough forms for their families to complete, and be sure to regularly transfer the information to the online version.

REMEMBER: This is a numbers game. The Suzuki organization is having similar forms sent to the Government, but with the opposite request. We have to show the Premier that there are more people wanting the legal and proper use of pesticides than those opposed.

THE SUCCESS OF THIS VENTURE DEPENDS ON YOU. It is imperative that you get as many people as possible to fill in and remit the form. We are also looking at other means of illustrating to the Government that pesticides are an important, proper, and needed tool, but this is one of the clearest ways for you to help prove it!

THIS IS TO BE AN ONGOING, LONG-TERM EFFORT. Keep getting forms completed until the Government announces that 'cosmetic' pesticides will not be banned, even if it takes a year. This will only work if you get enough interested people to sign on.

The misinformed anti-pesticide groups are pressuring the Government and its representatives on an ongoing basis, so we have to ensure that our point is view is heard loudly and clearly.

Let's get as many as names as possible on this petition — before a final decision is reached.
