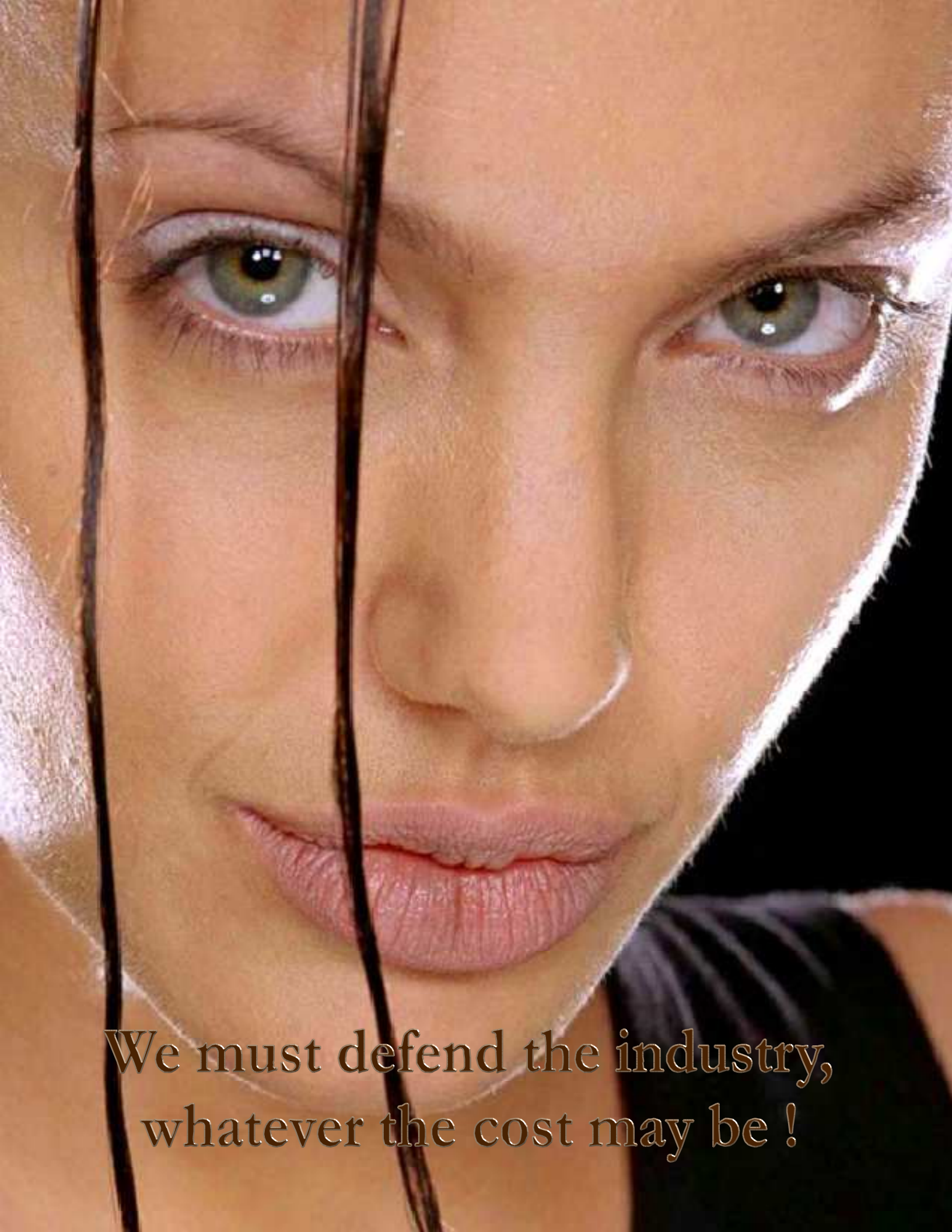

HE HAS WORKED IN VIRTUALLY ALL ASPECTS OF THE GREEN SPACE INDUSTRY, INCLUDING GOLF AND PROFESSIONAL LAWN CARE, AND HAS SERVED IN PUBLIC AFFAIRS, WORKPLACE SAFETY, AND ENVIRONMENTAL COMPLIANCE. MR. GATHERCOLE HAS SUPERVISED, CONSULTED, PROGRAMMED, AND/OR OVERSEEN THE EXECUTION OF HUNDREDS OF THOUSANDS OF PEST CONTROL APPLICATIONS IN THE URBAN LANDSCAPE.
