STATISTICAL ANALYSIS of the Toronto 2010 Municipal Election Results —

Almost HALF of all councillors who had voted YES for the PROHIBITION of pest control products were DEFEATED in the 2010 Toronto Election Campaign.

Conclusions —

Politicians who vote YES and SUPPORT the PROHIBITION of pest control products tend to end up being viewed as BAD or UNDESIRABLE for re-election by the electorate.
