IRONICALLY ... both Daffodil Production for Canadian Cancer Society and the Professional Lawn Care Industry use the SAME conventional ingredients that are needed to control insect and weed pests.

Contract-Daffodil-Growers working for Canadian Cancer Society use conventional pest control products on a regular and continuous basis, and have done so for decades.

IRONICALLY ... pesticide-treated-cancer-daffodils sold by Cancer-Lunatics are not toxic.

IRONICALLY ... conventional pest control products used to produce pesticide-treated-cancer-daffodils are scientifically safe since they have been scrutinized and approved by the hundreds of expert scientists at HEALTH CANADA !

IRONICALLY ... Cancer-Lunatics like Kaminsky and Seely consider the hundreds of qualified scientists of HEALTH CANADA's respected PEST MANAGEMENT REGULATORY AGENCY to be incompetent and/or incapable of arriving at correct scientific conclusions regarding pest control products.

UNSATIATED, Suzuki has also called on all provinces to EXTEND THEIR PESTICIDE BANS TO GOLF COURSES.

As a result of his POLITICAL INTERFERENCE in the 2011 Ontario General Election, David Suzuki himself was QUIETLY FORCED TO STEP DOWN from the Board of Directors of David Suzuki Foundation.

Anti-Pesticide Activists LIE Regarding Alternatives

Despite claims to the contrary, overall, there are NO viable, efficacious, economical, or low-risk alternatives to replace conventional pest control products.

So-called alternatives, such as Corn Gluten Meal, Fiesta, Flame-Throwers, Nematodes, and Sarritor, are DISMAL FAILURES.

Green Alternative Pesticides are INEFFECTIVE, INADEQUATE, HIGH-RISK, INEFFECTIVE, MORE TOXIC, and STUNNINGLY EXPENSIVE !

Green Alternative Pesticides are NOT viable, NOT efficacious, NOT economical, NOT low-risk ... most are NOT even legal.

Green Alternative Pesticides are BOGUS and DISMAL FAILURES — they DO NOT WORK — Lisa Gue is WRONG !

Green Alternative Pesticides are products that are supposed to REPLACE conventional pest control products.

Green Alternative Pesticides are NOT superior to conventional pest control products.

Unfortunately, there are NO viable, efficacious, economical, or lower-risk alternatives to replace the PROHIBITED products, and there will likely be NONE within our collective lifetime.

There are NO Green Alternative Herbicides that selectively and effectively control weeds in turf.

There are NO Green Alternative Insecticides for Chinch Bugs, a major damaging pest in home lawns.

There are NO Green Alternative Insecticides that effectively control White Grubs, another major turfgrass pest.

Fortunately, CONVENTIONAL pest control products are SAFE, EFFECTIVE, ECONOMICAL, and LOW-RISK.

Virtually all Green Alternative Pesticides are BOGUS, displaying NEGATIVE CHARACTERISTICS such as the following —

- Green Alternative Pesticides are ALMOST TOTALLY INEFFECTIVE except under very specific circumstances.
- Green Alternative Pesticides, such as Acetic Acid and Corn Gluten Meal, are PROHIBITED in some municipal jurisdictions.
- Green Alternative Pesticides are questionably HIGHER IN TOXICITY when compared to conventional products.
- Green Alternative Pesticides are STUNNINGLY MORE EXPENSIVE to use when compared to conventional pest control products.
- Green Alternative Pesticides are SUPPLIED by the same Anti-Pesticide Organizations that actively sought the prohibition of conventional pest control products.
- Green Alternative Pesticides may have NEGATIVE SIDE-EFFECTS like phyto-toxicity (an effect that adversely affects plant growth) or metal corrosion or rodent-attractant.
- Green Alternatives, like Nematode Insecticides, are NOT legally registered as pest control products, and therefore, are UNREGULATED.
- Green Alternative Pesticides will NOT fully control pests, and will only provide PARTIAL SUPPRESSION.
- Green Alternative Pesticides will NOT have a full range of safety information such as HUMAN TOXICITY and ENVIRONMENTAL IMPACT, which is necessary for the registration of conventional pest control products.
- Green Alternative Pesticides will require EXTREMELY-HIGH-INPUTS OF ACTIVE INGREDIENT since they will otherwise be less effective — the rates and the frequency of application may be exorbitantly high.

- Green Alternative Pesticides will require MORE PERSONAL PROTECTION for the user.
- Green Alternatives like WEED-BURNING FLAME-THROWERS may BURN DOWN BUILDINGS AND HOMES ... just like NAPALM !
- Green Alternative Pesticides are NOT SAFER, NOT BETTER, NOT MORE EFFECTIVE, and NOT LOWER-RISK when compared to conventional pest control products.

LIES Concerning Green Alternative Pesticides

NON-EXPERT Anti-Pesticide Activists, like Lisa Gue, ALLEGE, with NO SCIENTIFIC PROOF, that pest control products are somehow the cause of health and environmental issues.

Anti-Pesticide Activists are NOT CREDIBLE experts on pest control products.

This PROBLEM WITH LACK-OF-ACTIVIST-CREDIBILITY reflects the overall larger problem with ALL Anti-Pesticide Activists.

There are NO Anti-Pesticide Activists who are scientists or researchers with credentials in the field of pest control products.

NONE !

They are NOT COMPETENT to talk about pest control products.

NON-EXPERT Anti-Pesticide Activists COMPENSATE for their INCOMPETENCE by becoming COMPULSIVE LIARS, especially about Green Alternatives.

Anti-Pesticide Activists LIE to Government Officials and the public that viable, efficacious, economical, or lower-risk Green Alternatives are already available to replace conventional pest control products.

Anti-Pesticide Activists LIE !

Anti-Pesticide Activists, like Lisa Gue, who promote Green Alternatives DO NOT KNOW WHAT THEY ARE TALKING ABOUT !

Moreover, instead of increasing the public's awareness of the largest known preventable causes of health issues, such as smoking and diet, Anti-Pesticide Activists prefer SCAMMING, DECEIVING, and ALARMING the public into believing there is some IMAGINARY DANGER with conventional pest control products.

Rather than providing information for improving the lifestyle choices of the public that could, without a doubt, actually save lives, Anti-Pesticide Activists prefer CONCOCTING MYTHS, DECEPTIONS, FEAR-MONGERING, FRAUDULENT LIES, MISCONCEPTIONS, COERCION, THREATS, TERROR, and PARANOID CONSPIRACIES about conventional pest control products.

Green Alternative Pesticides and CHILDREN

Green Alternative Pesticides are NOT SCIENTIFICALLY SAFE !

Green Alternative Pesticides may be considered as UNSAFE as using Agent Orange, DDT, and other controversial products.

Green Alternative Pesticides are questionably HIGHER IN TOXICITY, and pose HIGHER ENVIRONMENTAL RISKS.

Green Alternative Pesticides should not be allowed anywhere near CHILDREN !

Green Alternative Pesticides and EVEN organic fertilizers may contain ...

- Fermented Materials
- Heavy Metals
- Living Pathogenic Organisms

NORAHG

Green Alternative Pesticides MAY BE DEEMED UNSAFE FOR CHILDREN, ADULTS, AND THE ENVIRONMENT.

Green Alternatives, like Nematode Insecticides, are NOT legally registered as pest control products, and therefore, are UNREGULATED.

Green Alternatives, like Fiesta Herbicide, are associated HEALTH PROBLEMS like Hemochromatosis, the most common form of iron overload disease.

Many Green Alternative Pesticides have NOT BEEN TESTED by Good Laboratory Practice (GLP) qualified laboratories, as is the case with CONVENTIONAL pest control products registered by the Federal Government.

Many Green Alternative Pesticides may be deemed NOT SAFE, especially for children !

Fortunately, there are VIABLE ALTERNATIVES to Green Alternative Pesticides.

CONVENTIONAL pest control products are SCIENTIFICALLY SAFE !

CONVENTIONAL pest control products are applied at VERY LOW DOSES, and DO NOT PRESENT A CONCERN TO CHILDREN ... and even people.

CONVENTIONAL pest control products CAUSE NO HARM.

Overall, when CONVENTIONAL pest control products are used properly, there are NO harmful irreversible effects to health and the environment !

When CONVENTIONAL pest control products are used properly, they can be deemed SAFE FOR CHILDREN !

Anti-Pesticide Activists, like Lisa Gue, who promote Green Alternatives DO NOT KNOW WHAT THEY ARE TALKING ABOUT !

Background Information from an Independent Perspective

Prohibition WILL Be Imposed in British Columbia

By 2012, the NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products used in the Urban Landscape WILL BE IMPOSED throughout the Province of British Columbia.

In 2011, the Government of British Columbia invited the public to participate in MOCK-CONSULTATIONS concerning a proposal to PROHIBIT pest control products in the Urban Landscape.

This was organized by the government's Special Committee on Cosmetic Pesticides, which was appointed by the Legislative Assembly of British Columbia.

The British Columbia PROHIBITION will be 100 per cent Politically-Based and 0 per cent Science-Based.

And PROHIBITION will INEVITABLY include the GOLF INDUSTRY.

Mock-Consultations

The MOCK-CONSULTATIONS by Special Committee on Cosmetic Pesticides were DONE IN BAD FAITH.

Nevertheless, Special Committee on Cosmetic Pesticides MAINTAINED THE PRETENSE of listening to what the public had to say with its MOCK-CONSULTATIONS.

While seemingly listening to all interested parties regarding the fate of « *cosmetic pesticides* », Special Committee on Cosmetic Pesticides will, BEYOND ANY DOUBT, RECOMMEND THE PROHIBITION of pest control products in the Urban Landscape.

Background Information from an Independent Perspective (continued)

Mock-Consultations (continued)

The ULTIMATE GOAL of many Anti-Pesticide Lunatic members of this committee was to IMPOSE the PROHIBITION of pest control product used in the Urban Landscape.

Doctor Keith R. Solomon

Doctor Keith R. Solomon, Ph.D., is a Professor in the Department of Environmental Biology at the University of Guelph.

Solomon is also Director of the Centre for Toxicology.

According to Dr. Solomon in his presentation to Special Committee on Cosmetic Pesticides in British Columbia on November 8th, 2011 —

- There are NO TOXICOLOGICAL or HEALTH REASONS for Anti-Pesticide PROHIBITION.
- NOT EVERY pest control product is highly toxic.
- NOT EVERY pest control products is highly dangerous.
- Pest Management Regulatory Agency uses the PRECAUTIONARY APPROACH to set guidelines for exposures for humans.
- At least in home and garden use, most pest control products are actually VERY NON-PERSISTENT.
- There is really A LACK OF EVIDENCE linking pest control product exposure to human risks of cancer.

Background Information from an Independent Perspective (continued)

Doctor Keith R. Solomon (continued)

- There is NO EVIDENCE of ANY causal link between pesticide use and cancer.
- Pest control products are LESS TOXIC THAN TABLE SALT.
- EPIDEMIOLOGY STUDIES are really based only on CORRELATION and SUGGESTED LINKS, and they CANNOT ESTABLISH CAUSALITY ON THEIR OWN.

Dr. Solomon told the committee that ...

If you want to do it [impose PROHIBITION] for political reasons, that's fine.

That's within your mandate.

But if you do that, you should be honest enough to admit that you're actually doing that.

Consider the countervailing risks.

There are certainly INCREASED COSTS related to either the actual cost of the alternatives, or the lack of efficacy of many of these, which means they have to be applied MORE OFTEN, and this INCREASES COSTS as well.

The alternatives are not all themselves without risk.

Background Information from an Independent Perspective (continued)

The Fraser Institute

The Fraser Institute is an independent non-profit research and educational organization (THINK-TANK) based in Canada that espouses free market principles.

In 2010, The Fraser Institute was ranked No. 1 among 97 THINK-TANKS in Canada, for the third year in a row, in the University of Pennsylvania's Global Go-To THINK-TANK Index, a global survey of close to 1,500 scholars, policy makers, and journalists.

The Fraser Institute was also rated as the only Canadian organization in the Top 25 leading THINK-TANKS in the world in 2010, out of a global group of 6,480 THINK-TANKS.

According to a 2011 media release from The Fraser Institute ...

- British Columbia is considering adopting ILL-CONCEIVED laws restricting pest control product use that DO NOT accurately reflect the current state of scientific knowledge.
- A HASTY BAN of pest control products SHOULD NOT BE IMPLEMENTED until the underlying science is conclusive and a comprehensive analysis of the potential side-effects resulting from the BAN has been undertaken.
- By BANNING pest control products for cosmetic uses, British Columbia would be following the QUESTIONABLE PRECEDENT several other provinces have set.
- NO cause-and-effect relationship between pest control products and cancer has been established scientifically.

Background Information from an Independent Perspective (continued)

The Fraser Institute (continued)

- 2,4-D, a herbicide used by Professional Lawn Care companies, is in the same cancer-risk category as pickled vegetables and cell-phones.
- The Environmental Impact Quotient (EIQ) for SOAP is HIGHER THAN the EIQ for 2,4-D Herbicide.
- A blanket PROHIBITION lacks the careful contrasting of costs and benefits.
- Politicians should avoid enacting POORLY-DESIGNED regulations to control pest control product use that may ultimately prove MORE DAMAGING than the pest control products themselves.

Activists Become RICH Because of Prohibition

Anti-Pesticide Activists, funded with MILLIONS OF DOLLARS in government grants and public donations, SQUANDER AND MISAPPROPRIATE vast sums of profit to finance the QUESTIONABLE CONSPIRACY to PROHIBIT pest control products in the Urban Landscape.

PROHIBITION continues to make Anti-Pesticide Activists RICH !

The more Anti-Pesticide Activists concoct LIES, THREATS, COERCION, FEAR-MONGERING, MISCONCEPTIONS, and TERROR about conventional pest control products, THE MORE THEY BECOME RICH !

Anti-Pesticide Activists are WASTING MONEY AND RESOURCES because pest control products are, in fact, HEALTH-CANADA-APPROVED, FEDERAL-
LY-LEGAL, SCIENTIFICALLY-SAFE, and PRACTICALLY-NON-TOXIC.

Activists Become RICH (continued)

Anti-Pesticide Activists have a HUGE VESTED INTEREST IN PERPETUATING IMAGINARY DANGERS about pest control products used in the Urban Landscape, attracting HUGE PROFITS and BENEFITS, in the form of DONATIONS, GOVERNMENT GRANTS, and CELEBRITY.

Canadian Cancer Society

Public comments were made to Special Committee on Cosmetic Pesticides by completing an on-line E-QUESTIONNAIRE or by sending a written submission.

Canadian Cancer Society issued « *Model Response* » to « *coach* » people in answering the E-QUESTIONNAIRE.

Predictably, Anti-Pesticide Activists have FLOODED the Special Committee on Cosmetic Pesticides with THOUSANDS, YES THOUSANDS, OF COMMENTS consisting of LIES and MIS-INFORMATION.

Anti-Pesticide Activists « *coached* » by Canadian Cancer Society have CARPET-BOMBED and TERRORIZED the Special Committee on Cosmetic Pesticides.

The issue here is CREDIBILITY of the source of information, since the VAST MAJORITY of the COMMENTS are ORCHESTRATED, through a coast-to-coast CAMPAIGN, using NON-EXPERT VOLUNTEERS with Canadian Cancer Society.

This CAMPAIGN gives an unsuspecting public the FALSE and FRAUDULENT impression that the Anti-Pesticide Movement has considerable size and power, when in fact, IT DOES NOT.

Background Information from an Independent Perspective (continued)

False Allegations

ALLEGATIONS from Anti-Pesticide Activists about the IMAGINARY DANGER of pest control products are TOTALLY FALSE, and are UNTRUE MIS-REPRESENTATIONS designed to alarm and enrage the public.

These ALLEGATIONS from Anti-Pesticide Activists also ENHANCE their BUSINESS, CASH-FLOW, and PROFIT.

There is NOT ONE KNOWN ILLNESS or DEATH from the proper use of pest control products used in the Urban Landscape.

By comparison, there are THOUSANDS OF DEATHS per year from KNOWN CANCER-CAUSING SUBSTANCES such as cigarette smoke and alcohol.

Perhaps if Anti-Pesticide Activists were to prioritize their energies to the primary causes of cancer, such as life-style choices, LIVES WOULD BE SAVED.

Moreover, the MAJOR SOURCE of exposure to pest control products is from FOOD SUPPLY, and NOT the Urban Landscape.

Prohibition CARNAGE

The ONLY known effect of Anti-Pesticide PROHIBITION is BUSINESS CARNAGE.

In jurisdictions like Ontario, PROHIBITION led to the DEATH of an elderly man who was forced to hand-pull TOXIC NOXIOUS WEEDS.

Background Information from an Independent Perspective (continued)

Prohibition CARNAGE (continued)

In jurisdictions where PROHIBITION has been IMPOSED, the Professional Lawn Care Industry has SUFFERED IMMENSE LOSSES, in the HUNDREDS OF MILLIONS OF DOLLARS.

Moreover, because of PROHIBITION, green spaces are OVER-RUN WITH WEEDS, INFESTED WITH INSECTS, and DISMALLY DESTROYED — they look like GARBAGE DUMPS.

BETRAYAL by Trade Associations

Incredibly ... and for some UNFATHOMABLE REASON ... trade associations like Western Canada Turfgrass Association (WCTA) and Canada Nursery Landscape Association (CNLA, a.k.a. British Columbia Landscape and Nursery Association) SUPPORT the PROHIBITION of pest control products in the Urban Landscape.

These trade associations DO NOT represent the interests of the Professional Lawn Care Industry.

Their Voices DO NOT Speak for the Professional Lawn care Industry !

In fact, these IDIOTIC trade associations have gone out of their way to SUPPORT Anti-Pesticide PROHIBITION that will IMMINENTLY BE DEVASTATING to the Professional Lawn Care Industry.

These trade associations not only BETRAYED the ENTIRE Green Space Industry, they have also VALIDATED the Anti-Pesticide agenda, which will lead to TOTAL PROHIBITION of pest control products AND even fertilizers ... INCLUDING the Golf Industry.

BETRAYAL by Trade Associations (continued)

The elected leaders and staff of these trade associations are ATTEMPTING TO RETAIN SAFE, SECURE, WELL-PAYING JOBS AND POSITIONS AS LEADERS ...

... AT THE EXPENSE OF THE JOBS THEY WILL DESTROY IN THE PROFESSIONAL LAWN CARE INDUSTRY.

These IDIOTIC trade associations BETRAYED the Green Space Industry, and TORPEDOED the Professional Lawn Care Industry !
