# Beware of Self-Proclaimed Experts with Inadequate Credentials, Suspect Opinion, and Mythical Stories

Anti-Pesticide Activist Lee Harding is a former administrator and scientist for Environment Canada and Canadian Wildlife Service, but left his government position in 1997.

His work consisted of studies of caribou, grizzly bears, mink, and muskrats.

Harding has produced NO scientific literature pertaining to the use of pest control products in the Urban Landscape.

In fact, he has NO recognized training, experience, or background with these products.

Anti-Pesticide Activists like Harding are NOT CREDIBLE experts on pest control products.

Harding is also CLOSELY ATTACHED to Anti-Pesticide Organizations like Wildsight and Port Moody Ecological Society, which also make his opinion COMPLETELY SUSPECT.

Ostensibly, Harding wants the Government of British Columbia to IMPLEMENT a NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products used in the Urban Landscape.

Furthermore, Harding has a VESTED INTEREST in PROMOTING Anti-Pesticide PROHIBITION since he has been operating a FOR-PROFIT environmental consulting business named SciWrite since 1984.

However, Harding is CORRECT in saying that there is a HUGE BODY SCIENTIFIC KNOWLEDGE regarding pest control products.

Nonetheless, Harding COULD NOT EVEN BE BOTHERED to have used the EXTENSIVE TOXICOLOGY DATABASE that is available from either Health Canada or U.S. Environmental Protection Agency.

Evidently, Harding prefers to attempt PROFITING from Anti-Pesticide PROHIBITION with his environmental consulting business, at the expense of the Professional Lawn Care Industry.

Harding ALLEGES that « some people and pets are more sensitive than average, and can become sick even when a pesticide is used as directed ».
