Marketplace, a series broadcast on CBC Television, analyzed Canadian-Cancer-Society's financial reports dating back a dozen years.

It discovered that each year, as the society raised more dollars, the proportion of money it spent on research DROPPED DRAMATICALLY — from 40.3 per cent in 2000 to under 22 per cent in 2011.

The amount of money spent on research has increased slightly over the years, but as a portion of the Canadian-Cancer-Society's growing budget, it has ALMOST BEEN CUT IN HALF.

In 2011, Lichty and some of his colleagues set up an information booth at the Relay for Life Fund-Raiser in Ancaster, Ontario, to raise awareness about the DROP IN FUNDING FOR RESEARCH AT CANADIAN-CANCER-SOCIETY.

According to Brian Lichty, Researcher at McMaster University —

<< Cancer researchers are spending a lot of their time, or most of their time, trying to figure out how to get the money to fund their research, rather than actually doing research. And it has become a much bigger portion of what our day-to-day activities amount to. >>

Spending a FORTUNE on Fund-Raising

Marketplace asked Canadian-Cancer-Society for an on-camera interview, but it declined, instead responding by e-mail.

According to the Cancer-Lunatics —

<< While funding cancer research is a crucial part of the society's work, we also have profound responsibilities to do everything we can to reduce the risk of Canadians ever developing cancer and to provide meaningful support to people living with cancer. >>

But when Marketplace scrutinized the financial reports, it found that A GREATER PERCENTAGE OF FUNDS WAS NOT BEING DIRECTED TOWARD SUPPORT, INFORMATION AND ADVOCACY.

Instead, the reports reveal that the area that is getting THE GREATEST PORTION OF DONOR DOLLARS is FUND-RAISING, up from 26 per cent of all monies raised in 2000, to 42.7 per cent in 2011.

Greg Thomson, a spokesman for the charity watch-dog Charity Intelligence, said Canadian-Cancer-Society appears to SPEND MORE ON FUND-RAISING than a number of other charities.

<< I would want to understand better what they're spending their money on, why they're spending that much. Because we found a number of very effective organizations that don't need to spend nearly the percentages on fundraising and admin that we've seen. >>

According to Brian Lichty, Researcher at McMaster University —

<< I suspect, if donors are not happy with the situation, if they want a greater proportion of their money to go to research — because that is why they donated their money — then maybe there will be a grass-roots movement. Some pressure from the donors and the volunteers to try and find a way to put more of the money they raise into research. >>

Marketplace is a Canadian television series, broadcast on CBC Television. Launched in 1972, the series is a consumer advocacy newsmagazine, which shows investigative reports on issues such as product testing, health and safety, fraudulent business practices and other news issues of interest to product and service consumers.

The program was influential in the banning of urea formaldehyde foam insulation and lawn darts in Canada, the legislation of warnings on exploding pop bottles, successful prosecution of retailers for false advertising, new standards for bottled water and drinking fountains, new regulations to make children's sleep-wear less flammable, and the implementation of safer designs for children's cribs.



Canada Revenue Agency — Informant Leads Program

The Canada Revenue Agency (CRA) takes abuse of Canada's tax laws very seriously.

When an individual or business does not fully comply with tax legislation, an unfair burden is placed on law-abiding tax-payers and businesses and the integrity of Canada's tax base is jeopardized.

The mandate of the Informant Leads Program is to co-ordinate all leads that the CRA receives from informants, to determine if there is an element of non-compliance with tax legislation, and to ensure that appropriate enforcement action is taken.

The program is regionalized into five offices across the country.

To report suspected tax evasion, contact the office in your region.

An informant's identity will not be disclosed or you may provide information anonymously.

Notable activities — worked in virtually all aspects of the green space industry, including golf, professional lawn care, distribution, environmental compliance, government negotiations, public affairs, and workplace safety • supervisor, consultant, and, programmer for the successful execution of hundreds of thousands of management operations in the golf and urban landscape, as well as millions of pest control applications • advisor, instructor, and trainer for thousands of turf and ornamental managers and technicians • pesticide certification instructor for thousands of industry workers • founder of the modern professional lawn care industry • prolific writer for industry publications and e-newsletters • first to confirm the invasion of European Chafer insect in both the Montreal region and the Vancouver/Fraser Valley region • with Dr. Peter Dernoeden, confirmed the presence of Take-All Patch as a disease of turf in Eastern Canada • with Dr. David Shetlar, confirmed the presence of Kentucky Bluegrass Scale as an insect pest in South-Western Ontario, and later, in the Montreal and Vancouver regions
