

INTRODUCTION

In Canada, pesticides are used for either cosmetic reasons (to improve the look of gardens, lawns and other green spaces) or noncosmetic reasons (to protect our food and water supply, or to prevent the spread of disease).



Our position on the use of pesticides depends on what they are being used for.

Our position on cosmetic use of pesticides

The cosmetic use of pesticides provides no health benefit, and may cause harm. [Wrong!]

EVIDENCE ABOUT CANCER NOT DEFINITE

The EVIDENCE ABOUT PESTI-CIDES AND CANCER IS NOT DEF-INITE, but some research studies show a stronger link between some types of pesticides and cancers. [Wrong!]

Pest Control Products DO NOT CAUSE CANCER.

Canadian Cancer Society has NO CREDIBLE EXPERTISE since it is a mere FUND-RAISING, PROFIT-SEEKING, and LOBBYING organization, and it is NOT a science, research, or health organization.

Canadian Cancer Society has STATED RE-PEATEDLY that scientific research does NOT provide a conclusive link between pest control products and cancer.

THE PRECAUTIONARY **PRINCIPLE**

Our position is based on the precautionary principle, which states

> When an activity raises threats of harm to human health or the environment, precautionary measures should be taken even if some cause-andeffect relationships are not fully established scientifically.

(If something may cause harm to humans or the environment, we should be cautious even if the link is NOT DEFINITE yet.)

The Precautionary Principle Is DISCREDITED.

Solomon is Professor at the Centre for Toxicology and Department of Environmental Biology, University of Guelph, and Director, Canadian Network of Toxicology Centres.

Landscape and garden use of pest control products DOES ERATION under the precautionary principle.

They are not serious, they are selective to pests, have low toxicity to non-target organisms, and are well understood.

control products are NOT IRREVERSIBLE.

There is rapid recovery through reinvasion and weed seeds and most need to be used at least once per year.

A well-maintained conventional lawn and landscape, or a pest-free crop, can ON-LY BE ACHIEVED WITH CONVENTIONAL pest control products.

Fortunately, CONVENTIONAL pest control products are SAFE, EFFECTIVE, ECONOMICAL, and LOW-RISK.

The SAFEST WAY to maintain Green Spaces is with pest control products that are HEALTH-CANADA-APPROVED, FED-ERALLY-REGULATED, SCIENTIFICALLY-SAFE, PRACTICALLY-NON-TOXIC, and CAUSE NO HARM.

PESTICIDES USED AS A LAST OPTION

PESTICIDES SHOULD BE USED AS THE LAST OPTION, in the smallest possible amount, and only where needed to make a place usable. [Wrong!]

Commentary From An Independent Perspective

NO BENEFIT And NO SCIENTIFIC BASIS For Use As Last Option.

There is NO BENEFIT and NO SCIENTIFIC BA-SIS to simplistic messages like « use least toxic pesticides as a last resort » for the large number of end-users who apply pest control products according to the label and practice good stewardship.

Nor are these messages beneficial for those who neither seek training nor adequately read practical, and effective to simply choose a product considered a « least toxic pesticide »

These messages hinder safety and stewardship education and practices that are in the best interest of the end-user, our food supply, public health, and ecosystem preservation.

American Phytopathological Society, Entomological Society of America, and Weed Science Society of America do not promote the use of pest control products above other pest management techniques.

Pest control products should ONLY be used when needed, when risks to non-target organisms and habitats have been carefully considered, and when diligent attention will be given to following all label directions and other applicable laws.

In addition, general and product-specific stewardship must always be practiced to prevent undesired effects under the particular application conditions.



Cancer-Lunatic Position On Pesticides

RE-ENTRY INTERVAL AFTER AN APPLICATION

People should STAY AWAY from treated areas for at least 48 HOURS after the last amount of pesticide is applied. [Wrong!]

Commentary From An Independent Perspective

Keep People Off Treated Area Until Foliage Is Dry.

Re-Entry Intervals are set to ensure that any remaining pest control product residues on the treated surface do not pose an unacceptable risk to human health.

Re-Entry Intervals reflect the amount of time required for pest control product levels to dissipate (either from uptake into the plant, or degraded by natural processes) to a level that is well below any point of concern.

Re-Entry Intervals are established using a science-based approach to predict the amount of a pest control product that may be deposited surface.

All pest control products used by Professional Lawn Care companies require the following Re-Entry Interval —

until foliage is dry.

This requirement applies to MOST products applied on Golf Course Turf, except Compass 50 WG, which has a Re-Entry Interval of 12 hours, and Heritage MAXX, which has a Re-Entry Interval of 4 hours.

There are NO pest control products applied to turf that require a Re-Entry Interval that is beyond 12 hours, and certainly, there are NONE where 48 hours is required.

Cancer-Lunatic Position On Pesticides

AGRICULTURE INDUSTRY

The use of pesticides in home or personal fruit-and-vegetable gardens should also be PHASED OUT.

Although the pesticides you use at home may be milder than those used for AGRICULTURE ... [Wrong!]

... and you may use them less of-

In the AGRICULTURE BUSINESS, there are usually more rules in place to reduce exposure, such as training for people who apply pesticides to properly use equipment that protects them, plans to reduce residue levels and pesticide drift, and rules to limit access to sprayed areas.

We encourage farming practices that reduce the use of pesticides. [?!?!]

Notable activities — worked in virtually all aspects of the green space industry, including golf, professional lawn care, distribution, environmental compliance, government negotiations, public affairs, and workplace safety • supervisor, consultant, and, programmer for the successful execution of hundreds of thousands of management operations in the golf and urban land-scape, as well as millions of pest control applications • advisor, instructor, and trainer for thousands of turf and ornamental managers and technicians • pesticide certification instructor for thousands of industry workers • founder of the modern professional lawn care industry • prolific writer for industry publications and e-newsletters • first to confirm the invasion of European Chafer insect in both the Montreal region and the Vancouver / Fraser Valley region • with Dr. Peter Dernoeden, confirmed the presence of Take All Patch as a disease of turf in Eastern Canada • with Dr. David Shetlar, confirmed the presence of Kentucky Bluegrass Scale as an insect pest in South Western Ontario, and later, in the Montreal and Vancouver regions

Special contributions — creator of the exception status that has allowed the golf industry to avoid being subjected to ant pesticide prohibition • creator of the signs that are now used for posting after application • co-founder of annual winter convention for Quebec golf course superintendents • the major influence in the decision by Canadian Cancer Society to stop selling for profit pesticide treated daffodils • the only true reliable witness of the events of anti pesticide prohibition in the town of Hudson, Quebec • retired founder of FORCE OF NATURE and A LOOK AT reports

Notable award — the very first man of the year for contributions leading to the successful founding of Quebec professional lawn care industry, which served as a beach-head against anti pesticide activists in the 1980s and 1990s
