Extraordinary crimes by Physicians For Global Survival had to be AVENGED by extraordinary people at Canada Revenue Agency.

In November 2008, following an AUDIT of Physicians For Global Survival (PGS), Canada Revenue Agency charged that Warren Bell's RIDICULOUS Enviro-Lunatic Terrorist Organization was ...

... NOT constituted and operated for exclusively charitable purposes and does not devote all of its resources to charitable activities.

On February 22nd, 2011, Canada Revenue Agency issued its NOTICE OF INTENTION TO REVOKE PGS'S CHARITY TAX-EXEMPT STATUS.

According to Canada Revenue Agency —

[Physicians For Global Survival] existed in part for « the promotion of nuclear disarmament », which we considered to BE AN UNSTATED COLLATERAL POLITICAL PURPOSE ...

... in our view, such a purpose was NOT CHARITABLE under the advancement of education or under other purposes BENEFICIAL to the community deemed by law to be charitable.

According to the Income Tax Regulations, REGISTERED CHARITY TAX-EXEMPT organizations like Warren Bell's Physicians For Global Survival MAY ONLY DEVOTE A MAXIMUM OF 10 PER CENT OF THEIR TOTAL RESOURCES TO NON-PARTISAN POLITICAL ACTIVITIES, which are defined as ANY TYPE OF CALL TO POLITICAL ACTION (i.e. INTERFERENCE IN PARTISAN POLITICS).

During its audit, Canada Revenue Agency determined that Warren Bell's Physicians For Global Survival was ...

Guilty Of Using 26 Per Cent Of Its Resources For Political Activities

This included BLATANT INTERFERNCE IN PARTISAN POLITICS with a letter-writing campaign to the Prime Minister and Members Of Parliament to support a ban on nuclear weapons.

In response to being FOUND GUILTY OF CONSPIRACY TO INTERFERE IN PARTISAN POLITICS, an UNREPENTENT Warren Bell responded by deeming the audit as « *remarkably fuzzy* », where definitions can basically be altered according to the whim of the government-of-the-day.

Why are Bell's organizations even necessary to society ?

The actions by PGS RAISED QUESTIONS about its VALIDITY and CREDIBILITY — why did PGS deserve a CHARITY TAX-EXEMPT STATUS ?

Bell also uses CAPE to INVALIDATE HEALTH CANADA, and to IMPOSE UNNECESSARY ANTI-PESTICIDE PROHIBITIONS across the nation, despite overwhelming scientific evidence proving that pest control products are SCIENTIFICALLY-SAFE, CAUSE NO HARM, and DO NOT CAUSE CANCER.

These actions by CAPE have RAISED QUESTIONS about its VALIDITY and CREDIBILITY.

Activists like Bell who operate these organizations have HUGE VESTED INTERESTS in perpetuating imaginary dangers about a variety of BOGUS ENVIRONMENTAL ISSUES because THEY PAY THEMSELVES VAST SUMS OF MONEY TO DO SO.

Are Warren Bell's organizations necessary to society ?

The answer is NO.

Perhaps it is time for Canada Revenue Agency to AUDIT Warren Bell's TAX-RECORDS for the last ten years, which covers the period of time that he was operating as a LOBBYIST for Canadian Cancer Society, as well as Canadian Association Of Physicians For The Environment.

Moreover, Canada Revenue Agency must VERIFY whether Bell is declaring his income as a LOBBYIST for these organizations.

It is time to investigate Warren Bell himself.

THE AVENGERS Against Suzuki

Extraordinary crimes by David Suzuki Foundation have to be AVENGED by extraordinary people at Canada Revenue Agency, otherwise known as THE AVENGERS.

On April 23th, 2012, David Suzuki Foundation became THE TARGET OF A COMPLAINT TO THE CANADA REVENUE AGENCY (CRA), just days after its namesake co-founder, David Suzuki himself, STEPPED DOWN amid heightened tensions between environmental charities and the Government of Canada.

EthicalOil.org, a non-profit organization that promotes oil from Canada and other democracies, sent a COMPLAINT to Canada Revenue Agency asking it to INVESTIGATE whether David Suzuki Foundation is BREAKING RULES THAT PERTAIN TO POLITICAL ACTIVITY.

Registered charities are allowed to devote only a SMALL FRACTION of their resources to POLITICAL ACTIVITY, although they can NEVER BE PARTISAN.

EthicalOil.org said in its 44-page COMPLAINT, which was drafted by Calgary-based JSS Barristers —

If you find the Suzuki Foundation is in contravention of the CRA rules, then we request that you consider whether the Suzuki Foundation should have its CHARITABLE STATUS REVOKED or otherwise be SANCTIONED.

The COMPLAINT relates to David Suzuki Foundation's activities since 2011, and the bulk of the COMPLAINT outlines allowable political activity such as letter-writing campaigns to federal politicians or blog posts urging the

Government of Canada to change its environmental policies.

Jamie Ellerton, Executive Director of EthicalOil.org, said those activities point to David Suzuki Foundation's POLITICIZATION.

According to Ellerton, Canada Revenue Agency should ...

... determine whether or not they are crossing the 10 per cent political threshold and VIOLATING CHARITIES LAW.

The COMPLAINT also says David Suzuki Foundation RECEIVED FUNDING FROM THE BRITISH GOVERNMENT, and that the purpose of the funding may have been TO FORWARD THE POLICIES OF THE UNITED KINGDOM GOVERNMENT ON CLIMATE CHANGE IN CANADA.

Ellerton said the COMPLAINT was faxed to David Suzuki Foundation, but the organization did not confirm receipt or provide comment.

Ellerton said that organizations like Suzuki should FORGO CHARITABLE STATUS — and all the economic benefits it brings — if they want THE FREEDOM TO BE POLITICAL —

What we're looking to accomplish [in issuing a complaint to the revenue agency] is to ENSURE TAX-PAYERS AREN'T SUBSIDIZING THE POLITICAL ACTIVITY of the David Suzuki Foundation.

Other portions of the COMPLAINT accuse David Suzuki Foundation of ENGAGING IN PROHIBITED PARTISAN ACTIVITY and point to the following as two examples —

- A blog post titled ONTARIO LIBERAL PLATFORM MAINTAINS GREEN ENERGY

FOCUS, which was published two days after the 2011 provincial election was called in 2011; and

- A July 2011 Toronto Star article that reported Mr. Suzuki had endorsed Premier Dalton McGuinty and was URGING ONTARIANS TO RE-ELECT THE LIBERAL LEADER.

EthicalOil.org also mounted a FORMAL COMPLAINT against Environmental Defence in March 2012.

THE AVENGERS Against Greenpeace

Extraordinary crimes by Greenpeace have to be AVENGED by extraordinary people at the Government of New Zealand, otherwise known as THE AVENGERS.

In New Zealand, Greenpeace, an Anti-Pesticide and Enviro-Lunatic Terrorist Organization, appealed against a 2010 ruling by the Charities Commission, which found ITS PROMOTION OF DISARMAMENT AND PEACE was POLITICAL rather than educational, and while it did not directly advocate illegal acts, Greenpeace-Lunatics had ACTED ILLEGALLY.

According to Justice Paul Heath —

Non-violent, but potentially ILLEGAL ACTIVITIES (such as trespass), designed to put (in the eyes of Greenpeace) objectionable activities into the public spotlight were an independent object DISQUALIFYING it from registration as a charitable entity.

According to Justice Heath, Greenpeace's pleas for disarmament and peace COULD BE SEEN AS AN INDEPENDENT PURPOSE, and its

political activities WERE NOT NECESSARY to educate members of the public on the key issues of Greenpeace.

Greenpeace-Lunatic-Lawyer Davey Salmon argued all of the organisation's primary purposes were charitable and the engagement of charities in political advocacy was more acceptable now in 21st Century New Zealand.


