

DDT is the ONLY chemical under the UN Stockholm Convention on Persistent Organic Pollutants that is granted an exemption for use in public health. Key points in this Outlook :

• UN agencies are misleading the public by claiming that malaria can be controlled without insecticides, notably DDT. The stated aim is to stop DDT use globally by 2020.

• UN agencies are committing scientific fraud by deliberately and incorrectly interpreting data on malaria control using noninsecticide methods.

• While DDT is no panacea, it is still a critical weapon in the battle against malaria and other insect-borne diseases.



The United Nations Stockholm Convention on Persistent Organic Pollutants (POPs), which came into force in 2004, governs the use of DDT.

DDT is the ONLY chemical under the UN Stockholm Convention on Persistent Organic Pollutants that is granted an exemption for use in public health.

It is against this background that the Stockholm Convention Secretariat and the financial mechanism of the convention, the GLOBAL ENVIRONMENT FACILITY (GEF), the UN Environment Program (UNEP), and groups within the Pan American Health Organization (PAHO) and World Health Organization (WHO) have engaged in SCIENTIFIC MAL-FEASANCE to achieve political goals, the most obvious being DDT elimination by 2020.

GLOBAL ENVIRONMENT FACILITY was established in 1991 and is a partnership of ten agencies, including the World Bank, which houses the GEF.

GLOBAL ENVIRONMENT FACILITY has allocated over 9 BILLION DOLLARS in funds for projects with the aim of improving the environment, and has raised over 40 BILLION DOLLARS from other partners for its projects. For over seventy years, DDT has been a vital insecticide in the battle against disease.

Yet it is vilified for largely illegitimate concerns about its impact on the environment and human health.

Through a mix of environmental fervor, self-interest, and disregard for evidencebased policy, United Nations (UN) agencies are misleading the public about DDT mistakenly claiming it is not needed and can be eliminated globally by 2020.

Such claims must be withdrawn, and the aggressive timeline for the elimination of DDT must be shelved.



CONTROL OVER THE USE OF INSECTICIDES for public health also GIVES AGENCIES CONTROL OVER FUNDS

At stake is not only INCREASED POWER OVER THE USE OF CHEMICALS for the control of diseases, but also the REPUTATIONAL BENEFITS of achieving a goal deemed desirable by environmental groups.

In addition, one cannot discount the fact that MANY MILLIONS OF DOLLARS have been spent by numerous governments through the United Nations system to rid the world of Persistent Organic Pollutants (POPs) and find alternatives to DDT.

CONTROL OVER THE USE OF INSECTI-CIDES for public health also GIVES AGEN-CIES CONTROL OVER THESE FUNDS.

This Outlook spotlights a peer-reviewed paper in Research and Reports in Tropical Medicine, which exposes false claims about an insecticide-free malaria-control project managed by UN Environment Program, and financed by Global Environment Facility in Mexico and Central America. Furthermore, the World Health Assembly, the governing body of the World Health Organization, must prioritize the needs of malarial countries ahead of the political agenda of UN agencies and set a positive agenda for the use of DDT and the development of much-needed new public-health insecticides.

Independent donors should continue to fund DDT use where needed for malaria control.

The campaign against DDT means it is used far less than is efficient or desired by malaria-control programs.



The control of malaria through so-called sound-environmental-methods-without-DDT was UNSUCCESSFUL

Claims that environmental interventions were effective ARE INVALID

The project was designed to demonstrate successful control of malaria through the use of « *environmentally sound* » methods without DDT and other insecticides.

Almost inevitably, the project's backers claimed it achieved this objective. [?!?!]

A proper analysis of epidemiologic data, however, revealed NO SUCH SUC-CESS.

Reductions in malaria cases and deaths in the region were achieved primarily through pharmaco-suppression (therapeutic and prophylactic use of anti-malarial drugs).

Claims that environmental interventions were effective ARE INVALID.

LET'S PAUSE ... AND LOOK AT SOME ALARMING STATISTICS

It has been predicted that so-called GLOBAL WARMING will affect the Arctic, as well as the African and Asian countries, North America, and Europe.

Consequently, it is expected that dozens of millions of refugees will be created, and that famine will affect 80 to 200 million people.

Every day, almost 16,000 children DIE from hungerrelated causes — almost 6 MILLION CHILDREN DIE ANNUALLY due to hunger.


The latest statistics on the world epidemic of AIDS and HIV indicate that 39¹/₂ million people are living with it.

AIDS deaths for 2006 were 2.9 million, despite recent improvements to access to anti–retroviral treatment.

Equally serious is the fact that a world–wide shortage of fresh drinking water affects forty per cent of the planet's population.

Each year, 11 MILLION PEOPLE DIE of diseases related to water that is not clean enough for consumption.

Finally, some observers believe that Malaria acutely afflicts MORE THAN 515 MILLION PEOPLE PER YEAR.



515 MILLION PEOPLE is MORE PEOPLE than live in Canada, the United States, and Mexico, combined.

Two-thirds of all Malaria cases occur in Africa.

Additionally, Malaria causes more than 1 MILLION DEATHS PER YEAR, principally among children under the age of five years and pregnant women.

At least eighty-six per cent of these deaths are in Sub-Saharan Africa.

Globally, an estimated 3,000 women, children, and infants DIE from Malaria every day.

Twelve billion dollars per year is lost to Malaria.

In some countries, more people die of Malaria than HIV/AIDS — and recently, a new study showed that people who contract Malaria become more likely to spread HIV.

ERADICATING MALARIA WITH DDT

Malaria has wrought an enormous economic toll, by incapacitating otherwise productive people.

The burden of Malaria costs Sub–Saharan Africa an estimated twelve billion dollars per year.

Thousands survive the disease with brain damage, thus keeping millions at home to care for them.

It is the principal reason why people in Africa are living in abject poverty.

Both North America and Europe have not harboured Malarial mosquitoes since the 1940s.

This was accomplished through the use of a range of public health measures, as well as generally increasing health and living standards.

In fact, the beginning of the decline of Malaria was due principally to the drainage of swampland and the removal of mill-ponds.

It had been known since 1914 that Malaria could be controlled by fluctuating water levels.

Nonetheless, DDT contributed to the final eradication of Malaria in the developed world.

In 1955, the World Health Organization (WHO) began a program to eradicate Malaria throughout the ENTIRE world.

The program RELIED GREATLY upon the application of DDT to control mosquitoes, with a practice called DDT Residual House Spraying.

As a result of this program, by 1967, Malaria was eradicated from all developed countries where Malaria was endemic.

Large areas of tropical Asia and Latin America were freed from the risk of infection.

In Sub–Saharan Africa, the campaign was only launched in three countries since it was not considered feasible in the others.



Swaziland and Mozambique are examples of countries that have very successfully REDUCED Malaria infestations with DDT.

Throughout the years, spectacular DECREASES in Malaria infections and deaths were seen after implementing an extensive anti–mosquito program with DDT.

Here are five examples. —

- India 1945
- Almost 1 million Malaria I deaths reported
 - India 1960 ■ Only a few thousand cases were reported
- Republic of China (Taiwan) 1945
 1 million cases of MALARIA. DDT was soon adopted

Republic of China **1969**

- Only 9 cases were reported, and shortly thereafter, Malaria was eradicated from the island
- Skri Lanka (Ceylon)
 1946
- 28 million cases of Malaria
 - Skri Lanka 1961 ■ Only 110 cases were reported
 - Skri Lanka 1969 ■ The DDT program was halted, and Malaria rebounded with 2¹/₂ million cases

South Africa (KwaZulu Natal Province)
 1996
 DDT was standed and the number of

 DDT was stopped and the number of MALARIAL deaths rose from 8,000 to 42,000

- Venezuela 1943
- 817,000 Malaria I deaths reported
 - Venezuela 1958 ■ Only 800 cases were reported

In 1970, the U.S. National Academy of Sciences summed up the situation with the following excerpt from their book Life Sciences. -

« To only a few chemicals does man owe as great a debt as to DDT. [...] In little more than two decades, DDT has prevented 500 million human deaths, due to MALARIA, that otherwise would be inevitable. »


The situation concerning Malaria eradication can be summarized with the three following points —
