Key points in this Outlook :

- UN agencies are misleading the public by claiming that malaria can be controlled without insecticides, notably DDT. The stated aim is to stop DDT use globally by 2020.
- UN agencies are committing scientific fraud by deliberately and incorrectly interpreting data on malaria control using non-insecticide methods.
- While DDT is no panacea, it is still a critical weapon in the battle against malaria and other insect-borne diseases.

# DDT

## Our World of Politicized Science

Countries in Latin America were FORCED AWAY FROM USING DDT in compliance with the North American Free Trade Agreement, wherein the Commission for Environmental Cooperation of North America ( CEC ) PRESSURED Mexico in the mid-1990s to STOP PRODUCTION AND USE OF DDT.

Without DDT, countries used MORE EXPENSIVE insecticides, which had to be SPRAYED MORE FREQUENTLY, creating PROBLEMS for malaria control.

Over time, the countries in Central America moved to greater use of pharmacosuppression.

Malaria cases have FALLEN as a result of this wide-spread and EXPENSIVE distribution of malaria treatments, but NOT through the environmental controls touted by the United Nations.

Officials of Global Environment Facility ( GEF ), United Nations Environment Program ( UNEP ), and the Secretariat, however, IGNORE the use of pharmacosuppression in their discussion of successful malaria control in Mexico and Central America.

For over seventy years, DDT has been a vital insecticide in the battle against disease.

Yet it is vilified for largely illegitimate concerns about its impact on the environment and human health.

Through a mix of environmental fervour, self-interest, and disregard for evidence-based policy, United Nations (UN) agencies are misleading the public about DDT — mistakenly claiming it is not needed and can be eliminated globally by 2020.

Such claims must be withdrawn, and the aggressive timeline for the elimination of DDT must be shelved.

*The decline of malaria CANNOT be attributed  
to environmental interventions*

Furthermore, these officials FALSELY ATTRIBUTE changes in malaria burdens to Global Environment Facility's environmental interventions.

A separate epidemiological evaluation, which was designed to measure any changes in disease rates, found NO STATISTICAL DIFFERENCES in malaria rates in demonstration areas versus in control areas, and this was consistent across ALL eight countries.

Malaria rates in most countries were FALLING, but with NO difference between the demonstration areas and controls, the DECLINE CANNOT BE ATTRIBUTED TO THE ENVIRONMENTAL INTERVENTIONS.

But United Nations Environment Program ( UNEP ), Global Environment Facility ( GEF ), the Secretariat, and other officials IGNORED those findings.

Furthermore, the World Health Assembly, the governing body of the World Health Organization, must prioritize the needs of malarial countries ahead of the political agenda of UN agencies and set a positive agenda for the use of DDT and the development of much-needed new public-health insecticides.

Independent donors should continue to fund DDT use where needed for malaria control.

The campaign against DDT means it is used far less than is efficient or desired by malaria-control programs.

Furthermore, despite the fact that the control areas were a crucially important part of the project, they were NOT EVEN MENTIONED in the 2008 final report.

Ultimately, the success of reduction in malaria was most likely entirely due to pharmaco-suppression.

One might wonder WHY A CONTROL PROGRAM WOULD REQUIRE INSECTICIDES and vector control if pharmaco-suppression is such a powerful method of malaria control.

This is a complex issue, but it is important to note that even though reductions in malaria cases have been achieved in Mexico and Central America, its model of wide-spread distribution of the anti-malarial drugs chloroquine and primaquine is NOT TRANSFERABLE ELSEWHERE.

First, wide-spread drug resistance to chloroquine in Africa and South-East Asia would make the intervention LARGELY USELESS there.

Second, primaquine is a radical treatment for vivax malaria, whereas in Africa over 90 per cent of malaria cases are caused by the more deadly strain of falciparum malaria.

Third, pharmaco-suppression is EXPENSIVE and REQUIRES MORE SOPHISTICATED HEALTH SYSTEMS THAN EXIST IN MOST OF AFRICA, where the greatest incidence of malaria lies.

So even if United Nations Environment Program ( UNEP ), Global Environment Facility ( GEF ), and their partners were straightforward about the REAL REASON FOR THE DECLINES IN MALARIA in the project areas, there would be NO REASONABLE ARGUMENT that it has any application in other areas, or any usefulness for global malaria-control policy.

We believe the MOTIVATIONS of United Nations Environment Program ( UNEP ) and Global Environment Facility ( GEF ) are NOT to improve global malaria policies, but to GAIN CONTROL AND POWER OVER THE USE OF INSECTICIDES.

There could be multiple motivations for seeking greater control over insecticides, and one can and should be ever mindful of the fact that governmental and inter-governmental agencies CONTINUALLY SEEK TO REMAIN RELEVANT and to EXPAND THEIR PROGRAMS, POWER, and BUDGETS.

Every day, almost 16,000 children DIE from hunger-related causes — almost 6 MILLION CHILDREN DIE ANNUALLY due to hunger.

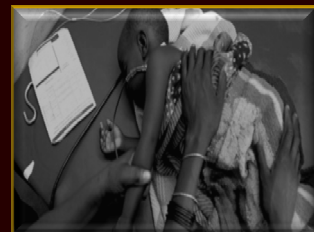
The latest statistics on the world epidemic of AIDS and HIV indicate that 39½ million people are living with it.

AIDS deaths for 2006 were 2.9 million, despite recent improvements to access to anti-retroviral treatment.

Equally serious is the fact that a world-wide shortage of fresh drinking water affects forty per cent of the planet's population.

Each year, 11 MILLION PEOPLE DIE of diseases related to water that is not clean enough for consumption.

Finally, some observers believe that Malaria acutely afflicts MORE THAN 515 MILLION PEOPLE PER YEAR.







# Background Information from an Independent Perspective

It had been known since 1914 that Malaria could be controlled by fluctuating water levels.

Nonetheless, DDT contributed to the final eradication of Malaria in the developed world.

In 1955, the World Health Organization ( WHO ) began a program to eradicate Malaria throughout the ENTIRE world.

The program RELIED GREATLY upon the application of DDT to control mosquitoes, with a practice called DDT Residual House Spraying.

As a result of this program, by 1967, Malaria was eradicated from all developed countries where Malaria was endemic.

Large areas of tropical Asia and Latin America were freed from the risk of infection.

In Sub-Saharan Africa, the campaign was only launched in three countries since it was not considered feasible in the others.

Swaziland and Mozambique are examples of countries that have very successfully REDUCED Malaria infestations with DDT.

Throughout the years, spectacular DECREASES in Malaria infections and deaths were seen after implementing an extensive anti-mosquito program with DDT.

Here are five examples. —

- India ■ 1945
  - Almost 1 million Malaria I deaths reported
- India ■ 1960
  - Only a few thousand cases were reported
- Venezuela ■ 1943
  - 817,000 Malaria I deaths reported
- Venezuela ■ 1958
  - Only 800 cases were reported

- Sri Lanka ( Ceylon ) ■ 1946
  - 28 million cases of Malaria
- Sri Lanka ■ 1961
  - Only 110 cases were reported
- Sri Lanka ■ 1969
  - The DDT program was halted, and Malaria rebounded with 2½ million cases
