As the Bed-Bug epidemic continues to spread through New York City and elsewhere, the United States Environmental Protection Agency ( US EPA ) is now planning to commence research aimed at developing pesticide alternatives, especially genetic-based solutions, rather than allow DDT to be used.

PBS NewsHour reported on February 7<sup>th</sup>, 2011, that chemically-based anti-Bed-Bug methods, particularly DDT, are « noxious





but effective », and highlighted the growing resistance of Bed-Bugs to more commonly employed pesticides.
