Cancer-Lunatics Coerce Government Officials Regarding Prohibition on Pesticide Use, Including Golf Courses

Cancer-Lunatics were able to successfully COERCE Government Officials in Prince Edward Island (P.E.I.) through relentless pressure.

In December 2009, the Government of the Province of Prince Edward Island announced its intention to « *implement changes to how lawn-care pesticides will be managed in the province* ».

Moreover, on December 2nd, 2009, a Government Official in the Province of Prince Edward Island issued the following WARNING to the Golf Industry —

<< *We're allowing (2,4-D) on golf courses because it's a major industry for P.E.I., and we're working towards getting off it.*

What we're basically saying is you [THE GOLF INDUSTRY] better find a way to get off it over the next couple of years. >>

SUBVERSIVE, CONTEMPTIBLE AND RADICAL ENVIRONMENTAL TERRORIST ORGANIZATION

LUNATIC-CANCER-TERRORISTS IGNORE THE REAL EXPERTS

Canadian-Cancer-Society is UNABLE TO BE HONEST about the fact that pest control products are SCIENTIFICALLY-SAFE since IMAGINARY DANGERS about them continue to attract HUGE SUMS OF PROFIT in the form of donations.

Canadian-Cancer-Society has NEVER STOPPED giving the FALSE and FRAUDULENT impression that the public has been exposed to cancer-causing agents whenever a pest control product was being used in the Urban Landscape.

As « *proof* », it has alleged that cancer problems are INCREASING, a « *fact* » that has been CONTRADICTED once again by AMERICAN CANCER SOCIETY in 2010.

In 2010, AMERICAN CANCER SOCIETY reported that cancer incidence rates and deaths CONTINUE TO DECLINE.

The incidence of cancer ... • decreased by 1.3 per cent per year from 2000 to 2006 in men • decreased by 0.5 per cent per year from 1998 to 2006 in women.

Cancer death rates ... • dropped 21 per cent since 1991 among men • dropped 12 per cent since 1992 among women.

In fact, the Pesticide Risk Assessment is VERY LOW for HEALTH-CANADA-APPROVED and FEDERALLY-LEGAL pest control products — 1-IN-1-MILLION-RISK-OF-CANCER.

1-IN-1-MILLION = $0.000001 = 1.0 \times 10^{-6}$, often referred to as 10^{-6} cancer risk.

This means that assuming daily exposure over a 70 year life-time that an individual would have a 1-IN-1-MILLION-RISK-OF-CANCER above normal probability.

SUBVERSIVE, CONTEMPTIBLE AND RADICAL ENVIRONMENTAL TERRORIST ORGANIZATION

SUBVERSIVE-CANCER-TERRORISTS NEVER STOPS

CANCER-TERRORIST-CONSPIRACIES have led to NEEDLESS and SENSELESS PROHIBITION of pest control products.

Because of CANCER-TERRORIST-CONSPIRACIES, DAMAGES to the Professional Lawn Care Industry have been EXTENSIVE because there are NO valid economical alternatives to replace the prohibited products.

Consequently, Professional Lawn Care Companies have been UNABLE to provide adequate weed and insect control, and have been UNABLE to keep their customers satisfied.

In 2010, EXTENSIVE DAMAGES in the Province of Ontario alone reached 500,000,000 DOLLARS, with up to almost 800 BUSINESS FAILURES and BANKRUPTCIES.

40 to 70 per cent of Professional Lawn Care customers have been ANNIHILATED.

Because of CANCER-TERRORIST-CONSPIRACIES, Professional Lawn Care businesses have been forced to TERMINATE many or most of their employees.

Up to 12,500 have become UNEMPLOYED.

Canadian-Cancer-Society continues to MISAPPROPRIATE the ENVIRO-PROFIT that it collects for cancer research by SQUANDERING HUNDREDS OF THOUSANDS OF DOLLARS on SUBVERSIVE-CANCER-TERRORISM and ANTI-PESTICIDE CONSPIRACIES.

Cancer-Lunatics purport having UNDISCLOSED, NON-EXISTENT and UNVERIFIABLE SECRET EVIDENCE about the safety of pest control products that are, in fact, HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, and SCIENTIFICALLY-SAFE.

Canadian-Cancer-Society has also MISAPPROPRIATED its resources to further support FOREIGN PROHIBITION-TERRORISTS.

Canada Revenue Agency Informant Leads Program

The Canada Revenue Agency (CRA) takes abuse of Canada's tax laws very seriously.

When an individual or business does not fully comply with tax legislation, an unfair burden is placed on law-abiding taxpayers and businesses and the integrity of Canada's tax base is jeopardized.

The mandate of the Informant Leads Program is to co-ordinate all leads that the CRA receives from informants, to determine if there is an element of non-compliance with tax legislation, and to ensure that appropriate enforcement action is taken.

The program is regionalized into five offices across the country.

To report suspected tax evasion, contact the office in your region.

An informant's identity will not be disclosed or you may provide information anonymously.
