More than 105,000 tickets were sold for the Cancer-Lottery, which supports
the Alberta Cancer Foundation and the Canadian Cancer Society in Alberta

Baker worked on community campaigns and events, including the CASH AND CARS LOTTERY, during his stint as Director of Revenue Development for Canadian Cancer Society.

The lottery, which is governed by Alberta Gaming and Liquor Commission rules, does not allow board members or senior staff to buy tickets, said Canadian Cancer Society spokes-person Tiffany Kraus.

Since Baker already had stepped down from his role at Canadian Cancer Society, he was free to claim the prize, Kraus said.

According to Cancer-Lunatic Tiffany Kraus —

<< *It's really quite the COINCIDENCE. We were quite SHOCKED when we saw that name came out.* >>

Professional Lawn Care Industry

It is DIFFICULT TO BELIEVE ANYONE who is affiliated with Canadian Cancer Society, an organization that has MERCILESSLY TERRORIZED, BASELESSLY SMEARED, FALSELY ACCUSED, GROTESQUELY PUNISHED, INNOCENTLY CONVICTED, SHAMELESSLY PERSECUTED, and WRONGFULLY DEPRIVED those people working in the Professional Lawn Care Industry.

CONSPIRACIES by Canadian Cancer Society have led to NEEDLESS and SENSELESS PROHIBITION of pest control products used in the Urban Landscape.

Because of Cancer-Lunatic CONSPIRACIES, DAMAGES to the Professional Lawn Care Industry have been EXTENSIVE because there were NO valid economical alternatives to replace the prohibited products.

Consequently, Professional Lawn Care Companies were UNABLE to provide adequate weed and insect control, and were UNABLE to keep their customers satisfied.

Because of Cancer-Lunatic CONSPIRACIES, EXTENSIVE DAMAGES in the Province of Ontario alone reached 500,000,000 DOLLARS, with up to almost 800 BUSINESS FAILURES and BANKRUPTCIES, and UP TO 12,500 UNEMPLOYED.

Pay-Offs

It is DIFFICULT TO BELIEVE ANYONE who is affiliated with Canadian Cancer Society, an organization that provides its employees with SAFE, SECURE, WELL-PAYING JOBS, with AWARDS, INCENTIVES, BONUSES, and BOUNTIES ... AT THE EXPENSE OF the jobs they ultimately DESTROYED in the Professional Lawn Care Industry.

It is DIFFICULT TO BELIEVE ANYONE who is affiliated with an organization that actually doles out AWARDS for « *BEST Environmental Terrorists of the Year* » by CONSPIRING to PROHIBIT pest control products that are otherwise FEDERALLY-LEGAL and SCIENTIFICALLY-SAFE.

In addition to these AWARDS, Cancer-Lunatics are paid an INCENTIVE OF 2,000 DOLLARS by Canadian Cancer Society the ORGANIZATION of EVERY Anti-Pesticide Forum.

Cancer-Lunatics are also paid a BONUS OF 1,000 DOLLARS by Canadian Cancer Society FOR EVERY PRESENTATION MADE TO EACH MUNICIPAL TOWN COUNCIL.

Additionally, for making presentations to Government Officials, Cancer-Lunatics are given a BOUNTY OF 5,000 DOLLARS by Canadian Cancer Society upon SUCCESSFUL PROHIBITION LEGISLATION.

And overall, Cancer-Lunatics are PAID a BASE SALARY of OVER 40,000 DOLLARS PER YEAR, plus expenses, by Canadian Cancer Society, to COERCE, INTIMIDATE, and ALARM GOVERNMENT OFFICIALS.
