

Old Growth Money

EIGHTY-ONE-MILLION-DOLLARS is what the David Suzuki Foundation has spent over the past decade, according to its Canadian tax returns.

No wonder the foundation is so influential.

The question is, **WHERE DID ALL THAT MONEY COME FROM ?**

Money doesn't grow on trees.

It turns out, a lot of it comes from corporations, especially the millions from **AMERICAN FOUNDATIONS** that fuel the environmental movement.

Call it Old Growth Money.

Over the past ten years, about half of the David Suzuki Foundation's **81 MILLION DOLLARS** was from tax-receipted **DONATIONS**.

EIGHTY-ONE-MILLION-DOLLARS was spent by David Suzuki Foundation over the past decade

Claudine and Stephen Bronfman Foundation

A total of 8.7 MILLION DOLLARS was from Canadian charitable foundations, including 6 MILLION DOLLARS from the CLAUDINE AND STEPHEN BRONFMAN FOUNDATION.

That's about 8 PER CENT OF THE TOTAL REVENUE of David Suzuki Foundation over the past decade.

In the foundation's earlier years, BRONFMAN MONEY WAS EVEN MORE IMPORTANT.

Between 2000 and 2002, 13 per cent of the David Suzuki Foundation's revenue was Bronfman money.

In 2002, for example, the Bronfman Foundation granted 925,000 DOLLARS to the David Suzuki Foundation.

Nearly 30 per cent of the Bronfman's charitable giving has gone to the David Suzuki Foundation over the past decade, according to my calculations.

In 2010, the amount that the Bronfmans granted to the David Suzuki Foundation was 427,560 DOLLARS.

U.S. Tides Foundation

The big mystery is ...

... where did the David Suzuki Foundation get 25 MILLION DOLLARS that has been reported to Revenue Canada over the years as « *other gifts* » and « *other revenue* ».

My guess is that quite a chunk of that money came indirectly from AMERICAN FOUNDATIONS, through TIDES CANADA or TIDES USA.

Indeed, I've traced 10 MILLION DOLLARS that the David Suzuki Foundation has been paid by American foundations, according to U.S. tax returns.

Millions more may have gone through Tides USA and Tides Canada which « *canadianizes* » U.S. money.

William and Flora Hewlett Foundation
& David and Lucile Packard Foundation

Over the past decade, the William and Flora Hewlett Foundation and the David and Lucile Packard Foundation have granted 91 MILLION DOLLARS to environmental organizations in Canada, particularly for work on the strategic, north coast of British Columbia — Canada's gateway to Asia.

The Hewlett Foundation and the Packard Foundation were created by the founders of the tech giant, Hewlett-Packard.

Through Tides Canada, Tides USA, and the Pew Charitable Trusts, the Hewlett Foundation and the Packard Foundation have granted at least 55 MILLION DOLLARS to environmental organizations in British Columbia.

Gordon and Betty Moore Foundation

The Gordon and Betty Moore Foundation — created from the wealth of the founder of INTEL — has granted a further 26 MILLION DOLLARS to Tides Canada.

That's a total of 81 MILLION DOLLARS that has gone — indirectly — from billion-dollar American charitable foundations to British Columbia environmental organizations.

My guess is that some of that money went to the David Suzuki Foundation.

Especially considering that in at least one instance, the Vancouver address for Tides USA, as reported to the U.S. Internal Revenue Service by the Hewlett Foundation, was EXACTLY THE SAME AS THE ADDRESS of the David Suzuki Foundation —

2211 WEST FOURTH AVENUE, SUITE 219.

David Suzuki Foundation was co-founded in 1991 by Non-Expert Enviro-Lunatic Fund-Raiser, Alliance-Puppet-Master, Psychedelic Hippie, and Entertainer DAVID TAKAYOSHI SUZUKI.

David Suzuki Foundation operates across Canada and the United States, but its business headquarters, with over FIFTY EMPLOYEES, is located in Vancouver, British Columbia.

It has branch offices in Ottawa and Montreal.

Suzuki is a MILLIONAIRE FOR-PROFIT LOBBYING ORGANIZATION that operates with a budget of over SIX MILLION DOLLARS PER YEAR.

Suzuki is arguably the largest MULTI-MILLION DOLLAR MONEY-MAKING MACHINE of its kind.

David Suzuki Foundation uses POLITICIZED SCIENCE to COERCE, INTIMIDATE, and ALARM the public with NONSENSICAL solutions to conserve nature and help achieve sustainability within a generation.

David Suzuki Foundation has developed expertise in the distribution of ideas related to POLITICIZED SCIENCE and public policy concerning the environment.

David Suzuki Foundation operates as a so-called non-profit INDEPENDENT charity that DOES NOT accept government grants.

Suzuki has claimed to be funded by more than forty-thousand donors from around the world (including eighteen-thousand in Ontario), as well as over fifty corporations and foundations.

Suzuki and GOLF

David Suzuki Is Being UNCHARITABLE

The rules at the CANADA REVENUE AGENCY seem clear.

A registered charity « *cannot be involved in partisan political activities* ».

Unless, apparently, you are David Suzuki and the David Suzuki Foundation.

Here is how CANADA REVENUE AGENCY defines what is prohibited to David Suzuki Foundation —

« *A political activity is considered partisan if it involves direct or indirect support of, or opposition to, a political party or candidate for public office.*

Charities can promote the policies of political parties and candidates they agree with, but must not directly or indirectly support the political party or candidate for public office. »

On July 21st, 2011, the Toronto Star reported David Suzuki, in an interview, urged Ontarians to re-elect Liberal Premier Dalton McGuinty on October 6th, 2011 —

« *I'm offering an endorsement of what Mr. McGuinty has done, absolutely.* »
