Ontario General Election

The 40th Ontario General Election will be held on October 6th, 2011.

It will elect Members of the Legislative Assembly (MPPs) of Ontario.

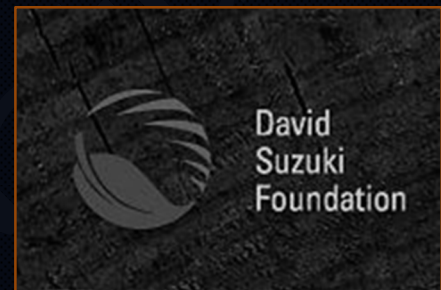

But Suzuki and the foundation are « *one-in-the-same* », insisted John Laforet, President of Wind Concerns Ontario.

According to Laforet —

<< David Suzuki is the primary spokesperson for the foundation.

This is a charitable foundation.

They've RECEIVED MONEY FROM THE GOVERNMENT OF ONTARIO, and now they're turning and supporting Ontario's Premier [McGuinty]. >>

Laforet went on to say that Canada Revenue Agency should look « *seriously* » into Suzuki's political endorsements and interference.

Gregory Thomas of Canadian Taxpayers Federation agreed.

Given Suzuki's close ties to the foundation, he said, there could be a CONFLICT-OF-INTEREST with his endorsement of McGuinty.

McGuinty Pay-Offs to Suzuki

In 2010, David Suzuki Foundation RECEIVED BETWEEN 100,000 AND 250,000 DOLLARS from The Ontario Trillium Foundation.

Trillium is an agency of the Government of Ontario, and is the LARGEST FUNDER of the environmental not-for-profit sector in Ontario.

This agency has been used to provide PAY-OFFS to those who support the ENVIRO-LUNATIC MASTER-BASTERD PREMIER of the Province of Ontario.

Trillium operates as a FINANCIAL SHIELD to provide direct funding to Environmental-Terrorist-Organizations.

Trillium is also used to FINANCE ANTI-PESTICIDE ORGANIZATIONS that CONSPIRED to PROHIBIT pest control products in the Urban Landscape.

Observers estimate that The Ontario Trillium Foundation SPENT OVER 2,000,000 DOLLARS ON THE CONSPIRACY TO PROHIBIT PEST CONTROL PRODUCTS.

On April 22nd, 2009, the Government of Ontario ARBITRARILY PROHIBITED pest control products that are, in fact, HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, and SCIENTIFICALLY-SAFE.

This NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION led to the DESTRUCTION OF THE MODERN PROFESSIONAL LAWN CARE INDUSTRY.

In fact, PROHIBITION WAS UNNECESSARY since pest control products are carefully regulated by Health Canada to protect health or environment.

Moreover, government money acquired from law-abiding tax-payers and businesses in the Professional Lawn Care Industry was DIVERTED through Trillium to ANTI-PESTICIDE ORGANIZATIONS.

The Professional Lawn Care Industry's TAX-DOLLARS were used to DESTROY its companies.

Between 2001 and 2006, Trillium funded over 600 environmental projects across Ontario worth more than 47 million dollars.

In 2007, annual funding was boosted to 105 million from 100 million dollars.

Additionally, Trillium FINANCED the SUBVERSIVE CONSPIRACY TO PROHIBIT pest control products.

While the Government of Ontario was seemingly listening to all stakeholders regarding the fate of « *cosmetic pesticides* », it was ostensibly CONSPIRING towards the demise of the Professional Lawn Care Industry by PROVIDING FREE MONEY TO SUBVERSIVE TAX-EXEMPT ANTI-PESTICIDE ORGANIZATIONS.

In 2007–2008 alone, almost 500,000 DOLLARS was provided by The Ontario Trillium Foundation to ANTI-PESTICIDE ORGANIZATIONS.

During the period 1999–2009, over 1,5000,000 DOLLARS was provided to ANTI-PESTICIDE ORGANIZATIONS.

Thanks to Trillium funding, SUBVERSIVE LOBBYING AND ADVERTISING orchestrated by ANTI-PESTICIDE ORGANIZATIONS guaranteed the passage of the Ontario Cosmetic Pesticides Ban Act.

Trillium claims that the money was never given for this purpose.

But hey !

Trillium DID at least PAY FOR THE INFRA-STRUCTURES OF ANTI-PESTICIDE ORGANIZATIONS.

Evidently, ANTI-PESTICIDE ORGANIZATIONS used Trillium money, directly or indirectly, to CONSPIRE TO PROHIBIT PEST CONTROL PRODUCTS.

Clearly, it is a CONFLICT-OF-INTEREST to use government grants for the purpose of CONSPIRING TO PROHIBIT pest control products that are, otherwise, HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, and SCIENTIFICALLY-SAFE.

Coincidentally, VAST SUMS OF MONEY were provided by The Ontario Trillium Foundation during the period of time covering the public debates on PROHIBITION for the City of Toronto and the Province of Ontario (2001 – 2008).

In 2004, the Court of Appeal for Ontario unfortunately concluded that City of Toronto DID have the authority to PROHIBIT pest control products.

In 2008, the Cosmetic Pesticides Ban Act was unfortunately legislated by the Government of Ontario.

In BOTH CASES, the SUCCESSFUL PASSAGE OF THESE PROHIBITIONS were clearly INFLUENCED by Trillium, as well as by other sources of financing.

In 1999 and 2001, Trillium even financed ANTI-PESTICIDE ORGANIZATIONS to provide the means and/or the infra-structure to legally challenge the Professional Lawn Care Industry in the PROHIBITION IN TOWN OF HUDSON, QUEBEC.

On June 28th, 2001, The Supreme Court of Canada unfortunately UPHELD THE ACTS OF SUBVERSION by the Town of Hudson which prohibited the use of pest control products for the Professional Lawn Care Industry and Do-It-Yourself Homeowners.

Essentially, The Ontario Trillium Foundation SQUANDERED MILLIONS OF DOLLARS ON THE SUBVERSIVE ANTI-PESTICIDE CONSPIRACY OF PROHIBITION.

OVER 2,000,000 DOLLARS !

In 2009, The Ontario Trillium Foundation responded to portions of this report —

<< The Ontario Trillium Foundation does not fund advocacy efforts that do not meet the guidelines for not-for-profit organizations under the Canadian Revenue Agency rules. This would include advocacy efforts which are politically motivated or supportive of a specific political party or viewpoint. [...] Therefore, to be clear, the OTF did not fund activities by the organizations listed below as you have implied in your article. >>

Nonetheless, Trillium was used to FINANCE ANTI-PESTICIDE ORGANIZATIONS that CONSPIRED TO PROHIBIT PEST CONTROL PRODUCTS in the Urban Landscape.

The Ontario Trillium Foundation SQUANDERED AND MISAPPROPRIATED MILLIONS OF DOLLARS towards the SUBVERSIVE ANTI-PESTICIDE CONSPIRACY OF PROHIBITION.

Overall, observers estimate that this PROHIBITION CONSPIRACY cost Trillium, and tax-payers, OVER 2,000,000 DOLLARS.

Canada Revenue Agency

According to Canada Revenue Agency, registered charities « *cannot be involved in partisan political activities* » including « *attempts to sway public opinion on social issues* ».

The breaking of such rules could mean reprimands such as mandatory education around Canada Revenue Agency regulations, fines, or a REVOCATION OF CHARITY STATUS.

The Canada Revenue Agency takes abuse of Canada's tax laws very seriously.

When an individual or business does not fully comply with tax legislation, an unfair burden is placed on law-abiding tax-payers and businesses, and the integrity of Canada's tax base is jeopardized.

The mandate of the Informant Leads Program is to co-ordinate all leads that Canada Revenue Agency receives from informants, to determine if there is an element of non-compliance with tax legislation, and to ensure that appropriate enforcement action is taken.

The program is regionalized into five offices across the country.

To report suspected TAX-EVASION, contact the office in your region.

An informant's identity will not be disclosed, or you may provide information anonymously.

Fields of study — Horticulture/Agriculture, Mathematics, Physics

Alma mater — McGill University • University of Guelph • the first person ever to obtain university degrees and contribute to both the professional lawn care and golf maintenance industries

Expertise in — environmental issues and environmental terrorism • turf and ornamental maintenance and troubleshooting • history of the industry • sales and distribution of seeds, chemicals, fertilizers, and equipment • fertilizer manufacturing

Notable activities — worked in virtually all aspects of the green space industry, including golf, professional lawn care, distribution, environmental compliance, government negotiations, public affairs, and workplace safety • supervisor, consultant, and, programmer for the successful execution of hundreds of thousands of management operations in the golf and urban landscape, as well as millions of pest control applications • advisor, instructor, and trainer for thousands of turf and ornamental managers and technicians • pesticide certification instructor for thousands of industry workers • founder of the modern professional lawn care industry • prolific writer for industry publications and e-newsletters • first to confirm the invasion of European Chafer insect in both the Montreal region and the Vancouver/Fraser Valley region • with Dr. Peter Dernoeden, confirmed the presence of Take-All Patch as a disease of turf in Eastern Canada • with Dr. David Shetlar, confirmed the presence of Kentucky Bluegrass Scale as an insect pest in South-Western Ontario, and later, in the Montreal and Vancouver regions

Special contributions — creator of the exception status that has allowed the golf industry to avoid being subjected to the prohibition of pest control products • creator of the signs that are now used for posting after application • co-founder of annual winter convention for Quebec golf course superintendents • the major influence in the decision by Canadian Cancer Society to stop selling for profit pesticide treated daffodils • the only true reliable witness who intervened in the development of prohibition in the town of Hudson, Quebec • retired founder of FORCE OF NATURE and A LOOK AT e-newsletters

Notable award — man of the year for contributions leading to the successful founding of Quebec professional lawn care industry, which served as a beach-head against activism in the 1980s and 1990s

Legacy — Mr. Gathercole and his colleagues ... designed and implemented strategies that reined environmental activists to provide peace and prosperity for the entire modern green space industry across Canada • orchestrated legal action against activists in the town of Hudson, Quebec • launched the largest early professional lawn care business in Canada • quadrupled the business revenues of one of the largest suppliers in Canada

Mr. Gathercole is now retired, although his name continues to appear as founder of FORCE OF NATURE and A LOOK AT e-newsletters.
