Not only does LandsCAPE Ontario appear to support Environmental Terror, LandsCAPE Ontario **DOES NOT** keep its word !

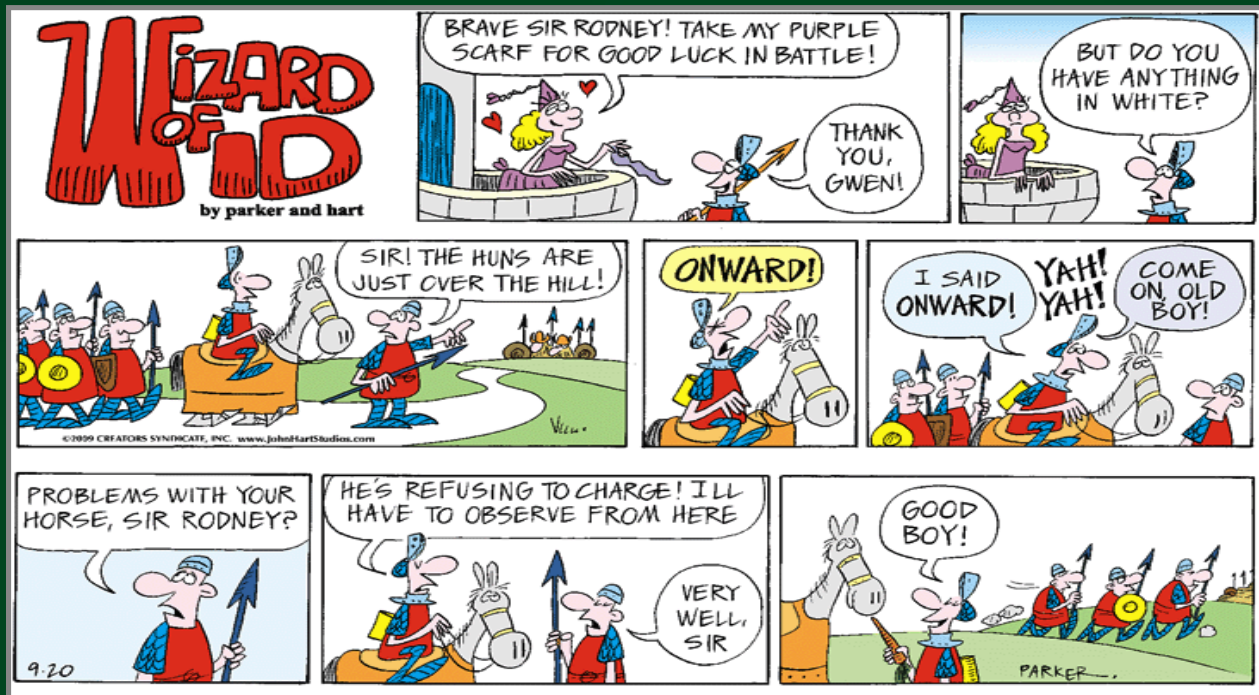

HE HOLDS A DEGREE IN HORTICULTURE FROM THE UNIVERSITY OF GUELPH, AND ANOTHER PURE AND APPLIED SCIENCE DEGREE FROM MCGILL UNIVERSITY. HE HAS WORKED IN VIRTUALLY ALL ASPECTS OF THE GREEN SPACE INDUSTRY, INCLUDING GOLF AND PROFESSIONAL LAWN CARE, AND HAS SERVED IN PUBLIC AFFAIRS, WORK-PLACE SAFETY, AND ENVIRONMENTAL COMPLIANCE. MR. GATHERCOLE HAS SUPERVISED, CONSULTED, PROGRAMMED, AND/OR OVERSEEN THE EXECUTION OF HUNDREDS OF THOUSANDS OF PEST CONTROL APPLICATIONS IN THE URBAN LANDSCAPE.
