In Ontario, by late 2009, **over 5000 PEOPLE HAVE BEEN UNEMPLOYED** (full time and summer students).

In Ontario, by autumn 2009, Professional Lawn Care companies have **LOST FORTY TO SEVENTY PER CENT OF THEIR CUSTOMERS** since the senseless Prohibition-Tyranny began in early 2009 !

Unquestionably, LandsCAPE Ontario appears to prefer fostering the **ADVANCEMENT** of its adored and treacherous **ORGANO-MANIAC** lawn care members, as well as its cherished but self-serving **FRANCHISE** members. LandsCAPE Ontario is sealing the fate of the industry in Ontario.

LandsCAPE Ontario has **ABANDONED** the **MAJORITY** of the Professional Lawn Care Industry.

LANDSCAPE ONTARIO RECOMMENDS BOGUS PEST CONTROL ALTERNATIVES.

Moreover, LandsCAPE Ontario appears to be **DECEPTIVELY SUPPORTING** so-called Lower-Risk **ALTERNATIVE PEST CONTROLS** for turf when **NO** valid, effective, legal, and safer alternatives exist ! (Products like beet juice and neem oil are **ILLEGAL** alternatives !)

LandsCAPE Ontario now sounds and acts just like the rest of the Environmental-Terror-Movement.

A **MAJORITY** of these **BOGUS** Green Alternatives have negatives ranging from almost **TOTAL INEFFECTIVENESS** except under very specific circumstances, to a question about their **TOXICITY**.

Some industry members have been preparing for this by focusing on alternative weed control products such as Sarritor. Others have changed their business models based on cultural practices with hand weeding and increased organic fertilizers as part of the mix. There is a great deal of concern about future viability. 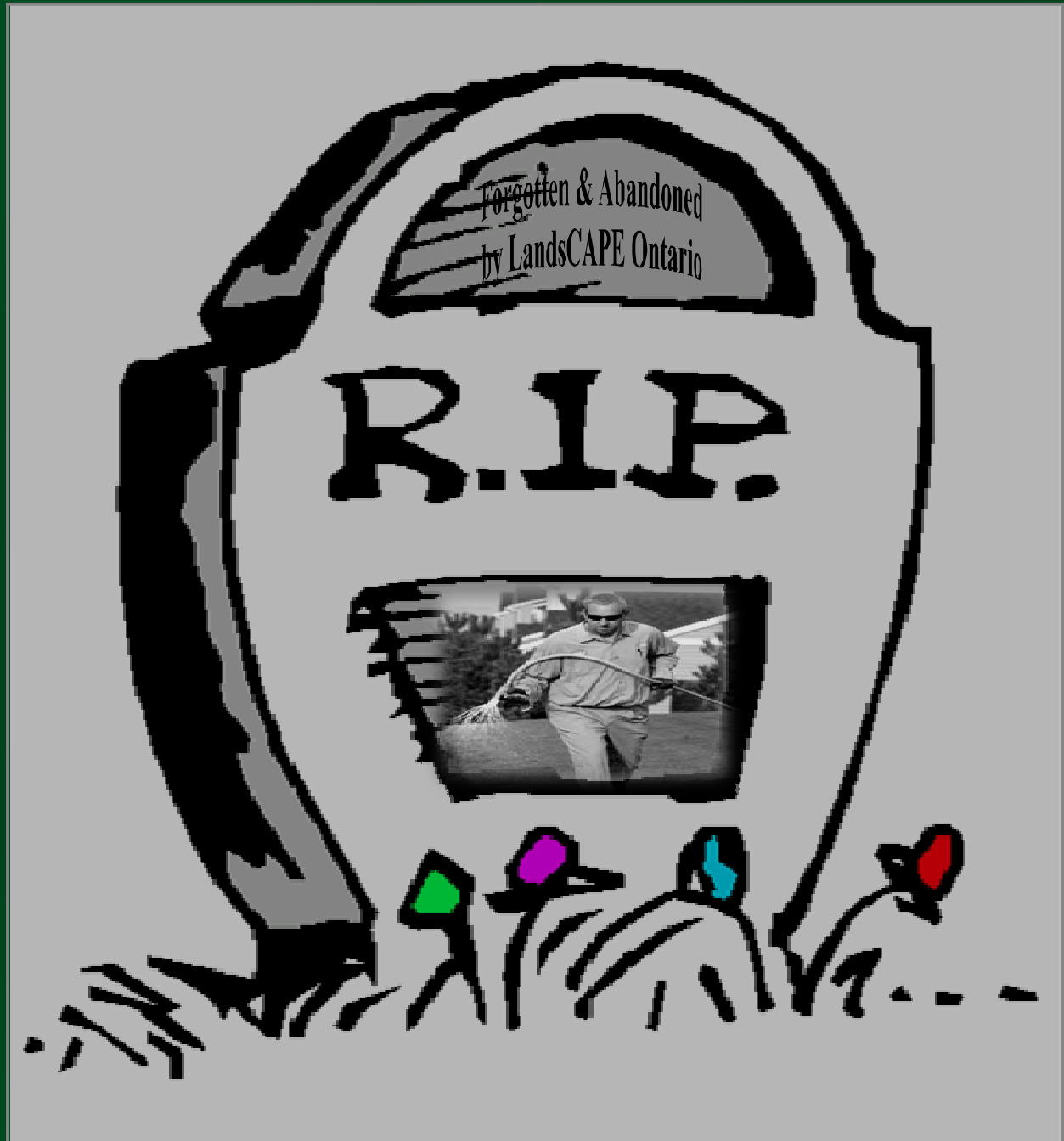

WILLIAM H. GATHERCOLE IS A PRINCIPAL FOUNDER OF THE MODERN PROFESSIONAL LAWN CARE INDUSTRY IN BOTH ONTARIO AND QUEBEC. HE HOLDS A DEGREE IN HORTICULTURE FROM THE UNIVERSITY OF GUELPH, AND ANOTHER PURE AND APPLIED SCIENCE DEGREE FROM MCGILL UNIVERSITY. HE HAS WORKED IN VIRTUALLY ALL ASPECTS OF THE GREEN SPACE INDUSTRY, INCLUDING GOLF AND PROFESSIONAL LAWN CARE, AND HAS SERVED IN PUBLIC AFFAIRS, WORKPLACE SAFETY, AND ENVIRONMENTAL COMPLIANCE. MR. GATHERCOLE HAS SUPERVISED, CONSULTED, PROGRAMMED, AND/OR OVERSEEN THE EXECUTION OF HUNDREDS OF THOUSANDS OF PEST CONTROL APPLICATIONS IN THE URBAN LANDSCAPE. HE HAS TRAINED, INSTRUCTED, AND CONSULTED WITH THOUSANDS OF TURF MANAGERS AND TECHNICIANS. MR. GATHERCOLE HAS ALSO BEEN AN AGRICULTURAL AGRONOMIST. FOR MANY YEARS, MR. GATHERCOLE WAS A CONTRIBUTING COLUMNIST FOR TURF & RECREATION MAGAZINE, CANADA'S TURF AND GROUNDS MAINTENANCE AUTHORITY.

MR. GATHERCOLE HAS FOLLOWED THE EVOLUTION OF ENVIRONMENTAL TERRORISM FOR OVER A QUARTER-CENTURY.
