Early on, the parent association also refused to fight against Environmental-Terror, and actually tried to seize the financial war chest that was being accumulated for the challenge.

There is a lesson to be learned here — « *pot and flower* » associations have **NOT** been decisive enough in defending issues pertaining to pest control products. Their interests seem to traditionally remain elsewhere. Just like LandsCAPE Ontario !

HE HOLDS A DEGREE IN HORTICULTURE FROM THE UNIVERSITY OF GUELPH, AND ANOTHER PURE AND APPLIED SCIENCE DEGREE FROM MCGILL UNIVERSITY. HE HAS WORKED IN VIRTUALLY ALL ASPECTS OF THE GREEN SPACE INDUSTRY, INCLUDING GOLF AND PROFESSIONAL LAWN CARE, AND HAS SERVED IN PUBLIC AFFAIRS, WORK-PLACE SAFETY, AND ENVIRONMENTAL COMPLIANCE. MR.
