The Golf Industry enjoys the benefits from an Anti-Pesticide PROHIBITION EXCEPTION STATUS despite the fact that it uses the VERY SAME INGREDIENTS used in Professional Lawn Care maintenance.

If it is safe to walk and play on a pesticide—treated golf course putting green, it is also safe to walk on a pesticide—treated lawn.

Moreover, in those jurisdictions that REFUSE TO RESCIND or IMPOSE PRO-HIBITION, the Professional Lawn Care Industry will no doubt DEMAND THAT ALL EXCEPTIONS TO PROHIBITION BE RESCINDED — including GOLF.

The Golf Industry must plan for the INEVITABLE and TOTAL REVOCATION of its EXCEPTION STATUS in most jurisdictions across Canada, in two to four years.

The Beginning of the End for Golf

The Golf Industry Anti-Pesticide PROHIBITION EXCEPTION STATUS will be first rescinded in the Provinces of Prince Edward Island and British Columbia.

Even in the Province of Prince Edward Island (PEI), the Golf Industry was provided with an Anti-Pesticide PROHIBITION EXCEPTION STATUS, and its use of pest control products WAS NOT PROHIBITED.
