Keep in mind all pesticides sold in Canada must go through the same regulatory process.

It is odd how Anti-Pesticide Activists trust the PMRA on the safety of the alternative products but not on the conventional ones, as they all must go through the same scru-

Unless, of course, they are referring to alternatives that do not have a government registration number.

But I'm sure, with their so-called expertise on the issue, Anti-Pesticide Activists are aware that would be illegal.

BOGUS Alternatives

It is IMPOSSIBLE for home-owners or profesproperties beautiful by using so-called Green Alternative Pesticides.

There are NO viable, eflow-risk alternatives to replace conventional pest control products.

Green Alternative Pesticides (a.k.a. Organic or Natural Pesticides) are FAILURES — they DO NOT INNOVATIVE prod-

- There is really A LACK OF EVIDENCE linking pest control product exposure to human risks of cancer.
- There is NO EVIDENCE of ANY causal link between the use of pest control products and cancer.
- Pest control products are LESS TOXIC THAN TABLE SALT.
- EPIDEMIOLOGY STUDIES are really based only on CORRELATION and SUG-GESTED LINKS, and they CANNOT ESTABLISH CAUSALITY ON THEIR OWN.
- If Government Officials want to IMPOSE A PESTICIDE BAN FOR POLITICAL REASONS, that's fine. That's within their mandate. But if they do that, they should be honest enough to admit that they are actually doing that.


