Which HEALTH ORGANIZATIONS ?!?!

Canadian Cancer Society is NOT a health, science, or research organization.

Canadian Cancer Society is a mere FUND-RAISING ORGANIZATION.



How did Seely arrive at the conclusion that products used in Professional Lawn Care are somehow « *toxic* » ?!?!

Was her ASSESSMENT based upon her vast scientific knowledge of pest control products ?!?! [No !]

Did Seely ASSESS these products after spending time and money carefully studying their effects on health and environment ?!?! [No !]
