RESPONSE TO CHRISTINA BECK (CANADIAN CANCER SOCIETY)

Cataclysmic Cost Increase of Pesticide Bans

According to Non-Expert Anti-Pesticide Activist Christina Beck, the CATAclysmic COST INCREASE OF A PESTICIDE BAN in the District Municipality of Langley will range between 12,540 and 25,081 dollars.

Ridiculously ... Beck has the estimate worked out to within 1 dollar.

Beck's estimates are WRONG !

Beck even CONTRADICTS the ESTIMATES from her own organization.

On January 29th, 2009, Canadian Cancer Society CONSERVATIVELY ESTIMATED the CATAclysmic COST INCREASE OF A PESTICIDE BAN —

« The implementation cost of a pesticide-control by-law is 50 CENTS TO 1 DOLLAR PER PERSON PER YEAR, decreasing over time. »
