In fact, the government won't allow convenience stores to sell alcohol not to protect the young, but TO PROTECT ITS PROFIT MARGINS.

# Anti-Pesticide Terrorism **NEVER** Ends

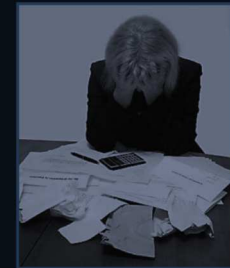

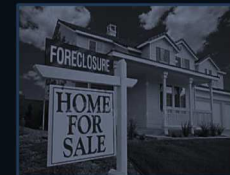
