Calgary (pronounced /'kælgri, 'kælgəri/) is the largest city in the Province of Alberta, Canada. The Calgary census metropolitan area (CMA) is the third most diverse in Canada in terms of visible minorities after Toronto and Vancouver when considering only CMAs with population greater than 200,000. It is located in the south of the province, in an area of foothills and high plains, approximately 80 km (50 mi) east of the front ranges of the Canadian Rockies. The city is located in the Parkland region of Alberta. Calgary is the third largest civic municipality, by population in Canada, and is also an emerging global city. According to the GaWC, Calgary is a "gamma negative world city."

In the Canada 2006 Census, the city had a population of 988,193 and the CMA had a population of 1,079,310. As of the 2009 civic census, Calgary's population was 1,065,455 and the CMA had a population of 1,182,446.

Greater Calgary is the fifth largest CMA in the country after Toronto, Montreal, Vancouver, and Ottawa. Located 300 km (200 mi) due south of Edmonton, statisticians define the narrow populated area between these cities as the "Calgary–Edmonton Corridor." CALGARY TO REDUCE PESTICIDE USAGE; MOVES NOT ENOUGH, CRITICS SAY

The city [OF CALGARY] is moving ahead with a bylaw to reduce the use of pesticides, with a final draft to be brought forward in DECEMBER [2009].

Critics and some aldermen [COUNCIL MEMBERS] say the city has further weakened its pesticide bylaw after council voted Monday not to move forward on targets for eliminating herbicide use.

" *We choked on that. We removed the target,* " said Alderman BRIAN PINCOTT, who already believed the bylaw did not go far enough. [CLEARLY AN ENVIRO-MANIAC-POLITICIAN !]

" I've worked long and hard towards making Calgary a safer place. I felt like we had that in our grasp."

Green groups who already felt the city was contemplating a weak bylaw were further disappointed. *" A bylaw that does not keep pesticides out of our water, air and our soil is a weak by-law,"* said **NATALIE ODD**, executive director of **Green Calgary**, which used to be called Clean Calgary.

But other aldermen [COUNCIL MEMBERS] who voted against the clause relating to targets said there were concerns about being able to enforce a ban, especially on private property.

" It's a ban by increments," Alderman GORD LOWE said.

And Alderman JOHN MAR said a complete ban would have *" unintended consequences."*

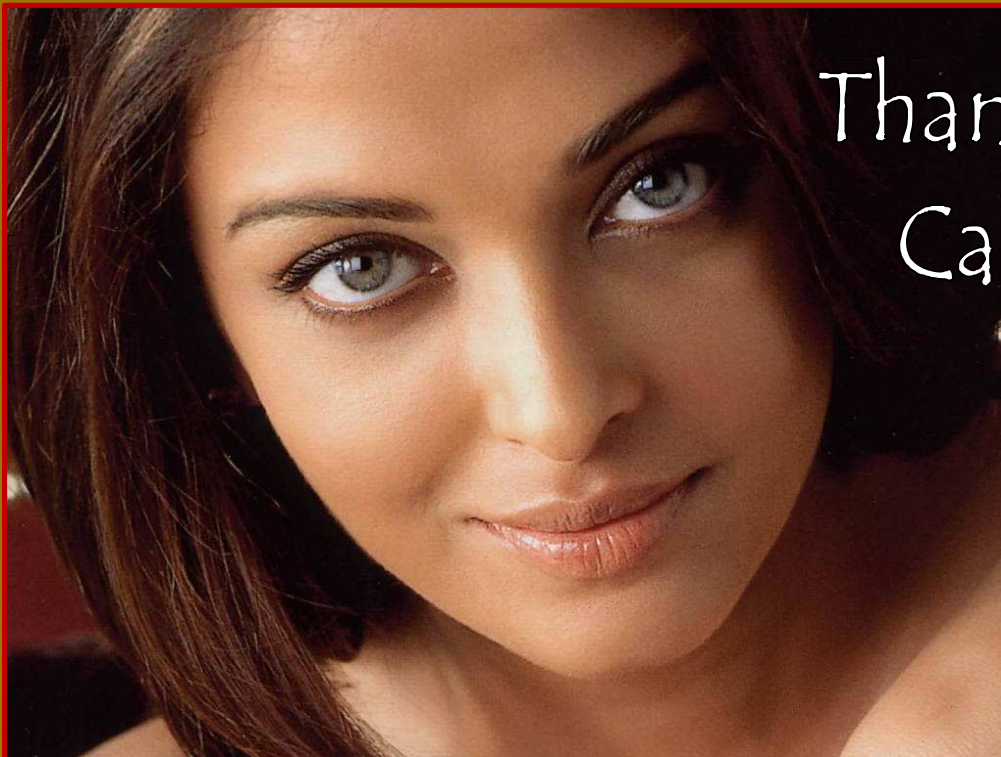

He said there are too many unanswered questions, including the effect on golf courses and how much control council can have over private property.

" Most important, how is this enforced ?" he said. " We're creating something unenforceable."

Overall, council gave the go-ahead in a 13-2 vote to develop a bylaw reducing herbicide use. Alderman LINDA FOX-MELLWAY and Alderman JOE CONNELLY were opposed.

It will come back to the utilities and environment committee — which held a lengthy hearing on the issue in OCTOBER — early next month [DECEMBER, 2009], when the public will again have an opportunity to comment.

It must then also return to council.

The principles that will now be part of the bylaw include banning products that are over-used, such as those that require dilution and any that are sprayed over a large area rather than applied to specific spots.

A system to notify neighbours that a pesticide has been used will also be developed.

And there will be increased standards for those licensed to apply the chemicals, such as lawn care companies.

" We struck the right balance, " Alderman DIANE COLLEY-URQUHART said. [DEFINITELY !]

" Some people did not feel we went far enough. Others think we went too far."

During the OCTOBER [2009] hearings, the committee heard that the province's decision to ban weed and feed products will help to reduce the amount of herbicide that ends up in the city's water.

It also heard from many people with varying opinions on the safety of herbicides people use on their lawns.

Calgary is the biggest city in Canada without comprehensive anti-herbicide rules. [SO WHAT ?]

PESTICIDE PLAN HITS RIGHT BALANCE

[CALGARY] CITY COUNCIL HAS FOUND SOME RARE MIDDLE GROUND THAT WILL REDUCE PESTICIDE USE WHILE STILL ALLOWING SPOT SPRAYING.

The bylaw still needs to be written, but administration now has clear direction. What's out is an outright ban. As proven in other municipalities, bans on the use of pesticides do not work because they are unenforceable, short of creating property police to patrol lawns.

The new rules call for tougher licensing standards for commercial lawn-care companies, the reduction or ban of herbicides that must be diluted, and those that are intended to be used over large areas.

The **Coalition for a Healthy Calgary** believes short of a ban, the bylaw is toothless. This position fails to acknowledge Alberta will become only the second province to ban the sale of combination fertilizer and herbicide products come **JANUARY 1, 2010**.

That renders municipal bans on usage unnecessary. As long as the products are available for purchase, no municipal ban will stop some people from using them on their lawns.

Banning the sale is what really works. Products that combine fertilizer with herbicide, are among the biggest culprits of the whole debate. Weed and feed products are often over-applied, with the excess chemical washing into the storm drainage system and polluting our waterways.

LAWN CARE COMPANIES AND OTHER COMMERCIAL USERS OF PESTICIDES POINT OUT THESE PRODUCTS, WHEN USED CORRECTLY, ARE NOT UNSAFE. BUT THEY ARE RARELY USED CORRECTLY BY INDIVIDUAL PROPERTY OWNERS.

ALL BYLAW DRAFT SAYS CITY WILL FINE INDIVIDUALS, NOT COMPANIES FOR HEAVY PESTICIDE USE

Calgary will limit the heavy spraying of pesticides by individuals but exempt professionally licensed applicators, according to a newly released draft bylaw that aldermen [COUNCIL MEMBERS] will consider WEDNESDAY. [DECEMBER 2ND, 2009]

It sets out **\$150 fines** for individuals who do not follow the new rules and **up to \$500** for licensed officials who do not keep proper records. But the city's bylaw division has already warned the bylaw will be tough to enforce and wouldn't even start a public-education campaign in earnest until a year after the rules take effect in JANUARY [2009].

"The only shock is that it's going to be even more minimal than we thought," said the **Canadian Cancer Society's** **EVIE RODWAY**.

"The impact is going to be very minimal, so Calgarians can't expect a big difference."

Calgary is the largest city Canadian without a comprehensive by-law governing pesticide use. Many municipalities have full ban on non-essential or "*cosmetic*" use of the yard chemicals, but **Calgary** is taking a softer approach.

Companies like **Green Drop** and **Weed Man** have said they follow best practises to avoid overuse of pesticides. Alderman **LINDA FOX-MELLWAY** said **IT'S NOT THE PROFESSIONALS THE BYLAW WANTS TO TARGET, BUT ORDINARY CITIZENS.**

"People do not know how to use this stuff," said **FOX-MELLWAY**, chairwoman of the committee that will hold another public hearing Wednesday to help shape the debate.

"The guys trained in using this know not to broadly spray. They know how to use this stuff – it's money to them."

The last public hearing on **Calgary's** pesticide bylaw endured late in the night, with various industry and anti-pesticide speakers as well as a **Health Canada** official, who noted that his agency rigorously tests the chemical products to ensure they're not harmful when used properly. This week's meeting will be the last chance for public input before the final bylaw is crafted.

Earlier this month, council voted to reject a motion calling for city to gradually move toward a fuller pesticide ban, with many aldermen [COUNCIL MEMBERS] saying tougher rules would be virtually unenforceable on private property.

Alderman JOE CECI is holding out hopes that colleagues minds will change on a bylaw he said is too weak. *" I do not see how it's going to address the real health concerns people have expressed to me about pesticides in Calgary," Ceci* said.

Calgary's proposals would take effect JANUARY 1 [2009], the same day as the province begins banning sale of all weed-and-feed products.

Individuals who aren't licensed to use pesticides would be barred from using hose-end spray chemicals and any that require dilution, but can still spot-spray pests or weeds. Anyone who gets paid to apply pesticides will need a licence, keep records and post notices for at least a day after using the chemical treatments.

The bylaw also doesn't impose a crackdown on pesticide use on city-owned parks or sports fields. The city has tried limiting its chemical use through an integrated pest management plan, and last year cut its herbicide use to 981 kilograms, down 80 per cent over the previous year's levels.

City administration won't spend any extra money in 2010 on public awareness around pesticides or enforcement, but is requesting **\$500,000** for programs in 2011.

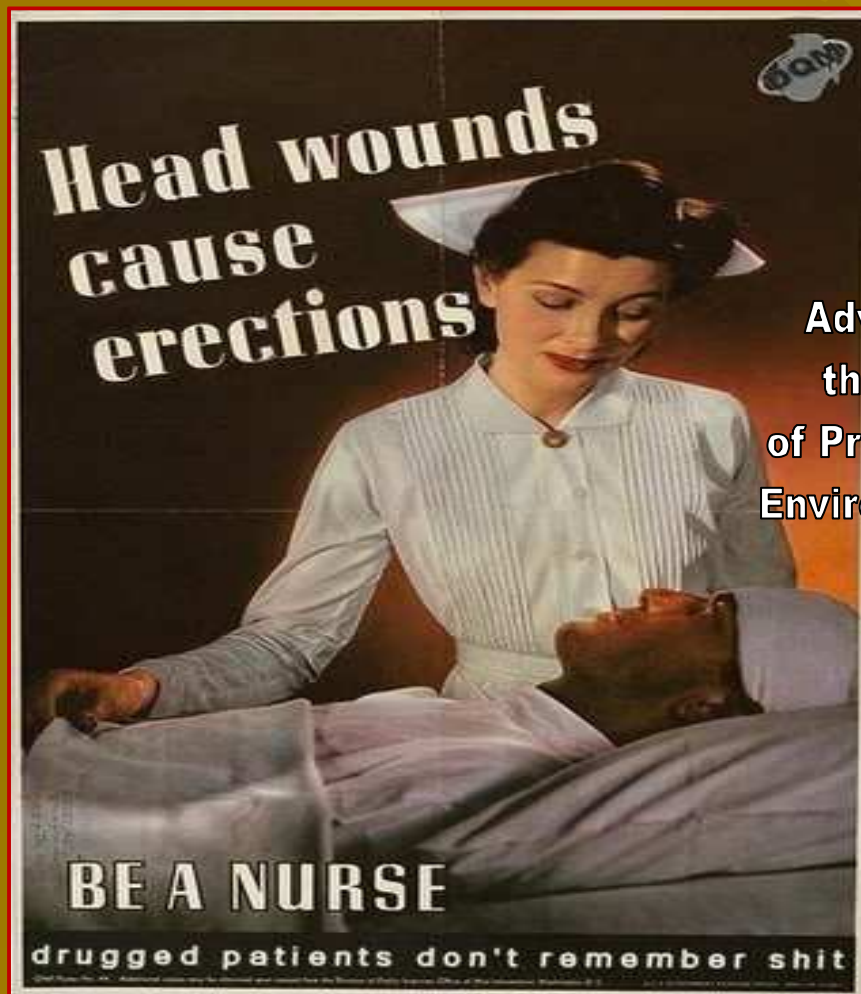
