Raey herself is paid a HEFTY SUM OF PROFIT as an « expert » on the IMAGINARY DANGER of pest control products, despite the fact that she has NO recognized expertise, training, or background in this matter.

The opinions expressed by Raey are TOTALLY VALUELESS and UTTERLY WORTHLESS.

Raey and her Cancer-Maniac buddies prefer JUNK LAWNS and JUNK LANDSCAPES that are unaltered by human activity, and are infested by damaging weeds, insects, and disease pests.

The prohibition of pest control products promoted by Raey and her Cancer-Maniac buddies has been DEVASTATING for the maintenance of public green spaces and sports fields since there are NO valid economical Green Alternatives to replace prohibited products.

Raey is also OUT-OF-TOUCH with the fact that pest control products are SCIENTIFICALLY SAFE.

Neither Raey, nor her Cancer-Maniac buddies, has ANY TRAINING or BACKGROUND in matters concerning pest control products or the maintenance of sports turf.

Their opinions are TOTALLY VALUELESS and UTTERLY WORTHLESS.

Enviro-Maniac-Activists, like Raey, conveniently consider the hundreds of qualified scientists of Health Canada's respected Pest Management Regulatory Agency to be incompetent and/or incapable of arriving at correct scientific findings concerning conventional pest control products.

In order to allow SOUND SCIENCE to be effectively practiced when evaluating pest control products, it would be preferable leave the interpretation of scientific research to those people who ARE competent to do it — Health Canada, and NOT people like Raey.

NO pest control product can be sold or used until Health Canada's scientists have evaluated ALL the existing evidence to determine whether the product meets stringent health and safety requirements.

Health-Canada-Registered pest control products are SCIENTIFICALLY SAFE since they have been scrutinized and approved by the HUNDREDS of expert scientists at Health Canada!

Overall, when they are used properly, there are NO harmful irreversible effects to health and the environment!

Raey CANNOT BE HONEST about the fact that pest control products are SCIENTIFICALLY SAFE since she is paid HUGE SUMS OF MONEY to concoct IMAGINARY DANGERS about them.

Raey CONVENIENTLY IGNORES the facts dispensed by the EXPERTS from Health Canada and the Pest Control Product Industry.

Furthermore, Raey believes she KNOWS BETTER than the HUNDREDS OF SCIENTISTS AT HEALTH CANADA, the government agency that STRINGENTLY regulates pest control products!

Raey knows full well that Green Alternatives are BOGUS.

There are NO valid Green Alternatives to effectively control damaging weed and insect pests.

There are NO viable, efficacious, or economical Green Alternatives to replace conventional pest control products.

Green Alternatives may be ALMOST TOTALLY INEFFECTIVE except under very specific circumstances — they may NOT fully control pests, and may only provide PARTIAL SUPPRESSION.

Green Alternatives may require rates and frequency of application that are EXORBITANTLY HIGH.

Green Alternatives may be questionably HIGHER IN TOXICITY—
the so-called non-toxic but BOGUS Green Alternatives that are being
proposed to replace conventional pest control products are NOT all
as low-risk or non-toxic as Raey assumes them to be.

Moreover, Raey knows full well that NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products has RUINED Modern Professional Lawn Care companies across Canada!

Professional Lawn Care businesses have BEEN UNABLE to shift successfully to Green Alternatives since VIRTUALLY ALL Green Alternatives are almost TOTALLY INEFFECTIVE except under very specific circumstances.

Wherever prohibition is imposed, DAMAGES to the Professional Lawn Care Industry are EXTENSIVE because there were NO valid economical alternatives to replace the prohibited products.

Consequently, Professional Lawn Care Companies are UNABLE to provide adequate weed and insect control, and are UNABLE to keep their customers satisfied.

EXTENSIVE DAMAGES IN ONTARIO LAST YEAR — in 2009, the Professional Lawn Care Industry LOST over 300,000,000 DOLLARS. Dozens of companies were forced to exit from the market by late 2009.

EXTENSIVE DAMAGES IN ONTARIO EXPECTED THIS YEAR — observers expected losses to reach 500,000,000 DOLLARS.

Within 36 months after the implementation of PROHIBITION-TERRORISM-LAWS, observers expected 780 BUSINESS FAILURES or BANKRUPTCIES in Ontario.

By late 2009, 40 to 70 % of Professional Lawn Care customers were ANNIHILATED.

Because of the PROHIBITION CONSPIRACY, Professional Lawn Care businesses were forced to TERMINATE many or most of their employees.

By late 2009, OVER 5,000 HAPLESS VICTIMS were UNEMPLOYED (full time employees and summer students).

In 2010, observers expected 8,300 to 12,500 UNEMPLOYED.

Because of PROHIBITION-TERRORISM, Professional Lawn Care businesses, which at one time provided a good living and some equity for eventual sale for retirement, became WORTHLESS!

Unfortunately, PROHIBITION-TERRORISM has guaranteed that no one would be able to buy or sell a Professional Lawn Care business!

Because of PROHIBITION-TERRORISM, many multi-vehicle Professional Lawn Care businesses are forced to DOWN-SIZE their operations to a single truck.

By 2010, there was a GLUT OF USED-EQUIPMENT-FOR-SALE because of the DOWN-SIZING and EXODUS of Professional Lawn Care businesses.

Because of PROHIBITION-TERRORISM, observers expected that many Professional Lawn Care businesses would simply be ABANDONED.

PROHIBITION-TERRORISM has DESTROYED the Modern Professional Lawn Care Industry.

EXTENSIVE DAMAGES IN QUEBEC SINCE 2006 — The NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products in Quebec was legislated BEFORE Ontario, and provided observers with valuable facts about the LEVEL OF CARNAGE to expect for Ontario.

Since 2006, Quebec PROHIBITION-TERRORISM-LAWS were DEVASTATING to the Professional Lawn Care Industry — OVER 60 per cent of the Professional Lawn Care Industry was ANNIHILATED.

In the PROVINCE OF ONTARIO, people like Natasha Raey, are facing charges of FRAUD under the Canadian CRIMINAL CODE.

In the PROVINCE OF ONTARIO, people, like Raey, conspired with Government Officials by using DISGRACEFULLY FALSE and MISLEADING information in order to impede access to Health-Canada-Approved products through FRAUDULENT MEANS.
