In municipalities throughout British Columbia, Government Officials are now CONSIDERING REVERTING BACK to conventional pest control products like Roundup since Green Alternative Pesticides and Practices DO NOT WORK.

In municipalities like Coldstream, British Columbia, the professional labour force has been DEVALORIZED into a group of mere COTTON-PICKING NIG-GARS.

District Municipality of Coldstream

Coldstream is a District Municipality in British Columbia, located in the Okanagan Valley, with a population under 10,000.

The municipality is directly south-east of the City of Vernon, and is considered part of Greater Vernon.

It is a member municipality of, and also the location of the head offices of, the Regional District of North Okanagan.



Anti-Pesticide CARNAGE

Coldstream parks are OVER-RUN BY WEEDS, and MUST BE TOTALLY RENO-VATED.

The PROBLEM OF WEEDS surfaced after Coldstream PROHIBITED the use of pest control products in 2009.

While WEED-PICKING was used initially to control weeds, it appears NO professional municipal employee wanted to continue with this form of MANUAL NIGGAR LABOUR.

Regional District of North Okanagan staff reported that, because of Anti-Pesticide PROHIBITION, the Creekside Park BASEBALL DIAMOND will cost

- 6,000 dollars PER WEEK for MANUAL NIGGAR LABOUR involving HOEING, and
- 5,809 dollars PER WEEK for DRAGGING THE SITE.

Moreover, the Creekside Park BASEBALL DIAMOND must be COMPLETELY RENOVATED with RE-SURFACING and NEW SHALE.

Regional District of North Okanagan will spend 3,000 DOLLARS to bring the Creekside Park BASEBALL DIAMOND up to standard SINCE THE WEEDS LEFT IT IN AN UNUSABLE CONDITION FOR PLAYING SAFELY.



Anti-Pesticide CARNAGE (continued)

According to the Coldstream Park Administrator —

We will RESTORE the diamond to a USABLE STATE.

However, it is undetermined exactly how Regional District of North Okanagan will ensure weed growth will not occur again.

This is because there are NO viable, efficacious, economical, or low-risk alternatives to replace conventional weed control products like Roundup.

Organic Pesticide-Free Maintenance DOES NOT WORK.

Roundup Is Environmentally-Friendly

Coldstream has DEMANDED that Regional District of North Okanagan allow it to use a federally-approved « organic » weed control product to control weeds along the BASEBALL PATHS.

The BASEBALL PATH is the area within which a base runner must stay when running between bases.

But there are differences of opinion between reasonable people and antipesticide lunatics on what the term « organic » means as all compounds are organic in nature, but there may still be an environmental impact.

According to the Coldstream Park Administrator —

Whether it is ROUNDUP or other federally approved chemicals, yes (WE WILL USE THEM).

If you talk to the people who approve herbicides, they will arque it is ENVIRONMENTALLY-FRIENDLY.

Organic Pesticide-Free Maintenance creates HAZARDOUS SLIPPING CONDI-TIONS on playing surfaces.

On sports turf, safety considerations also influence decisions to use pest control products because bare areas, or large weedy patches, can increase the SLIPPING HAZARD.

The Precautionary Principle dictates that pest control products SHOULD NOT BE PROHIBITED.

With the choice between treating and not treating, the decision for proper weed control must be made.

Proper weed control on turf helps PREVENT SLIPPING INJURIES by eliminating broad-leaved weeds with pest control products that have been SCIENTIF-ICALLY-ASSESSED.

The SAFETY ASSESSMENT of pest control products takes into consideration CHILDREN's physiology, behaviours, and habits WHILE PLAYING ON TREATED GRASS.
