### Tides Canada and Tides Foundation USA

By far, the largest British-Columbia-based recipient organization is TIDES CANADA, which has been paid nearly 60 MILLION DOLLARS by U.S. founda-

The [ENVIRO-LUNATIC] MAYOR OF THE CITY OF VANCOUVER, GREGOR ROB-ERTSON, is no stranger to Tides Canada.



## Tides Canada and Tides Foundation USA (continued)

In fact, GREGOR ROBERTSON was a Tides Canada DIRECTOR from 2002 until 2004 when he entered politics with the provincial NEW DEMOCRATIC PARTY.

In 2008, the [Enviro-Lunatic] MAYOR OF THE CITY OF VANCOUVER, GREGOR ROBERTSON, won the municipal election thanks to financing from Tides USA.

In the run-up to the 2008 municipal election, Vision Vancouver's BIGGEST FINANCIAL BACKER was the FORMER CHAIR of Tides USA, Joel Solomon.

In a rather candid interview last year, Solomon told the Huffington Post that the election of Robertson was the result of « nearly 20 years of moving in a purposeful direction ».

### **Bullitt Foundation and Tides Foundation USA**

In digging through U.S. tax returns and other records, one of the things that I have noticed is that the Seattle-based BULLITT FOUNDATION and the San Francisco-based TIDES FOUNDATION have PROVIDED FUNDS TO SUPPORT VI-SION VANCOUVER'S GREEN AGENDA.



Through Tides USA, Bullitt granted 50,000 DOLLARS in 2010 « for expenses

### Tar Sands Campaign

In 2009 and 2010, Tides USA paid 10 MILLION DOLLARS to 43 small, envi-

Tides USA and Tides Canada also spend roughly 20 million DOLLARS annually on consultants, 15 MILLION DOLLARS and 5 MILLION DOLLARS, respectively.

Bullitt Foundation also paid 564,000 DOLLARS to Tides USA for re-granting for various projects of Tides Canada, the Dogwood Initiative, and the Tyee Solutions Society.

In 2010-2011 Bullitt Foundation paid the Vancouver-based Pembina Institute for Appropriate Development 85,000 DOLLARS « to accelerate commercialization and deployment of electric vehicles as a part of a sustainable transportation system in Vancouver and the Lower Mainland ».

Bullitt Foundation also paid 70,000 DOLLARS to the Canadian Society Promoting Environmental Conservation (SPEC).

That included 32,000 DOLLARS in 2006 « to prevent highway expansion and bridge construction in the Lower Mainland » and a further 25,000 DOLLARS

In 2008, Bullitt Foundation paid the Dogwood Initiative 30,000 DOLLARS oil and gas infrastructure in Georgia Strait and the lower Fraser Basin ».

Indeed, if the agenda of the Bullitt Foundation is to BLOCK INFRASTRUCTURE DEVELOPMENT in the Lower Mainland, it wouldn't hurt to have the Vancouver mayor and council on side.
