In November 2012, a flyer distributed by a local Green Party candidate during the Victoria By-Election claimed the candidate was ENDORSED BY DAVID SUZUKI.

Victoria By-Election To The 41st Canadian Parliament

On August 23rd, 2012, Denise Savoie, Member of Parliament for Victoria, in British Columbia, since 2006, announced that she would be resigning her seat effective August 31.

Prominent environmental lawyer Murray Rankin was nominated as the New Democratic Party candidate, and WON the by-election on November 26th, 2012.

Donald Galloway, who predictably LOST the riding on behalf of Green Party, had won the party nomination based upon a mere coin toss.

Leader Of Green Party

In 2006, Elizabeth May became Enviro-Lunatic-Leader for Green Party of Canada, the POLITICAL SHIELD for Anti-Pesticide and Environmental-Terrorist Organizations.

In 2011, Elizabeth May was elected Member of Parliament in the Saanich-Gulf Islands, British Columbia, and remains the ONLY Green Party candidate to have ever won an election.

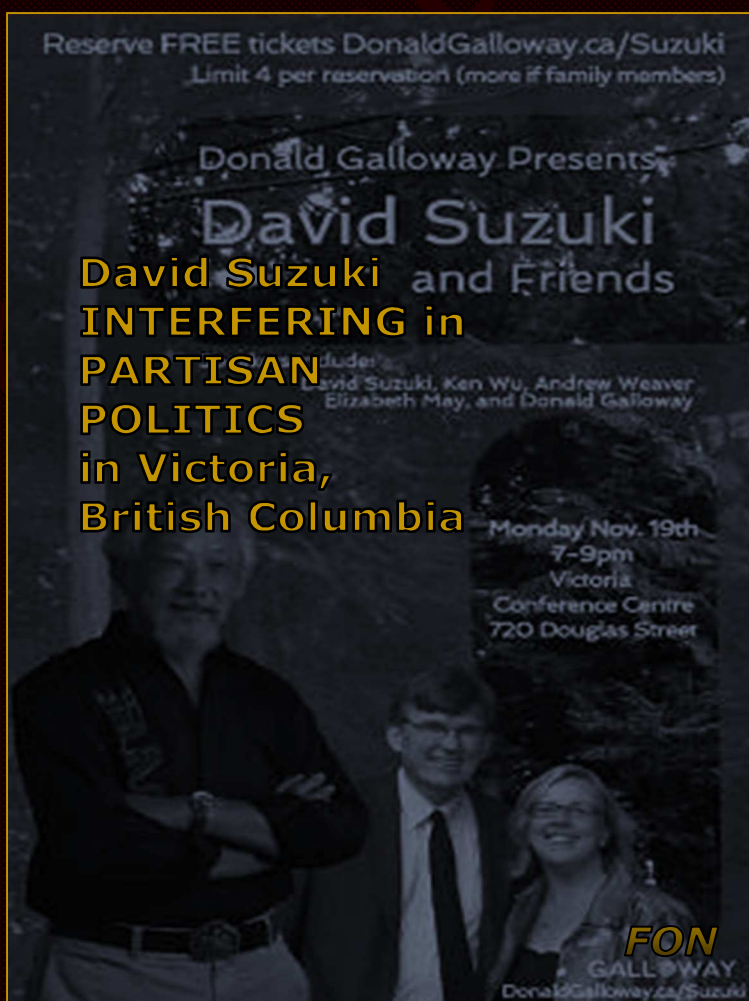

Why Did Suzuki DENY His Galloway Endorsement ?

Suzuki did not want to repeat 2011, when he INTERFERED IN PROVINCIAL POLITICS, and ENDORSED INCUMBENT PREMIER DALTON MCGUINTY.

On July 21st, 2011, the Toronto Star reported David Suzuki, in an interview, URGED ONTARIANS TO RE-ELECT LIBERAL PREMIER DALTON MCGUINTY on October 6th, 2011 —

I'm offering an endorsement of what Mr. McGuinty has done, absolutely.

SUZUKI IS NON-PARTISAN ?!?!

Since 2008, Suzuki was a PRINCIPAL PARTISAN ARCHITECT with the Ontario McGuinty Government in CONSPIRING TO PROHIBIT against pest control products used in the Urban Landscape.

Suzuki described the environmental policies of the Conservative opposition rival, Tim Hudak, as « *absolute insanity* ».

Suzuki had even ENDORSED Premier Dalton McGuinty's Green Energy Plan in a SUBVERSIVE VIDEO.

The SUBVERSIVE VIDEO, which showed David Suzuki and McGuinty walking through Vancouver's Stanley Park, was REMOVED from the Liberal Party web-site on September 18th, 2011, following COMPLAINTS from Wind Concerns Ontario, a citizens' group that opposed McGuinty's wind turbine proliferation throughout Ontario.

Given Suzuki's close ties to his foundation, there was clearly a CONFLICT-OF-INTEREST with his ENDORSEMENT of McGuinty.

In 2010, David Suzuki Foundation RECEIVED BETWEEN 100,000 AND 250,000 DOLLARS from The Ontario Trillium Foundation.

Trillium is an agency of the Government of Ontario, and operates as a FINANCIAL SHIELD to provide direct funding to Environmental-Terrorist-Organizations, like David Suzuki Foundation.

Suzuki was a PRINCIPAL PARTISAN ARCHITECT with the Ontario McGuinty Government in CONSPIRING TO PROHIBIT pest control products used in the Urban Landscape.

PAY-OFFS under the guise of GOVERNMENT GRANTS to Environmental-Terrorist-Organizations is NOTHING NEW for Trillium.

Even the leader of Green Party, Elizabeth May, said Galloway's DOOR FLYER was a MISTAKE.

May said she conveniently did not see the flyers until they had been printed, although her own image was inserted with both Suzuki and Galloway.

According to Elizabeth May —

Complaints Against Suzuki by Ethical Oil

On April 23th, 2012, David Suzuki Foundation became THE TARGET OF A COMPLAINT TO THE CANADA REVENUE AGENCY (CRA), just days after its namesake co-founder, David Suzuki himself, STEPPED DOWN amid heightened tensions between environmental charities and the Government of Canada.

EthicalOil.org, a non-profit organization that promotes oil from Canada and other democracies, sent a COMPLAINT to Canada Revenue Agency asking it to INVESTIGATE whether David Suzuki Foundation is BREAKING RULES THAT PERTAIN TO POLITICAL ACTIVITY.

The COMPLAINT comes on the heels of the Government of Canada's WARNING that it will keep a much closer eye on the BLURRY LINE BETWEEN CHARITY AND POLITICS, arming the tax department with 8-MILLION-DOLLARS to enforce the rules.

Registered charities are allowed to devote only a SMALL FRACTION of their resources to POLITICAL ACTIVITY, although they can NEVER BE PARTISAN.

EthicalOil.org said in its 44-page COMPLAINT, which was drafted by Calgary-based JSS Barristers —

If you find the Suzuki Foundation is in contravention of the CRA rules, then we request that you consider whether the Suzuki Foundation should have its CHARITABLE STATUS REVOKED or otherwise be SANCTIONED.

Complaints Against Suzuki by Ethical Oil (continued)

The COMPLAINT relates to David Suzuki Foundation's activities since 2011, and the bulk of the COMPLAINT outlines allowable political activity such as letter-writing campaigns to federal politicians or blog posts urging the Government of Canada to change its environmental policies.

Jamie Ellerton, Executive Director of EthicalOil.org, said those activities point to David Suzuki Foundation's POLITICIZATION.

According to Ellerton Canada Revenue Agency should ...

... determine whether or not they are crossing the 10 per cent political threshold and VIOLATING CHARITIES LAW.

The COMPLAINT also says David Suzuki Foundation RECEIVED FUNDING FROM THE BRITISH GOVERNMENT, and that the purpose of the funding may have been TO FORWARD THE POLICIES OF THE UNITED KINGDOM GOVERNMENT ON CLIMATE CHANGE IN CANADA.

Ellerton said the COMPLAINT was faxed to David Suzuki Foundation, but the organization did not confirm receipt or provide comment.

Ellerton said that organizations like Suzuki should FORGO CHARITABLE STATUS — and all the economic benefits it brings — if they want THE FREEDOM TO BE POLITICAL —

What we're looking to accomplish [in issuing a complaint to the revenue agency] is to ENSURE TAX-PAYERS AREN'T SUBSIDIZING THE POLITICAL ACTIVITY of the David Suzuki Foundation.

Other portions of the COMPLAINT accuse David Suzuki Foundation of ENGAGING IN PROHIBITED PARTISAN ACTIVITY and point to the following as two examples —

- A blog post titled ONTARIO LIBERAL PLATFORM MAINTAINS GREEN ENERGY FOCUS, which was published two days after the 2011 provincial election was called in 2011; and
- A July 2011 Toronto Star article that reported Mr. Suzuki had endorsed Premier Dalton McGuinty and was URGING ONTARIANS TO RE-ELECT THE LIBERAL LEADER.

EthicalOil.org also mounted a FORMAL COMPLAINT against Environmental Defence in March 2012.

Other Environmental-Terrorist-Organizations have CONCOCTED SCHEMES in order to protect themselves.

In 2012, ForestEthics Canada announced it would SPLIT INTO TWO so one segment could devote all its time to opposing projects such as the Northern Gateway oil pipeline.

ForestEthics Canada was never a registered charity itself, but its donors received tax receipts through its former UMBRELLA GROUP, TIDES CANADA.

It is known in at least one instance that the Vancouver address for TIDES USA, as reported to the U.S. Internal Revenue Service by the Hewlett Foundation, is EXACTLY THE SAME AS THE ADDRESS OF DAVID SUZUKI FOUNDATION — 2211 WEST FOURTH AVENUE, SUITE 219.

Complaints Made Greenpeace Lose Its Charity Status

Suzuki can be STOPPED, just like Greenpeace.

Greenpeace, an Environmental-Terrorist-Organization, appealed against a 2010 ruling by the Charities Commission, which found ITS PROMOTION OF DISARMAMENT AND PEACE was POLITICAL rather than educational, and while it did not directly advocate illegal acts, Greenpeace-Lunatics had ACT-ED ILLEGALLY.

According to Justice Paul Heath —

Non-violent, but potentially ILLEGAL ACTIVITIES (such as trespass), designed to put (in the eyes of Greenpeace) objectionable activities into the public spotlight were an independent object DISQUALIFYING it from registration as a charitable entity.

According to Justice Heath, Greenpeace's pleas for disarmament and peace COULD BE SEEN AS AN INDEPENDENT PURPOSE, and its political activities WERE NOT NECESSARY to educate members of the public on the key issues of Greenpeace.

Greenpeace-Lunatic-Lawyer Davey Salmon argued all of the organisation's primary purposes were charitable and the engagement of charities in political advocacy was more acceptable now in 21st Century New Zealand.
