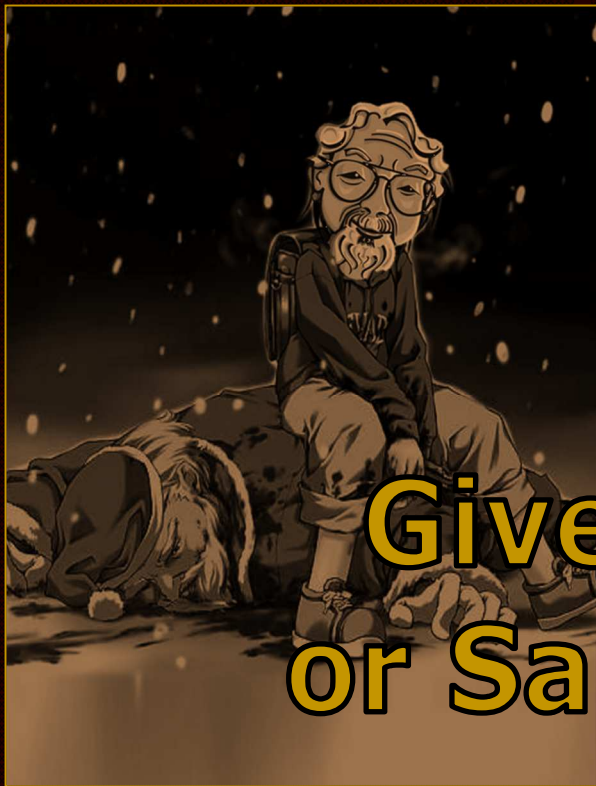

We won't be any happier and we won't be healthier — quite the opposite.

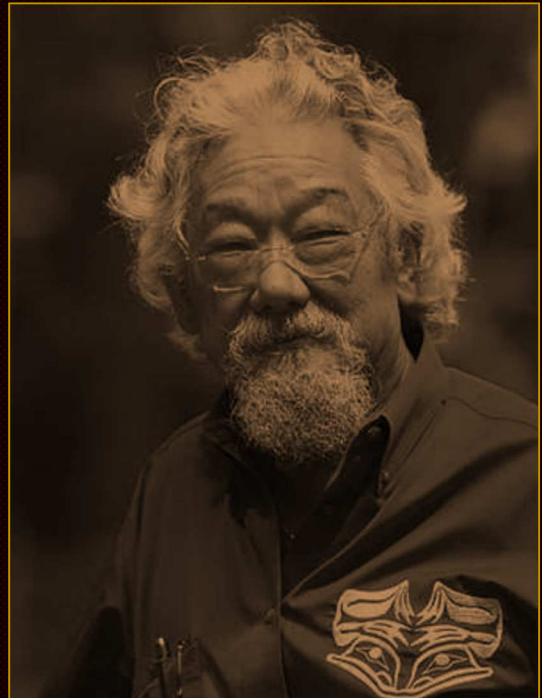
But the economy will be stronger. And that's all that counts, right ?
