State of Texas REPEALS I.P.M.



A bill submitted to the Texas Senate includes a provision that would ELIMI-NATE ALL REQUIREMENTS FOR SCHOOLS TO FOLLOW I.P.M.

Section 13 paragraph (2) of Senate Bill 468, introduced by Senator Florence Shapiro (R) of Plano, Texas, would REPEAL Section 1951.212 of the

Occupations Code, the section of state law entitled « Integrated Pest Management Programs for School Districts ».

The intent of the bill is to reduce costs to Texas school districts in this time of very tight budgets.

A BILL TO BE ENTITLED AN ACT relating to the flexibility of the board of trustees of a school district in the management and operation of public schools in the district.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 13. The following provisions are repealed:

- (1) Section 21.402(d), Education Code; and
- (2) Section 1951.212, Occupations Code.

SECTION 17. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2011.

The DISMAL FAILURE of Ontario Voluntary Turf Integrated Pest Management Accreditation

In essence, Integrated Pest Management became FASHIONABLE because of the impending threat of PROHIBITION of conventional pest control products.

For example, in 2005, the Ontario Green Space Industry launched I.P.M. ACCREDITATION as an alternative to the looming municipal PROHIBITIONS against conventional pest control products.

Indeed, since 2003, Pamela Charbonneau, a Turfgrass Specialist with Ontario Ministry of Agriculture, Food and Rural Affairs, had been spear-heading the ambitious Ontario Voluntary Turf Integrated Pest Management Accreditation program.
