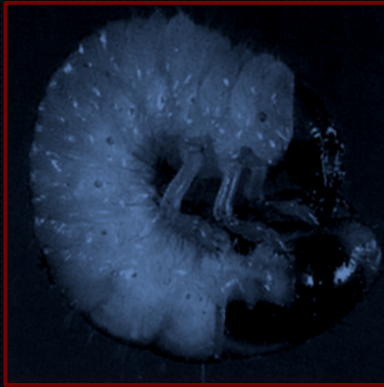

Approximately 100 million nematodes should cover a 33X45 ft lawn. Water the lawn for 3 hours prior to nematode application and for 3 hours following nematode application. Nematodes should be applied in the evening or on a cloudy day.

The DISMAL Failure of Nematode Insecticides

Despite claims to the contrary, overall, there are NO viable, efficacious, or economical Green Alternatives to replace conventional pest control products.

Overall, Green Alternatives are a DISMAL FAILURE since they merely suppress or inhibit pests of turf, and require an excessive number of repeat applications, often with extremely-high-inputs of active ingredient.

On the other hand, conventional pest control products fully and effectively control pests, without the need for excessive repeat applications, or without the use of exorbitant quantities of active ingredient.

Nematode Insecticides are yet another example of Green Alternatives that have been a DISMAL FAILURE.

Nematode Insecticides CANNOT be consistently considered as a true alternative to conventional insecticides, since the insect pests are often only SUPPRESSED, and NOT CONTROLLED.

Nematode Insecticides are NOT REGISTERED and HAVE NOT BEEN FULLY TESTED as pest control products in Canada.

When a product is registered under the Federal Pest Control Products Act, information is required concerning HUMAN TOXICITY (short-term, chronic, irritation, sensitization, developmental, mutagenic, and teratogenic), as well as ENVIRONMENTAL IMPACTS (eco-toxic fate and degradation).

Not only are Nematode Insecticides a DISMAL FAILURE, they are also INADEQUATELY TESTED FOR HUMAN TOXICITY and ENVIRONMENTAL IMPACT.

City of Vancouver Brochure



The European chafer, *Rhizotrogus majalis*, is an introduced insect that has become a serious pest of turf in Eastern North America. It was first discovered in New Westminster in late 2001 and has since spread beyond New Westminster's boundaries.

Description

Adult European chafers are tan or brown beetles resembling June beetles but measure only about 1.5cm in length. The grubs, measuring 2 to 3cm, are soft, white and covered with prominent warts and six prolegs.

Biology and Life Cycle

Chafers complete their life cycle in one year which can lead to rapid population increases. In British Columbia, the adult beetles emerge from the soil in early to late June and mate in swarms at dusk. In June and July, females lay up to 20 to 30 eggs in the soil. The eggs hatch in about 2 weeks and the small grubs begin to feed on the roots of turf. Heavy infestations may lead to the turf feeling "spongy" due to grub tunneling. Infested turf will commonly be wilted or dead and be easy to pull back, revealing the feeding larvae. Damage is seen in the fall to early spring when the grubs are full-grown. Feeding continues throughout the winter except during prolonged periods of freezing temperatures. The grubs feed until they pupate in May.

The Threat

The grubs feed on roots of many different plants, but prefer the fibrous roots of turfgrasses. Damage can be masked by abundant moisture in spring and fall but drier weather quickly results in the appearance of brown patches. From fall to early spring, birds, skunks and other predators turn over the lawn in search of the large grubs. The adult beetles seldom cause any significant damage. The short-lived beetles do not bite or sting.

Management Monitoring:

To monitor, cut squares of a 10 by 30cm square of sod to a depth of 5cm, a "field" test to count the grubs. Cut 5 sections per lawn, wading through soil beneath grass and counting the number of grubs. If more than 5-10 grubs are found per section, chaffer control may be necessary.

Maintenance:

Keep your turf healthy and vigorous by routine aerating, dethatching, fertilizing, deep watering and high mowing. This will help it tolerate smaller infestations without showing signs of damage. In high traffic areas consider grass replacements such as mulch or paving stones, or use alternative ground covers.

Biological control:

Apply nematodes, *Heterorhabditis bacteriophora*, during the third week of July. Apply at a rate of 70,000 per square foot, or 200,000 per square metre. Approximately 100 million nematodes should cover a 33X45 ft lawn. Water the lawn for 3 hours prior to nematode application and for 3 hours following nematode application. Nematodes should be applied in the evening or on a cloudy day.

Chemical control:

There is no chemical control option allowable under Vancouver's Pesticide By-law (Health By-law 9539).

Moreover, there were serious issues with the Ontario Minister of the Environment, John Gerretsen, who was responsible for implementing PROHIBITION. Gerretsen was INDISCREET with his CLOSE PUBLIC ASSOCIATIONS with RADICAL and SUBVERSIVE LUNATIC-PROHIBITION-TERRORISTS.

HORRENDOUS CARNAGE Caused by LUNATIC-PROHIBITION in Ontario

The DEVASTATION of the Professional Lawn Care Industry was EXTENSIVE because there were NO valid economical alternatives to replace the prohibited products. VIRTUALLY ALL Green Alternatives were almost TOTALLY INEFFECTIVE, except under very specific circumstances. The Green Alternatives were BOGUS. They were DISMAL FAILURES.

Consequently, Professional Lawn Care Companies were UNABLE to provide adequate weed and insect control, and were UNABLE to keep their customers satisfied.

LOSS OF REVENUES in Ontario Caused by LUNATIC-PROHIBITION

In 2009, the Ontario Professional Lawn Care Industry lost over 300,000,000 DOLLARS.

In 2010, losses reached over 500,000,000 DOLLARS.

Neither Suzuki, nor ANY of his co-conspirators, has ANY recognized expertise, training, or background, in matters concerning pest control products or the Green Space Industry.

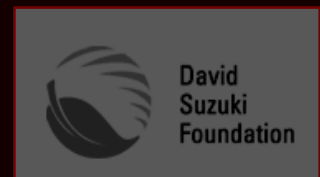
The Suzuki ENVIRO-TERROR-ALLIANCES are actually SHIELD organizations.

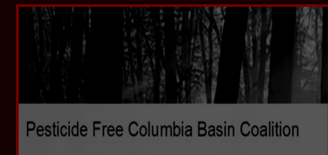
