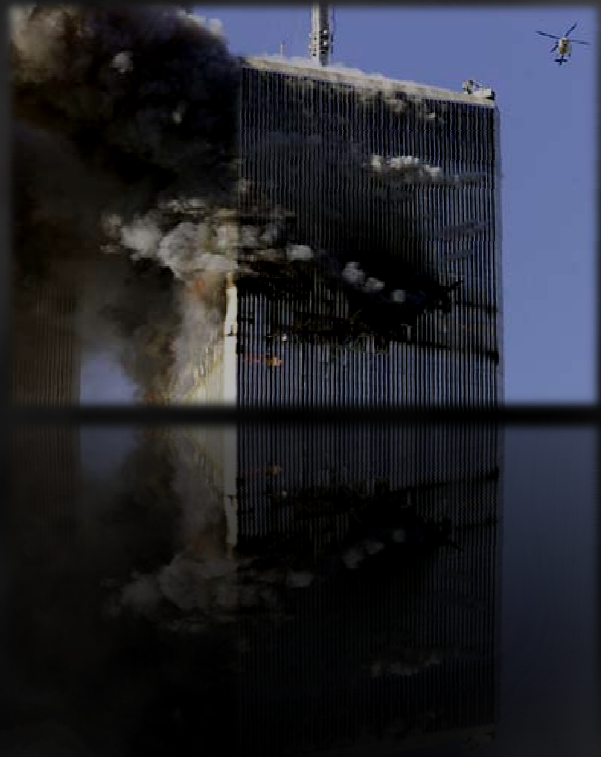

Consequently, their opinions are TOTALLY VALUELESS and UTTERLY WORTHLESS. They are NOT competent to give advice.

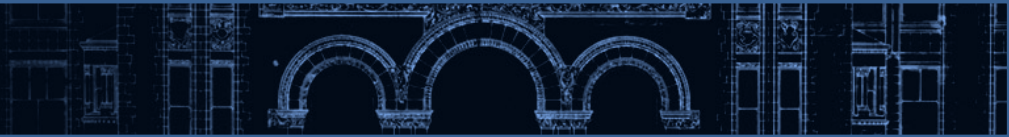

Gallagher —

My name is Irene Gallagher, and I am the manager of public issues at the Ontario division of the Canadian-Cancer-Society.

As I'm sure you are aware, cancer is a leading health issue in Ontario.

This year alone, approximately 63,000 Ontarians will be diagnosed with cancer and 27,300 DEATHS from CANCER will occur.

It is truly amazing how PROHIBITION-TERRORISTS like Gallagher CONCOCT their IMAGINARY DANGER about conventional pest control products and SCAM and DECEIVE the public by blurting out HOLLOW and DESPICABLY-ALARMIST expressions like « *cancer* » and « *death* ».

The Canadian-Cancer-Society is very concerned about the cosmetic use of pesticides, as they offer no countervailing health benefits to society.

Many Ontarians share our concerns, as illustrated through a 2007 Oracle POLL that indicated 71% of Ontarians support province-wide restrictions on pesticides. [Wrong !]

Predictably, the BOGUS Enviro-Poll indicates that most people favour a prohibition of conventional pest control products ! [Wrong !]

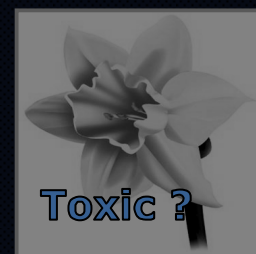
A MAJOR SOURCE OF DONATIONS collected by Cancer-Maniacs originates from the sale of Daffodil flowers.
