The Case of Nutri-Lawn Franchise Operating in Kingston and Belleville, in the Province of Ontario — Tymack Incorporated O/A Nutri-Lawn Kingston and Robert Baxby was fined 10,486 Dollars for using a pest control product, contrary to the NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION that was legislated and enforced by SUBVERSIVE Ontario Government Officials, who are, in fact, Prohibition-Terrorist-Thugs doing the bidding of their masters in the Environmental-Terror-Movement.

Pest control products are being used by Professional Lawn Care companies in contravention of prohibition because ...

... there are NO viable, efficacious, or economical Green Alternatives to replace conventional pest control products.

Tymack Incorporated operating as Nutri-Lawn Kingston and Robert Baxby were each CONVICTED of four violations under the Pesticides Act for USING A HEALTH-CANADA-APPROVED PEST CONTROL PRODUCT, and FAILING TO POST SIGNS as per regulations.

The Court heard that Mr. Baxby is the manager and sole director of Tymack Incorporated operating as Nutri-Lawn Kingston, who has been providing lawn care services in Belleville and Kingston, in the Province of Ontario.

### ALTERNATIVES

The Government of Ontario FALSELY ASSURED the Professional Lawn Care Industry that safe, effective, and affordable Green Alternatives were already available to replace conventional pest control products.

Virtually all Green Alternatives are BOGUS, displaying negative characteristics such as the following —

- BOGUS Green Alternatives are ALMOST TOTALLY INEFFECTIVE except under specific circumstances
- BOGUS Green Alternatives require EXTREMELY-HIGH-INPUTS OF ACTIVE INGREDIENT since they will otherwise be less effective
- BOGUS Green Alternatives are HIGHER IN TOXICITY, and pose HIGHER ENVIRONMENTAL RISKS
- BOGUS Green Alternatives are PROHIBITED in some jurisdictions because of concerns about safety
- BOGUS Green Alternatives are STUNNINGLY MORE EXPENSIVE to use when compared to conventional pest control products
- BOGUS Green Alternatives are supplied by the same For-Profit-Enviro-Terror-Businesses that sought the PROHIBITION-TERRORISM policies against conventional pest control products
- BOGUS Green Alternatives have negative side-effects like PHYTO-TOXICITY ( adversely affects plant growth ) or CORROSION or RODENT-ATTRACTION
- BOGUS Green Alternatives require MORE PERSONAL PROTECTION for the user
- Green Alternatives are NOT SAFER, NOT BETTER, and NOT MORE EFFECTIVE

On April 24<sup>th</sup>, 2009, Mr. Baxby met with Government of Ontario staff in Kingston to discuss the new cosmetic pesticide ban, and the requirements of the ban were explained to him.

Baxby was threatened by the Government's own Prohibition-Terrorist-Thugs to comply with the new ban ... or else.

These thugs essentially threatened Baxby with ENVIRONMENTAL-TERRORISM.

On August 13<sup>th</sup>, 2009, the Government of Ontario RECEIVED A REPORT FROM ONE OF ITS INFORMANTS that Baxby's company trucks and employees were applying chemicals to control weeds at a site in Kingston, leaving a strong odour.

( Big deal ! — Many types of products leave strong odours. )

### COINCIDENCES

The Government of Ontario received complaints about the Nutri-Lawn franchise in the CITY OF KINGSTON.

Coincidentally, the office of Jeffrey P. Lowes and M-REP Communications is LOCATED IN THE CITY OF KINGSTON.

Coincidentally, the office of Jeffrey P. Lowes and M-REP Communications has LEGALLY CHALLENGED the needless, senseless, and malicious prohibition that was legislated by the subversive Government of Ontario.

Coincidentally, the office of Jeffrey P. Lowes and M-REP Communications has outlined the list of CHARGES against the Government of Ontario and the Ministry of the Environment.

Coincidentally, the office of Jeffrey P. Lowes and M-REP Communications has implemented LEGAL PROCEEDINGS against individual members of Prohibition-Terrorist-Organizations under the Canadian Criminal Code.

The Government's own Prohibition-Terrorist-Thugs swarmed over the site and confirmed that the company had sprayed that morning.

There were also NO signs posted. The signs were likely removed by the informants themselves.

On August 19<sup>th</sup>, 2009, a NON-EXPERT examination of the turf areas by NON-EXPERT Government-Prohibition-Terrorist-Thugs at the site revealed BROAD-LEAVED WEEDS WITH ABNORMAL PATTERNS OF LEAF GROWTH, characteristic of exposure to PHENOXY HERBICIDES.

On October 8<sup>th</sup>, 2009, the Government of Ontario RECEIVED MORE REPORTS FROM ITS INFORMANTS related to company employees using a mixture in the spray tank at a site in Belleville.

## INFORMANTS

The Government of Ontario uses NAZI INFORMANTS.

The complaints concocted about Nutri-Lawn Kingston were received from UNSCRUPULOUS competitors operating in the Professional Lawn Care Industry.

Several TRAITOROUS Franchise Businesses have instructed their members and staff to betray their competitors to the Government's own Prohibition-Terrorist-Thugs.

These Franchise Businesses operate just like NAZI INFORMANTS.

Some of these same TREACHEROUS businesses also supported prohibition since they were investors in Green Alternatives ( that later turned out to be BOGUS ).

# Violating Prohibition

Again, NO signs were posted.

Again, the signs were likely removed by the informants themselves.

SAMPLES taken from the tank confirmed AMOUNTS OF PHENOXY HERBICIDE, and therefore, a banned substance.

However, transporting a so-called banned substance in a spray tank DOES NOT contravene the prohibition of pest control products in the Province of Ontario.

Moreover, NO samples were taken from the properties themselves.

The Government's own Prohibition-Terrorist-Thugs DID NOT prove that a phenoxy herbicide was actually sprayed.

Baxby's company was fined at total of 10,486 dollars on two charges, plus a victim fine surcharge, and given 12 months to pay the fines.
