The **DISMAL FAILURE** of Integrated Pest Management



Chicago CANCELLED the Integrated Pest Management Program and RESCINDED the PROHIBITION of pest control products

On August 18th, 2011, Park District of Highland Park in the City of Chicago commissioners **CANCELLED THE INTEGRATED PEST MANAGEMENT PROGRAM** and **RESCINDED THE PROHIBITION OF CONVENTIONAL PEST CONTROL PRODUCTS**.

Its grounds-keepers are allowed to again **DEPLOY PEST CONTROL PRODUCTS ON ITS PLAYING FIELDS** this fall.

The district introduced **NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION** about four years ago when it launched the **ILL-FATED** Integrated Pest Management program.

The **INEFFECTIVE** Integrated Pest Management program was, not surprisingly, praised as a model among the **Non-Expert Enviro-Lunatic Natural Lawn-Care Movement**.

The turf-maintenance principles shifted from pest control products to so-called organic, and cultural practices, including intensified irrigation, aeration, mowing, over-seeding and other cultural practices to keep the turf in good condition.

I.P.M. cultural practices DID NOT CONTROL WEED AND INSECT PESTS.

CORN GLUTEN MEAL, which was billed as a so-called natural substitute for synthetic herbicides, was tested in Highland Park.

District officials reported ODOR PROBLEMS and LIMITED SUCCESS with CORN GLUTEN MEAL.

CORN GLUTEN MEAL WAS A DISMAL FAILURE.

Restaurant-grade VINEGAR was also sprayed, ILLEGALLY, and it was determined to be a better alternative under specific circumstances only.

However, park officials reported that THE I.P.M. PROGRAM CONTRIBUTED TO THE WORST FIELD CONDITIONS THE CHICAGO DISTRICT HAS SEEN IN MORE THAN A DECADE.

Ted Baker, the district's director of park operations, said DANDELIONS, CLOVER AND OTHER INVASIVE WEEDS HAVE OVER-RUN SEVERAL DISTRICT PARKS.

The WEEDS REPORTEDLY REPRESENT MORE THAN 60 PER CENT OF GROUND COVERAGE at Fink, West Ridge and Danny Cunniff parks.

Officials added that I.P.M. and Pesticide-Free parks have recently become one of the district's MOST SIGNIFICANT SOURCES OF COMPLAINTS, with comments pouring in from general park users and athletic program representatives.

« THE FIELDS ARE GETTING WORSE EVERY YEAR » said Park District Commissioner Cal Bernstein. « I think something needs to be done to reverse the trend. »

Pesticide-Free Integrated Pest Management will NEVER achieve the level of total reduction or elimination attained by using conventional pest control products.

The Failure of Integrated Pest Management



Wherever Pesticide-Free Integrated Pest Management is entirely relied upon for the maintenance of turf and ornamentals, damaging pests MAY only be slightly suppressed, AT THE EXPENSE OF PLANT GROWTH AND PLAYING CONDITIONS.

In practice, I.P.M. MAY BE MORE USEFUL in providing some LIMITED IMPROVEMENT towards the efficiency and effectiveness of conventional pest control products.

The DISMAL FAILURE of Ontario Voluntary Turf Integrated Pest Management Accreditation

In essence, Integrated Pest Management became FASHIONABLE because of the impending threat of PROHIBITION of conventional pest control products.

For example, in 2005, the Ontario Green Space Industry launched I.P.M. ACCREDITATION as an alternative to the looming municipal PROHIBITIONS against conventional pest control products.

Indeed, since 2003, Pamela Charbonneau, a Turfgrass Specialist with Ontario Ministry of Agriculture, Food and Rural Affairs, had been spear-heading the ambitious Ontario Voluntary Turf Integrated Pest Management Accreditation program for the Modern Professional Lawn Care Industry.

Charbonneau claimed, naively, but in good faith, that ...

« *The I.P.M. Council has proposed I.P.M. Accreditation as an alternative to pesticide prohibitions in municipalities in Ontario as a means to APPEASE environmentalists.* »

Ontario Voluntary Turf Integrated Pest Management Accreditation may have served only to irritate Non-Expert-Lunatic-Prohibition-Terrorists, who countered that this Ontario I.P.M. program SHOULD HAVE ELIMINATED the need to use ALL conventional pest control products.

In the final analysis, the Ontario Voluntary Turf Integrated Pest Management Accreditation program was a DISMAL FAILURE.

Despite the fact that pest control products are HEALTH-CANADA-APPROVED AND SCIENTIFICALLY-SAFE, dozens of Ontario municipalities legislated PROHIBITION.

Finally, on April 22nd, 2009, the Government of Ontario implemented legislation the NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION against pest control products used by the Modern Professional Lawn Care Industry.

Unfortunately, Integrated Pest Management has NOT been scientifically proven to SIGNIFICANTLY REDUCE OR ELIMINATE the use of pest control products while effectively and consistently controlling the pests that damage turf and ornamental plants.

Moreover, Pesticide-Free Integrated Pest Management DOES NOT effectively and consistently control the pests of turf and ornamental plants.
