

Re: Eat pesticide-free veggies and fruit, Nutrition Notes column, by Victoria Mikhail, Aug. 1.

It is concerning to read dietitian Victoria Mikhail's column because it contained so much misinformation about the foods Canadians rely on to stay healthy.

Readers should know that before any pesticide can be sold in Canada, it must undergo a detailed scientific review and risk assessment by Health Canada's Pest Management Regulatory Agency (PMRA). Products are only approved for use once a scientific evaluation demonstrates they can be used without harm to human health, future generations or the environment.

Health Canada's primary objective is "to prevent unacceptable risks to people and the environment from the use of pest control products" and they would not approve products that are carcinogenic or otherwise harmful to human health.

When it comes to fruits and vegetables, whether the food you eat is grown using modern technologies or those approved for organic production, it is important to note that all of these pesticides are assessed for their safety before they can be used to protect crops.

Both Health Canada and the Canadian Food Inspection Agency are involved in ensuring that pesticides used in Canada and any possible residues on foods sold in Canada are strictly monitored.

According to a report released in 2012 by the CFIA, 99 per cent of the fruits and vegetables it tested complied with Health Canada's standards for pesticide residues. In fact, most had no detectable levels whatsoever.

The reality is that Canada has established a world-class process to evaluate pesticides that assures safeguards are in place for the protection of all Canadians and our environment.
