## More on the History of Imidacloprid

When used PREVENTIVELY on small White Grubs in turf, imidacloprid provides excellent residual control, in excess of ninety per cent.

Applications that are SOIL-DRENCHED have a LOW IMPACT on earthworms and predatory insects.

There are NO measurable adverse effects on bees.

However, if a liquid application of imidacloprid is **NOT** soil–drenched, predatory insects are definitely affected, and bee colonies have been known to decline.

For years, beekeepers in France have ALLEGED that imidacloprid, when it is used as a SEED TREATMENT for sun-flowers under the trade name Gaucho, has affected the behaviour of lots of bees by disrupting mobility, navigation, and feeding behaviour. [?!?!]

Imidacloprid is a SYSTEMIC INSECTICIDE that works its way from the sunflower seed through the plant. It can also get into the pollen and the nectar.

The introduction of imidacloprid, and its successor, clothianidin, COINCIDED with a significant drop in honey production.

According to National Union of French Beekeepers, the number of hives in France has PLUMMETED from 1.45 million in 1996 to one million in 2003.

Between 1995 and 2001, the average production of honey went from seventy-five kg/hive down to thirty kg/hive.
