Golf Industry Fighting the Conspiracy to Prohibit Pest Control Products

In fall 2011, Golf Course Superintendents in British Columbia were RALLYING TO MAKE A PRE-EMPTIVE STRIKE against Anti-Pesticide Provincial Government Officials.

If the Golf Industry wants to EXERT INFLUENCE on elected Government Officials, it MUST OPENLY AND FINANCIALLY SUPPORT ALL POLITICAL CANDIDATES who oppose ANY Anti-Pesticide PROHIBITION.

Forget about EDUCATING and CONVINCING Elected Government Officials.

GIVE THEM MONEY AND SUPPORT during the next General Election.



The Industry STRIKES Back

LARRY OLSON, Superintendent at Penticton Golf and Country Club, had urged his peers to reach their Members of the Legislative Assembly, and get them to understand what the province's golf courses are apt to look like in an era of Anti-Pesticide PROHIBITION.

In his memorandum to his peers, Olson said a provincial cosmetic pesticide PROHIBITION — similar to that already in place in Ontario — is IMMINENT.

Olson added a much darker likelihood is that ANY EXEMPTIONS GRANTED TO THE GOLF INDUSTRY WOULD BE TEMPORARY, and Golf Facilities might have to eventually function without the use of any pest control products whatsoever.

Olson is CORRECT.

The Golf Industry must plan for the INEVITABLE and TOTAL REVOCATION of its exception status in most jurisdictions across Canada, in two to four years.

The Golf Industry will LOSE many or ALL of its valued and necessary pest control products.

When PROHIBITION is IMPOSED on the Golf Industry, Golf Clubs MUST DEMAND COMPENSATION FROM GOVERNMENT since PROHIBITION will have created LOSS OF REVENUES, BUSINESS FAILURES, BANKRUPTCY, and UNEMPLOYMENT.

According to Olson, a private member's bill, brought forward by the leader of the opposition, was defeated, but another by the sitting Liberal government has a better chance of getting through.

In his memorandum to his peers, Olson said —

From what I understand, it is INEVITABLE that the Liberals will be bringing a bill to the Legislature.

We as superintendents MUST explain to the government what this will do to the Golf Industry in British Columbia.

With the fall sitting of the provincial Legislature scheduled to begin October 3rd, 2011, time was of the essence for the British Columbia Golf Superintendents to reach out to their Member of the Legislative Assembly.

The Golf Industry MUST OPPOSE ALL FORMS OF PROHIBITION AGAINST PEST CONTROL PRODUCTS USED IN THE URBAN LANDSCAPE.

It must OPPOSE even PROHIBITION on PUBLIC PROPERTY since this is a FIRST STEP towards TOTAL PROHIBITION.

The Golf Industry MUST ALSO OPPOSE ALL FORMS OF PROHIBITION AGAINST FERTILIZERS.

Olson urged his fellow superintendents to « *keep things simple* » when meeting with their elected representatives, suggesting most Members of the Legislative Assembly are likely to know little or nothing about the science of turfgrass maintenance.

In his memorandum to his peers, Olson stressed that the following issues needed to be conveyed —

Without pest control products, golf courses will succumb to DEAD or SERIOUSLY DAMAGED TURF.

Dead turf will result in fewer golfers wishing to play, HURTING a golf course's ability to turn a profit.

Government Officials COULD NOT CARE LESS about SERIOUSLY DAMAGED or DEAD TURF.

Nor do they care about the PROFITABILITY of Golf Facilities.

And, unless they happen to be AVID GOLFERS, Government Officials COULD NOT CARE LESS about the Golf Industry.

Before Anti-Pesticide PROHIBITION was legislated in Ontario, officials were WARNED that it would DESTROY the Modern Professional Lawn Care Industry.

Government Officials were OFFICIALLY WARNED about the « *SUN-SETTING* » that would result from PROHIBITION.

« *Sun-Setting* » means « *the decline and final phase* » of the Professional Lawn Care Industry ».

Nevertheless, Ontario Government Officials PROCEEDED with PROHIBITION, with DEPRAVED INDIFFERENCE to the CARNAGE that it wrought.

Golf Superintendents are living in « *The Outer Limits* » if they believe that MOST Government Officials will be concerned about DEAD TURF, or even the FATE of the entire Golf Industry.

The Golf Industry MUST DEMAND that ALL PROHIBITIONS pertaining to the use of pest control product in the Urban Landscape BE RESCINDED in ALL PROVINCIAL AND MUNICIPAL JURISDICTIONS.

The Golf Industry MUST ADOPT THE POLICY that the ONLY COURSE OF ACTION AGAINST PROHIBITION IS THROUGH LITIGATION.

When Anti-Pesticide PROHIBITION is IMPOSED, the Golf Industry MUST LAUNCH LITIGATION against those Government Officials and Activists who CONSPIRED TO PROHIBIT PEST CONTROL PRODUCTS.

When Anti-Pesticide PROHIBITION is IMPOSED, Golf Clubs MUST SEEK DAMAGES since they will be NO LONGER able to reproduce the business results obtained prior to PROHIBITION, and the VALUE of their businesses will have been DESTROYED.

Critical Issues

Regardless of its Exception Status in many jurisdictions, the Golf Industry faces some huge challenges because of its high degree of vulnerability concerning several public affairs issues.

In order to successfully deter the malicious efforts of all Lunatic Golf-Hating Anti-Pesticide Terrorists, the Golf Industry must immediately address the following CRITICAL ISSUES.

1. The Golf Industry MUST ADOPT THE POSITION THAT CONVENTIONAL PEST CONTROL PRODUCTS ARE SCIENTIFICALLY-SAFE AND CAUSE NO HARM.
2. The Golf Industry MUST ALSO ADOPT THE POLICY that its use of ANY FERTILIZERS DOES NOT HARM THE ENVIRONMENT.
3. The Golf Industry MUST OPPOSE ALL FORMS OF PROHIBITION AGAINST PEST CONTROL PRODUCTS. It must OPPOSE even PROHIBITION on PUBLIC PROPERTY since this is a FIRST STEP towards TOTAL PROHIBITION.
4. The Golf Industry MUST DEMAND that ALL PROHIBITIONS pertaining to the use of pest control product in the Urban Landscape BE RESCINDED in ALL PROVINCIAL AND MUNICIPAL JURISDICTIONS.
5. The Golf Industry MUST ALSO OPPOSE ALL FORMS OF PROHIBITION AGAINST FERTILIZERS.
6. The Golf Industry must TERMINATE ALL RELATIONSHIPS with all Anti-Pesticide Organizations that conspire to prohibit pest control products, like Canadian Cancer Society, World Wildlife Fund, and others. All related charitable tournaments that provide financial donations and support to these Anti-Pesticide Organizations must be SUSPENDED.
7. More specifically, the Golf Industry MUST DEMAND that Golf Canada (a.k.a. RCGA) TERMINATE ALL RELATIONSHIPS with all Anti-Pesticide Organizations that conspire to prohibit pest control products, like Canadian Cancer Society, World Wildlife Fund, and others. Golf Canada MUST CEASE SUPPLYING MILLIONS OF DOLLARS to organizations that have publicly THREATENED, REPEATEDLY, the Golf Industry with Anti-Pesticide PROHIBITION.

Critical Issues (continued)

8. The Golf Industry MUST CEASE ATTEMPTING TO EDUCATE and TO CONVINCING Anti-Pesticide Government Officials and Activists. They are to be considered ENEMIES of the industry. These Anti-Pesticide-Lunatics WILL NEVER reverse their attitudes AGAINST pest control products. NO ONE MUST NEGOTIATE WITH TERRORISTS, either environmental or political.
9. The Golf Industry MUST CEASE focusing on the INEFFECTIVE practices of Integrated Pest Management (IPM) as the solution to its public affairs problems. Besides, IPM practices DO NOT WORK in controlling pests.
10. The Golf Industry must plan for the INEVITABLE and TOTAL REVOCATION of its EXCEPTION STATUS in most jurisdictions across Canada, in two to four years. The Golf Industry will LOSE many or ALL of its valued and necessary pest control products.
11. The Golf Industry MUST ADOPT THE POLICY that the ONLY COURSE OF ACTION AGAINST PROHIBITION IS THROUGH LITIGATION.
12. When Anti-Pesticide PROHIBITION is IMPOSED, the Golf Industry MUST LAUNCH LITIGATION against those Government Officials and Activists who CONSPIRED TO PROHIBIT PEST CONTROL PRODUCTS. These products are, in fact HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, and PRACTICALLY-NON-TOXIC.
13. When Anti-Pesticide PROHIBITION is IMPOSED, Golf Clubs MUST SEEK DAMAGES since they will be NO LONGER able to reproduce the business results obtained prior to PROHIBITION, and the VALUE of their businesses will have been DESTROYED.
14. When Anti-Pesticide PROHIBITION is IMPOSED on the Golf Industry, Golf Clubs MUST DEMAND COMPENSATION FROM GOVERNMENT since PROHIBITION will have created LOSS OF REVENUES, BUSINESS FAILURES, BANKRUPTCY, and UNEMPLOYMENT.
15. The Golf Industry MUST DENOUNCE the so-called GREEN ALTERNATIVES to conventional pest control products as BOGUS. Green Alternatives DO NOT WORK. There will likely be NO viable, efficacious, or economical Green Alternatives within our collective lifetime.
16. The Golf Industry must DIVULGE to the public ALL scientific information that ascertains that its chemicals are definitely « *minimum-risk* » or « *reduced-risk* ». The Golf Industry must create a fully transparent data-base for right-to-

know concerning its chemicals. It must demonstrate that pest control products are Health-Canada-Approved, Federally-Legal, Scientifically-Safe, and Practically-Non-Toxic.

17. The Golf Industry MUST ALSO DENOUNCE CULTURAL PRACTICES as a so-called « *legitimate alternative* » to the use of pest control products. Cultural practices DO NOT WORK in controlling pests.

18. The Golf Industry must develop and publish GOLF MAINTENANCE PROTOCOLS and the PERFORMANCE STANDARDS expected by its playing customers. So far, the Golf Industry has been ridiculously inconsistent in defining « *suitable playing surfaces* ».

19. The Golf Industry MUST SCIENTIFICALLY DEFINE and PUBLICALLY DISCREDIT the mis-leading term « Organic Maintenance », and establish policies for EXPELLING Golf Clubs using this inaccurate and misleading term from its trade associations. These Golf Clubs are not WITH US, they are AGAINST US !

20. The Golf Industry must cease its wasteful « *Wag The Dog* » policies on irrelevant issues such as saving quintozone fungicide, which was ill-fated. Despite the many questions concerning the safety of quintozone, the Golf Industry had launched a petition in support of this ingredient. By defending a product associated with serious health, environmental, and turf phyto-toxicity issues, the Golf Industry weakened its credibility.

21. The Golf Industry MUST VIGOROUSLY EMBARK ON A MASSIVE PUBLIC RELATIONS CAMPAIGN to STOP the proposed scheme by Anti-Pesticide Activists and New Democratic Party of Canada (NDP) threatening a NATIONAL PROHIBITION against pest control products. NDP functions as a political shield for the Anti-Pesticide Terrorist-Movement.

22. The Golf Industry must very strongly address and discredit the misconceptions concerning imidacloprid, chlorothalonil, 2,4-D, and other chemicals.

23. The Golf Industry MUST VIGOROUSLY EMBARK ON A MASSIVE PUBLIC RELATIONS CAMPAIGN declaring that Pesticide-Free Maintenance is a DISMAL FAILURE !

24. The Golf Industry MUST VERY STRONGLY ADDRESS AND DISCREDIT ALL MISCONCEPTIONS concerning imidacloprid, 2,4-D, and other ingredients.

Critical Issues (continued)

25. The Golf Industry MUST TERMINATE ALL RELATIONSHIPS with ALL TEACHING AND RESEARCH INSTITUTIONS that SUPPORT the PROHIBITION of pest control products. ALL joint activities and educational seminars MUST BE ENDED FOR AN INDEFINITE PERIOD OF TIME. If they are not WITH US, then they are AGAINST US !

26. The Golf Industry MUST OPENLY AND FINANCIALLY SUPPORT ALL POLITICAL CANDIDATES WHO OPPOSE ANY PROHIBITION of pest control products.

27. The Golf Industry MUST DEMAND that NEW and ADVANCED products continued to be registered in Canada. Under the present circumstances, the Manufacturing Industry will NO LONGER invest in ANY new pest control products in Canada, since it abhors operating in markets made UNSTABLE by TERRORISM, whether political or environmental.

28. If the Golf Industry wants to EXERT INFLUENCE on elected Government Officials, it MUST OPENLY AND FINANCIALLY SUPPORT ALL POLITICAL CANDIDATES who oppose ANY Anti-Pesticide PROHIBITION. Forget about EDUCATING and CONVINCING Elected Government Officials. GIVE THEM MONEY AND SUPPORT during the next General Election.
