The **Hero-Councillors Brent Asmundson, Mae Reid, Linda Reimer, and Lou Sekora** voted AGAINST LUNATIC-TERRORIST-PROHIBITION.

Hero-Mayor Richard Stewart told media he believes the PROVINCIAL LEVEL OF GOVERNMENT must engage the issue.

Hero-Councillor-Brent Asmundson added that either way, THE CITY DOES NOT HAVE THE RESOURCES to properly investigate the issue.

Additionally, Hero Asmundson commented —

« *They're bans that can't be enforced — the cities can't go out and write tickets for people that buy pesticides they can purchase legally.* »

Enviro-Lunatic-Councillor **Selina Robinson** expressed MOCK-DISMAY —

« *It got defeated — I was completely shocked.* »
