Should lawn and garden pesticides be banned in British Columbia ?

Premier Christy Clark, Opposition NDP Leader Adrian Dix, and Enviro-Lunatic Fund-Raiser David Suzuki are lining up in favour of Anti-Pesticide PROHIBITION — it has become a motherhood issue.

And on February 20th, 2012, a majority of Coquitlam City Council voted for an Anti-Pesticide PROHIBITION that lets it march in lockstep with those municipalities who have already PROHIBITED so-called « *cosmetic pesticides* » under the PRETEXT that they « *might* » cause cancer and hurt the environment ...

... « *might* » being the operative word.

This will COST the City of Coquitlam, which applies herbicides to its boulevards and medians, THOUSANDS OF DOLLARS IN ALTERNATIVE TREATMENT METHODS.

And ALTERNATIVE TREATMENT METHODS, and so-called « *natural* » ways of controlling pests, are NOT necessarily healthy, effective ... or legal.

Coquitlam's Anti-Pesticide PROHIBITION also contains a bunch of BROAD EXCEPTIONS — broad enough to drive a truck through.

It EXEMPTS both those who maintain SPORTS FIELDS and those who control pests and weeds that might pose a threat to human or animal health and safety, including wasps, bees, thistles, and clover.

Western Canada Conspiracy to Prohibit Pest Control Products

Terry O'Neill — Councillor at City of Coquitlam

One of the Coquitlam Councillors who VOTED AGAINST THE BAN was former journalist Terry O'Neill, who explained that Health Canada « *had conducted a major review of cosmetic pesticides and had approved them* ».

O'Neill said he had been repeatedly « *encouraged* » [i.e. COERCED, INTIMIDATED, AND TERRORIZED] by Anti-Pesticide Activists to « *study the issue* » [i.e. TO REVERSE HIS THINKING AND VOTE IN FAVOUR OF PROHIBITION].

And O'Neill has studied the issue.

Which is why O'Neill is STRONGLY OPPOSED Anti-Pesticide PROHIBITION.

O'Neill pointed out that, since Ontario IMPOSED the PROHIBITION of pest control products in the Urban Landscape in 2009, there had been a reported INCREASE IN ALLERGIC REACTIONS DUE TO GREATLY INCREASED WEED POLLEN.

O'Neill also noted that, according to Dr. James Lu of Vancouver Coastal Health, THE ESTHETICS OF URBAN LANDSCAPES HAS PUBLIC HEALTH VALUE, and that appealing, well-kept neighbourhoods increases people's sense of safety and well-being.

PROHIBITION Is NOT Necessary

City of Coquitlam is moving towards the NEEDLESS, SENSELESS, and MALICIOUS PROHIBITION against pest control products used in the Urban Landscape.

In fact, pest control products that are HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, SCIENTIFICALLY-SAFE, and PRACTICALLY-NON-TOXIC.

Anti-Pesticide Councillor and Therapist Selina Robinson, and her buddies, have been PERPETUATING NOTHING BUT MYTHS regarding the need for PROHIBITION.

ANY PROHIBITION of pest control products is NOT supported by health and policy experts, and is not supported by local residents.

Scientific research shows, as reported through Health Canada's vast toxicology database, that NO harm will occur when pesticides are used according to label directions.

If/when Coquitlam IMPOSES Anti-Pesticide PROHIBITION, it will have done so in DEFIANCE of Health Canada's ASSESSMENTS proving that pest control products are SCIENTIFICALLY-SAFE ... a process that can take up to TEN YEARS and COST HUNDREDS OF MILLIONS OF DOLLARS.

City of Coquitlam DID NOT SPEND ANY MONEY on the ASSESSMENT of pest control products.

Health Canada, and NOT Coquitlam, and NOT Anti-Pesticide Activists like Robinson, has THE ESSENTIAL EXPERTISE on the subject of pest control products.

Overall, when pest control products are used properly, there are NO harmful irreversible effects to health and the environment !

There is NOT ONE KNOWN ILLNESS or DEATH from the proper use of pest control products used in the Urban Landscape.

PROHIBITION Is NOT Necessary (continued)

According to Dr. Leonard Ritter, the nation's LEADING EXPERT in the field of toxicology and pesticide safety, pest control products DO NOT CAUSE CANCER, and there is NO increase in cancer deaths in Canada when you consider that the population is aging and increasing.

The Fraser Institute, one of the top 25 leading think-tanks in the world, has said that the proposed bans ILL-CONCEIVED, and do NOT accurately reflect the current state of scientific knowledge.

A recent poll conducted by Canadian Consumer Specialty Products Association showed that the vast majority of residents are OPPOSED to PROHIBITION, and they actually favour the continued use of these products around their homes and in public green spaces.

Moreover, Canadian Cancer Society's own web-site states that scientific research does NOT provide a conclusive link between pesticides and human cancer.

Exception Status

If/when Coquitlam IMPOSES Anti-Pesticide PROHIBITION, it may wish to consider providing an EXCEPTION STATUS to ALL CERTIFIED APPLICATORS, including those in the Professional Lawn Care Industry.

EXCEPTION STATUSES have been adopted in jurisdictions like Kamloops, Kelowna, and Salmon Arm, where Government Officials have left pest control products in the hands of professionally-trained applicators.

Without EXCEPTION STATUSES, Anti-Pesticide PROHIBITION has led to CATASTROPHIC CARNAGE for businesses operating in the Professional Lawn Care Industry.

PROHIBITION has INFLICTED HORRENDOUS CATASTROPHIC CARNAGE in jurisdictions such as Halifax Regional Municipality, and the Provinces of Quebec and Ontario.

« Engaging » Colleagues

According to Coquitlam's Anti-Pesticide Councillor and Therapist Selina Robinson, her TENACITY on the issue of PROHIBITION was achieved by « *engaging my colleagues in discussion* ».

Robinson's strategy of « *engaging* » her colleagues on City Council basically amounted to COERCION, INTIMIDATION, SCREECHING, and TERRORIZING.

Selina Robinson, and her buddies Mae Burrows and Ashley Duyker, are Non-Expert Anti-Pesticide Activists who are SUPPORTED, FINANCIALLY OR OTHERWISE, by Canadian Cancer Society and Toxic Free Canada.

These organizations are FUND-RAISING, LOBBYING, and PROFIT-ACCUMULATING organizations that have NO expertise in science or research.

Robinson and her buddies could DO NOTHING ELSE but MIS-INFORM Coquitlam City Council since NONE OF THEM are COMPETENT to talk about pest control products.

Tenacity and Profit

On the issue of PROHIBITION, the TENACITY of Coquitlam's Anti-Pesticide Councillor and Therapist Selina Robinson was most likely achieved through PROFIT.

The ultimate winners of this debacle in Coquitlam are the Anti-Pesticide Activists themselves, who BENEFIT from PAY-OFF PROGRAMS provided by Canadian Cancer Society.

Clearly, LARGE SUMS OF MONEY have been spent on the Anti-Pesticide CONSPIRACY in Coquitlam,

Overall, Canadian Cancer Society has already SPENT between 2,500,000 AND 5,000,000 DOLLARS on SUBVERSIVE Anti-Pesticide CONSPIRACIES.

It Is Time To Investigate Robinson

It is highly likely that some Coquitlam Government Officials are BENEFITING from REWARDS also, through PAY-OFF PROGRAMS provided by organizations like Canadian Cancer Society.

DEMANDS are being made for Coquitlam's Anti-Pesticide Officials like Selina Robinson to release their TAX-RECORDS for the last three years, which covers the period of time that they would have been operating as LOBBYISTS for Canadian Cancer Society or Toxic Free Canada.

Furthermore, Anti-Pesticide Officials like Robinson must be RECUSED from anything to do with pest control products, and all of their inputs in council meetings must be INVALIDATED.

Until these officials are FULLY INVESTIGATED, it would be prudent for Coquitlam City Council to put any proposed Anti-Pesticide legislation ON HOLD INDEFINITELY.

Notable activities — worked in virtually all aspects of the green space industry, including golf, professional lawn care, distribution, environmental compliance, government negotiations, public affairs, and workplace safety • supervisor, consultant, and, programmer for the successful execution of hundreds of thousands of management operations in the golf and urban landscape, as well as millions of pest control applications • advisor, instructor, and trainer for thousands of turf and ornamental managers and technicians • pesticide certification instructor for thousands of industry workers • founder of the modern professional lawn care industry • prolific writer for industry publications and e-newsletters • first to confirm the invasion of European Chafer insect in both the Montreal region and the Vancouver / Fraser Valley region • with Dr. Peter Dernoeden, confirmed the presence of Take All Patch as a disease of turf in Eastern Canada • with Dr. David Shetlar, confirmed the presence of Kentucky Bluegrass Scale as an insect pest in South Western Ontario, and later, in the Montreal and Vancouver regions

Special contributions — creator of the exception status that has allowed the golf industry to avoid being subjected to anti pesticide prohibition • creator of the signs that are now used for posting after application • co-founder of annual winter convention for Quebec golf course superintendents • the major influence in the decision by Canadian Cancer Society to stop selling for profit pesticide treated daffodils • the only true reliable witness of the events of anti pesticide prohibition in the town of Hudson, Quebec • retired founder of FORCE OF NATURE and A LOOK AT reports

Notable award — the very first man of the year for contributions leading to the successful founding of Quebec professional lawn care industry, which served as a beach-head against anti pesticide activists in the 1980s and 1990s

Legacy — Mr. Gathercole and his colleagues ... designed and implemented strategies that reined anti pesticide activists to provide peace and prosperity for the entire modern green space industry across Canada • orchestrated legal action against anti pesticide activists in the town of Hudson, Quebec • launched the largest founding professional lawn care business in Canada • quadrupled the business revenues of one of the largest suppliers in Canada
