Canadian Cancer Society INTENDS TO DESTROY the Golf Industry.

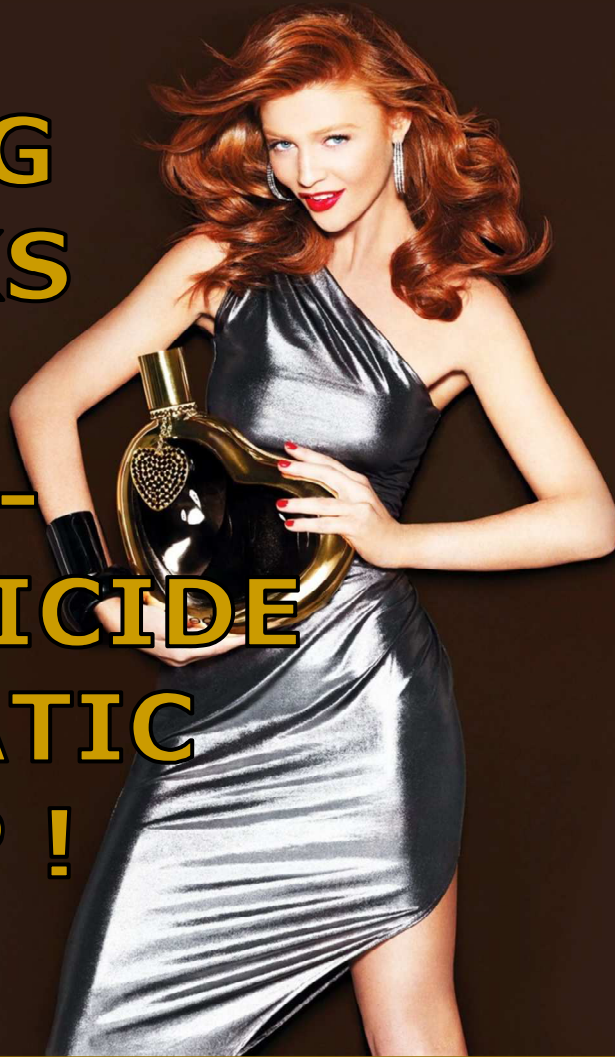

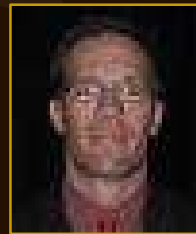

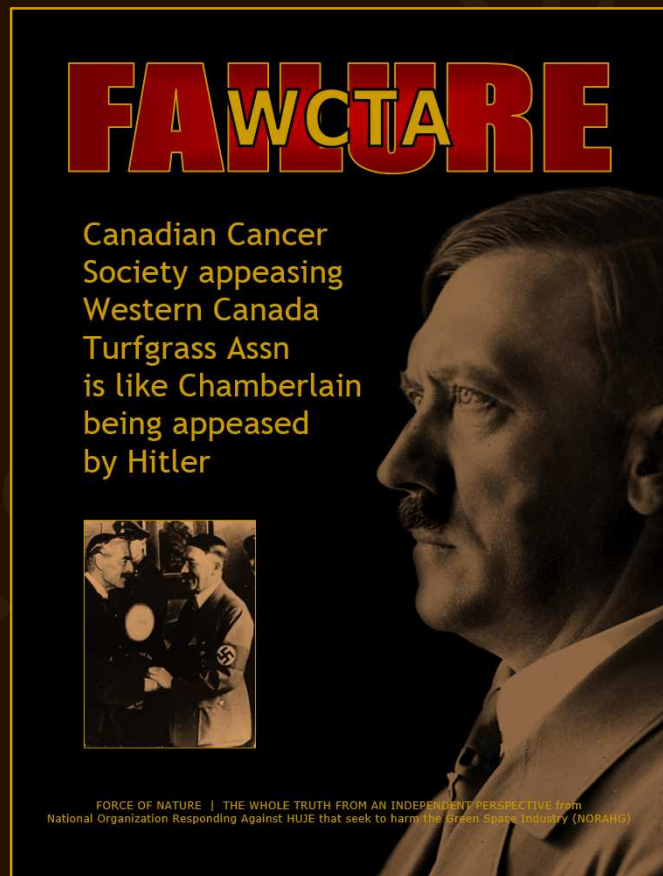

Essentially, what Rousseau told the committee is that Western Canada Turfgrass Association (WCTA) SUPPORTED the PROHIBITION OF HERBICIDES used in the Urban Landscape.

Observers called for the DISMISSAL of Jerry Rousseau, or at the very least, his role in any public affairs forum must be TERMINATED and his statements CENSORED.

International Agency For Research On Cancer (IARC) is BIASED AND PREJUDICED, and CANNOT BE RELIED UPON FOR THE ASSESSMENT OF CANCER WITH PEST CONTROL PRODUCTS.

Canadian Cancer Society's use of IARC assessments for cancer is INAPPROPRIATE.

In the past several years, IARC, a part of the World Health Organization, has COME UNDER SCRUTINY for ALLOWING ITS ASSESSMENTS TO BE COLORED BY A BIAS TOWARD POSITIVE RESULTS and TO BE SWAYED BY ADVOCACY IN THE WIDER SOCIETY.

When IARC's classification of individual agents is examined critically, it appears that the agency's ratings may be SYSTEMATICALLY INFLATED.

In its assessments, IARC considers experimental evidence of carcinogenicity but GIVES PRIORITY TO EPIDEMIOLOGICAL STUDIES that are SUBJECT TO HIGH RATES OF FALSE POSITIVES.

Since only a SMALL NUMBER of IARC's assessments have been REVIEWED BY INDEPENDENT SCIENTISTS, it remains to be seen to what extent its ranking of agents is affected by FALSE POSITIVES.
