CONVENTIONAL pest control products and fertilizers DO NOT CONTAIN LIVING PATHOGENIC ORGANISMS, FERMENTED MATERIALS, OR METALS THAT

MAY BE DEEMED UNSAFE FOR CHILDREN, ADULTS, AND THE ENVIRONMENT.

In many cases, so-called Organic Maintenance companies use Green Alternative Pesticides that are questionably HIGHER IN TOXICITY, and pose HIGHER ENVIRONMENTAL RISKS.

Many Organic Maintenance companies use Green Alternative Pesticides are NOT EVEN FEDERALLY-REGISTERED and TESTED FOR THE SAFETY OF HUMAN HEALTH AND THE ENVIRONMENT.

Many Organic Maintenance companies may use Green Alternative Pesticides that may be DEEMED UNSAFE FOR EXPOSURE TO CHILDREN.

Many Green Alternative Pesticides have NOT BEEN TESTED by Good Laboratory Practice (GLP) qualified laboratories, as is the case with CONVENTIONAL pest control products registered by the Federal Government.

Many Green Alternative Pesticides are NOT SCIENTIFICALLY SAFE !

Many Green Alternative Pesticides may be deemed NOT SAFE, especially for children !

In many cases, Organic Maintenance using Green Alternative Pesticides SHOULD NOT BE ALLOWED ANYWHERE NEAR CHILDREN !

In some cases, Organic Maintenance using Green Alternative Pesticides may be considered as UNSAFE as using Agent Orange, DDT, and other banned products.

GARBAGE DUMPS and
DANGEROUS Playing Surfaces

LUNATIC-TERRORIST- PROHIBITION in Canada has created GARBAGE DUMPS and DANGEROUS PLAYING SURFACES — ESPECIALLY TO CHILDREN !

In jurisdictions where LUNATIC-PROHIBITION was imposed, playing surfaces like home lawns, public green spaces, and sports fields became WEED-INFESTED and INSECT-INFESTED.

They became OVER-RUN by Dandelions and other weed pests, and were DESTROYED by damaging insect pests like European Chafer.

THE PROHIBITION OF PEST CONTROL PRODUCTS REPRESENTED A HAZARD TO ANYONE USING THESE PLAYING SURFACES, ESPECIALLY CHILDREN.

When it rained, organically-maintained pest-infested playing surfaces were SLIPPERY MUD BOGS.

Virtually all Green Alternatives are BOGUS, displaying negative characteristics such as the following —

- BOGUS Green Alternatives are ALMOST TOTALLY INEFFECTIVE except under specific circumstances
- BOGUS Green Alternatives require EXTREMELY-HIGH-INPUTS OF ACTIVE INGREDIENT since they will otherwise be less effective
- BOGUS Green Alternatives are HIGHER IN TOXICITY, and pose HIGHER ENVIRONMENTAL RISKS
- BOGUS Green Alternatives are PROHIBITED in some jurisdictions because of concerns about safety
- BOGUS Green Alternatives are STUNNINGLY MORE EXPENSIVE to use when compared to conventional pest control products
- BOGUS Green Alternatives are supplied by the same For-Profit-Enviro-Terror-Businesses that sought LUNATIC-TERRORIST-PROHIBITION against conventional pest control products
- BOGUS Green Alternatives have negative side-effects like PHYTO-TOXICITY (adversely affects plant growth) or CORROSION or RODENT-ATTRACTION or REPULSIVE ODOUR
- BOGUS Green Alternatives require MORE PERSONAL PROTECTION for the user

BOGUS Green Alternatives are a DISMAL FAILURE

Overall, Green Alternatives are a DISMAL FAILURE since they merely SUPPRESS or INHIBIT pests of turf, and require an excessive number of repeat applications, often with EXTREMELY–HIGH–INPUTS OF ACTIVE INGREDIENT.

On the other hand, conventional pest control products FULLY, EFFECTIVELY, and SAFELY CONTROL pests, without the need for excessively repeating applications, or without using exorbitant quantities of active ingredient.

Integrated Pest Management is a FAILURE and a WASTE OF TIME AND MONEY for the Green Space Industry.

Moreover, using IPM accomplishes virtually NOTHING in terms of resolving the public affairs issues concerning LUNATIC-TERRORIST-PROHIBITION against pest control products.

Nor does Integrated Pest Management effectively and consistently control the pests of established turf and ornamental plants — at best, it MAY provide some LIMITED IMPROVEMENT towards the efficiency and effectiveness of conventional pest control products.

Integrated Pest Management is an INEFFECTIVE management strategy for CONTROLLING the damaging pests of established turfgrasses, as well as trees and shrubs.

The Professional Lawn Care Industry used Integrated Pest Management, and FAILED to defend itself from LUNATIC-TERRORIST-PROHIBITION.

Furthermore, it will be increasingly difficult for the Golf Industry to defend any Exception Status based upon the need for high-quality playing conditions, especially since ALL pest control products, including those used on the golf course, represent to Lunatic-Vermin some kind of IMAGINARY DANGER.

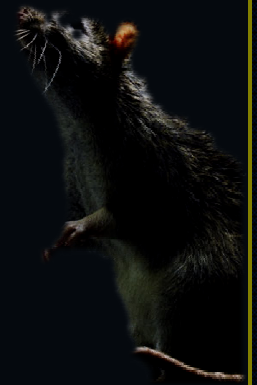
